Investigating a Landed UFO Site **By Dick Moss, MN MUFON State Dir.**

Recently, a UFO landed in a remote region of North Dakota and I happened to be in that area a few days ago. Shortly after we arrived a relative told us about a teen-age boy who had encountered a landed UFO a little after midnight on April 18. A pastor also mentioned the incident to me after a funeral we had attended. Several people wanted to see the landing site so we drove to the field to have a look. The object had made a whirring sound when it arrived causing the dogs near the farm house to start barking.

It is calving time and a farmer's son had decided to go out and, along with his Australian cattle dog, check on the cows at about this time. Off to the east, bright light beams were moving about and he thought that there might be somebody shining deer. When he got to the top of a ridge he saw a large wedge-shaped object on the ground about a half mile away emitting light beams that were sweeping the area. The UFO was sitting in an adjacent field near a rectangular cattle pond and these lights were reflecting off the water.

The witness said that there were three large oval lights or windows on the side emitting bluish or purple lights. The witness said that he got the feeling that he would not be hurt. The object eventually lifted up and shot off to the northwest at high speed. A boom and unfamiliar sounds, unlike the usual trains and trucks, were heard during its departure both by the witness and his family in their nearby farm home.

Round apparent landing pod impressions were later found to be spaced at about 32 ft by 32 ft by 25 ft forming an isosceles triangle.

A dead cow was found nearby that had not been eaten by coyotes, which was odd because it was estimated that this cow had been dead since last fall. There was an image resembling a domed flying saucer that had either been burned into the cow's hide or created some other way. A surgical cut was also found on each of its legs above the hoof and hide was missing from that point on down to the hoof. Hide had also apparently been cut off right above the animal's tail.

If any additional testimony is forthcoming, it will be described in a later issue.

**Document Referring To The Roswell
UFO Incident From Congressman's
Office - Release of letter/document
dated: March 23, 2005**

Permission was granted to leave letter as is.

A few years ago I received an email from a Mr. Robert F. Brown, a fellow who explained to me that he was persistent in his pursuit of information through different government agencies on an sighting event which he witnessed in late 1949 or early 1950 when he was 11 or 12 years old. Robert wrote letters to his Congressman, Mr. William D. Delahunt of Massachusetts in hopes that Congressman Delahunt would have the means to help retrieve alleged documents that may be floating around in an archive about Robert's sighting. As a young boy, Robert was told by his school principal not to be talking about 'Flying Saucers' as the FBI had just been at the school asking questions about Robert. Supposedly during the same week, after the school principal talked with Robert, two other teachers told him to stop talking about flying saucers as the FBI had been asking them questions about him as well.

In the years Mr. Brown has been on the trail of tracking down the information he is looking for, he has been communicating with Congressman Delahunt office, the FBI and Department of Justice. HBCC UFO Research has these letters here which I will post shortly after releasing this, simply incredible letter from the Congressman's office.

What I would like to point out in the letter/document posted with this report is that it is one sentence which I found to be of great interest. Which reads below:

("Thank you for your letter about UFO's and the July 1947 incident that happened in Roswell, New Mexico. After looking into this matter, I have found that the debris from that is still being analyzed and is not open to the public at this time")

I like so many others were under the impression that there was no UFO crash at Roswell in 1947, according to the government/military. The doors were closed on this sometime ago and some varying ideas were thrown out to us all on what the military said took place.

So when I read the letter from the office of Congressman, Mr. William D. Delahunt I see it as,

"someone has looked into the matter, (as it states in the letter) in other words looked into the alleged Roswell crash, and possibly found information on the actual crashed craft, and as stated in the letter, "debris" from that is still being analyzed and of course not open to the public for viewing". Very strange if you ask me.

My thoughts are, were they privy to information from somewhere or someone? Was it a complete goof up by the office staff?

Whatever the outcome, this opens the doors to another flood of questions and most likely not many answers to follow.

Thank you to Mr. Robert Brown for sending this information along to me. Also again, please check back as more letter will be added in the next couple of days.

**Extracts of Paul Hellyer's Speech
By Bill McNeff**

On September 25, 2005 Paul Hellyer, the former Defense Minister of Canada, announced in a speech at the Toronto Exopolitics Symposium that he had finally come to the conclusion that there is a truth to the reality of UFOs, their presence on our planet and the interaction between earth governments and extraterrestrials. The December/January 2006 issue of UFO Magazine had the entire text of Hellyer's speech. I extracted about half of it for a presentation I am scheduled to make before a senior's group in the Burnsville/Apple Valley area. Here are the extracts I made from his speech:

PAUL HELLYER 9/25/05:

"The subject [of UFOs] was not of major interest to me until quite recently. True, when I was minister of national defense 40 years ago, I received a report of sightings of unidentified flying objects, some of which were listed as natural phenomena, while

others were simply listed as source unknown. At that time I was far too busy trying to streamline the armed forces, improve morale, and save the taxpayers money to let any natural curiosity concerning the subject of UFOs lead me on what I would probably have considered to be a flight of fancy.

[But] since the turn of the century, I have met some ufologists who have sparked my interest in the subject and provided me with significant research material. Among other things, I was asked to watch a 2-hour television special put together by the late Peter Jennings for ABC News. I found it quite compelling. Commercial airline pilots, United States Air Force pilots, policemen, and other public officials all swore that they had had personal encounters with UFOs. Some witnesses alleged that they had been abducted. Why would they all say what they did if they didn't believe what they were saying?

It may have been that program that encouraged me to read a book that had been on my shelf for a couple of years. It is titled *The Day After Roswell*, and was written by Lt. Col. Philip J. Corso, a U.S. Army intelligence officer who had been a member of President Eisenhower's National Security Council and later head of the Foreign Technology Desk at the U.S. Army's R & D Department. It was one of the most fascinating books I have ever read. It is the unimpeachable source of what I am going to say to you today. The long-time intelligence officer confirms beyond any shadow of doubt the long-circulated rumour that on or about July 4th, 1947 a UFO crashed not far from Roswell, New Mexico. ".although the colonel was not present at the crash site, he subsequently saw one of the bodies recovered from the wreckage while it was en route for autopsy. Even more significant, 10 years later, he was put in charge of a pile of scrap collected at the crash site and stored by the army for a decade until Corso was given the task of doing something with it.

His assignment was to feed the alien technology, which was decades in advance of our own, into the U.S. industrial system for the benefit of the U.S. military. The secrecy involved in all matters pertaining to the Roswell incident was unparalleled... when the alien technology was fed to U.S. industry, at no time was the source revealed. Colonel Corso had the perfect cover. It was foreign technology that he was providing -- ostensibly something picked up from the Soviets or the

Germans. No questions were allowed and no explanations were given. The projects resulted in reverse engineering that led to developments that included today 's integrated circuits, fibre optics, lasers, and super-tenacity fibres.

Last summer when I was reading [Corso's book] at Arundel Lodge I shared a few of the contents with my nephew, Philip. Not having read the book, he was more than a little skeptical. A couple of days later he phoned a retired U.S. Air Force general of his acquaintance to ask him about the book. "Every word of it is true, and more," the general told him. [A short time later]... I phoned the general who Philip had introduced me to. I asked him about Corso's book. "Every word of it is true, and more," he repeated for my benefit. We then spent 20 minutes or so discussing the "and more" to the extent he could without revealing classified material. What he said was just as fascinating and compelling as the book.

UFOs are as real as the airplanes flying overhead. That is my unequivocal conclusion. But that conclusion alone would not have been enough for me to speak out today. The reason I am going public today is because there are more profoundly important policy issues that must be addressed...

There is a problem for earthlings. Within hours of the crash at Roswell, U.S. General Nathan Twining designated the visitors as "enemy aliens." It appears. that it has remained as official U.S. policy ever since. At the time, however, it was an enemy about which the U.S. could do nothing because the visitors were so technologically superior. "This led to the recommendation that the discovery be treated with the utmost secrecy to the point that the crash at Roswell didn't happen and the UFOs don't exist. The rationale was that ordinary people couldn't cope with the news and might easily panic... This policy resulted in what has probably been the greatest and most successful cover-up in the history of the world.

But much has happened in the more than half century since that policy was adopted. The most important change has been in U.S. military capability.

The U.S. has developed the alien's own weapons-- lasers and particle guns—to the point where they can be used against the visitors from space. In his book Colonel Corso makes it clear that the Reagan Administration's Strategic Defense Initiative was

primarily designed for use against the alien intruders. Its contemporary successor, the anti-missile missile defense system is also being designed with that as one of the principal objectives.

The policy question is this: Is it wise to be spending so much time and money building capability designed to rid the skies of alien invaders? And what are the possible consequences in the event we should shoot down a few of them?

A related question is: To what extent are they really an enemy? What crimes have they committed against humanity? They have certainly upset the military by flying over their most secret installations, by shadowing their planes, and by buzzing their astronauts. Beyond that, the aliens have allegedly abducted a few people and frightened them badly... But to the best of my knowledge they have never killed anyone. So are they really enemy or merely legitimate explorers from afar?

These are extremely important questions, but with few answers due to lack of information.

The point is that there has been no public input, and there should be. The time has come to lift the veil of secrecy and let the truth emerge so there can be a real and informed debate about one of the most important issues facing our planet. Forgive me for stating the obvious; but it is quite impossible to have that kind of an informed debate about a problem that does not officially exist.

Let me close by switching briefly from the real to the hypothetical. Last Christmas I had the pleasure of reviewing a delightful little book entitled *Exopolitics: Politics, Government and Law in the Universe* by Alfred Webre. Webre postulates a universe that includes many planets sustaining life more advanced than our own, and all subject to universal governance based on the rule of law.

Earth, he suggests, is an exception. Rather than being the center of the universe as our ancestors believed, we are the black sheep of the interplanetary community. We have been quarantined and isolated from the "highly organized, interplanetary, intergalactic multidimensional universe society [because of our backward culture].

To end the quarantine, Earthlings must advance morally and spiritually while re-establishing the connection with interplanetary society. Until recently we didn't have the technology to do the latter, but increasingly we do. Meanwhile, visits from our interplanetary neighbors present opportunities for peaceful communication and collaboration. People who believe in God, as I do, will find nothing in Webre's thesis inconsistent with their beliefs, although I admit it is a mighty mind stretch. His proposal, I think, is worth considering. He calls it "A Decade of Contact."

He proposes an era of openness, public hearings, publicly funded research, and education about extraterrestrial reality. Who knows? That could be just the antidote the world needs to end its greed-driven, power-centered madness."

UFO Sightings in Wisconsin and Minnesota Wisconsin and Minnesota are studied together here due to their proximity. This improves the map and simplifies the statistics.

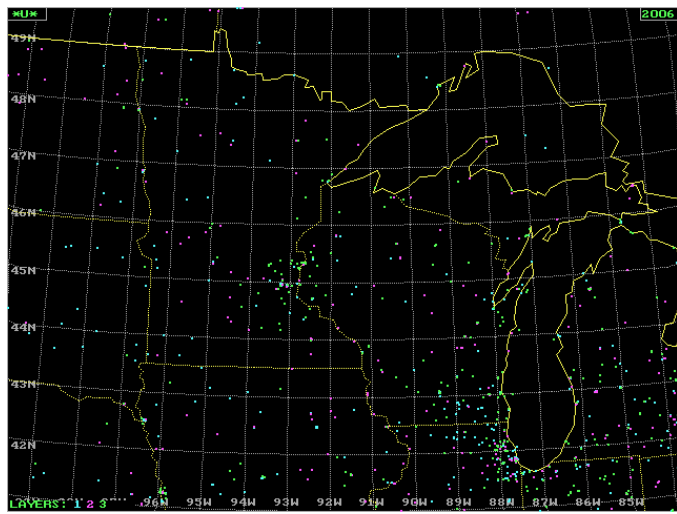
Sightings eras are in colors: 95 events from the 1890s through 1959 show as Blue dots, 75 from 1960 through 1974 are in Violet, and 117 from 1975 to the present are Green.

Wisconsin has more sightings (164) than Minnesota (125) overall, and a higher density of sightings per square miles of area. The geographical center of the two-state area is at 91:22W - 44:45N, which is Southeast of Eau Claire, WI.

The earliest sighting mapped was from 13 April, 1897 at Lake Elmo, MN. A vague figure was seen searching around with a lantern. He (it?) ran into the trees. A strange grey object flew away from there.

Sightings for all years and both states are combined and plotted as daily counts to show seasonal effects. No compelling peaks show, but the busiest single days were 22 March with 8 events listed, and 7 July 1947 with 6. The busiest month all-time was July (39 listings here) versus an average of 22 for the

other 11 months of the year. The busiest weekday is Wednesday (49) versus an average of 35 or 36 for the other six days. Sightings here are mostly on farmlands.



50-year graph of Wisconsin & Minnesota

The violet running average curve at bottom has several peaks. Six especially busy months are circled in green. Half of those occurred as Mars made close approaches to Earth. Distance scales for planets are inverted, so high means near. Correlation with Venus is nil to negative.

The busiest years for WI & MN combined were:

1947 (17) 1952 (25) 1956 (11) 1957 (10)

1965 (11) 1966 (10) 1967 (18) 1975 (11)

1978 (16) 1979 (15) 1993 (11) 1995 (10)

Years not shown have 8 or fewer listings.

The largest local flap, within 10 days and 20 miles, was around Scandia, MN late March 1978. Robert Engberg wrote a special report. A group of four sightings around Elkhorn, Eagle River and East Troy, WI took place on 7 July, 1947... far away from the western states.

Hybrids and Genetic Engineering

In previous articles, we have seen many themes associated with the apparent alien presence in our world. However, one idea that seems to crop up repeatedly in the accounts of experiencers is that of their interest in human reproduction and genetics. Much of the abduction literature suggests that study and manipulation of the human genome seems to be the primary purpose behind their activities. Budd Hopkins and David Jacobs strongly suggest that this is the primary reason for the Abduction phenomenon. Budd Hopkins builds an excellent case for the existence of this agenda in his book *Intruders*(i). David Jacobs builds a further case that there is a coherent and non-benevolent purpose to this process(ii). Many other authors have elaborated on this abduction/hybridization scenario(iii) with various interpretations and conclusions.

In this model, the methods and goals of the phenomenon are relatively well understood and our purpose here will not be to recount the details of the standard abduction scenario. I leave it to the reader to familiarize him/her self with the details of the standard model of UFO abduction posed by Hopkins, Jacobs, Mack, and others. What we wish to do here is to examine this process in light of previous contact models we have studied.

Is abduction a means of contact with an up and coming humanity, to usher us into what Stanton Friedman refers to as "The Cosmic Kindergarten?" Or is it simply a different form of invasion, an exploitation of humanity for purposes which only the Visitors understand? What are the Visitors attempting to accomplish with this strange process, and what is the motivation behind it?

Whatever the Visitor agenda may be, descriptions by abductees indicate that they do seem to be conducting some form of reproductive and/or genetic manipulation. Nearly every experiencer has described the harvesting of genetic material, while many have described the implanting and subsequent harvesting of apparently-hybrid babies. Many of these have experienced subsequent child presentations [See Budd Hopkins book "*Intruders*" and Raymond Fowler's book "*The Watchers*"]. A large number of experiencers have described rooms containing incubation tubes with hybrid beings in

various states of incubation. And in his book "*Sight Unseen*" Budd Hopkins describes encounters between experiencers and the apparent end-product of this hybridization process, humans who seem to have alien characteristics.

Hybrids and missing fetuses

Let's continue our speculations by examining some of the most salient aspects of the abduction/hybridization descriptions within the "standard model" of UFO abduction:

1. Extraction of sperm and ova from the bodies of experiencers: This appears to be a relatively standard procedure, nearly universally described as part of the abduction experience
2. The apparent transgenic crossbreeding or genetic manipulation of the extracted material to create some form of human-alien hybrid embryo
3. Embryo implantation and the subsequent removal a few weeks to months later, of a partially developed being
4. Incubation of the extracted fetus: Many abductees describe being shown a room containing incubation tubes, which apparently contain hybrid fetuses in varying states of incubation.
5. Child presentation: Some time subsequent to the fetal extraction, the experiencer is shown a child whom they are told is their own. This is described by a high percentage of (mostly female) abductees.

Several experiencers, with whom I have worked, have related heart-wrenching accounts in which they have been impregnated or otherwise implanted with embryos. They carry these partially to term, only to have their pregnancy "disappear" a few months later, well prior to the time of delivery.

Many of these cases can be represented in aggregate by the experiences of an abductee I will call "Sandra". Sandra had undergone a series of abduction experiences during her late teen and early adult years. At one point, during the period in which these were occurring, she learned that she was pregnant. Years later, when I interviewed Sandra, she described how, at a relatively early point in her pregnancy, while lying in bed, she suddenly found herself surrounded by small gray beings.

In the typical abduction scenario, the beings took her from her room, and into what she described as a strange looking "hospital" (possibly a UFO). She was taken to an examining room, where strange looking "doctors" with solidly-black eyes entered.

They "removed something" from her, which she suddenly, and with a heart-wrenching cry, described as "My baby!" Sandra noted that on closer examination, these "doctors" were short, had no hair and large black eyes. They appear to have been the usual gray beings associated with the "standard" UFO abduction.

Another experiencer, "Carolyn," describes herself as having had numerous UFO encounters. She feels that she has at least one "star child" who is "out there somewhere". Carolyn and her husband live in a rural wooded setting, near a moderate sized town in the upper Midwest. At one point, Carolyn and her husband had an up-close UFO sighting, which turned out to be an apparent UFO abduction. Shortly after their encounter, Carolyn learned that she was pregnant, and the happy couple began to look forward to becoming a family.

At a point several months after their encounter, Carolyn was again abducted. Subsequent to this abduction experience, she discovered to her horror that she was no longer pregnant. Although it was relatively late in her pregnancy, and she was not aware of any actual miscarriage event, no baby was present. The mystery deepened as she also noticed geometric marks on her abdomen. In the next few weeks she began to have nightmares of UFOs, aliens, hospitals and abductions, dreams frequently associated with the close encounter phenomenon. In the next several months she also began to more clearly remember details of her initial UFO abduction, which had apparently occurred at the time of their sighting.

A couple of years later, Carolyn was again abducted. This time, she was shown a child who had the appearance of a human boy approximately two-years in age. Carolyn knew immediately that this was her child. From that point on, she has considered him to be her star child.

Incubation Tubes

Many experiencers describe seeing rooms containing apparent incubation tubes in which there are beings that resemble human fetuses. Representative of such cases are the descriptions by one experiencer, whom I will refer to as "Susan". Susan had recently undergone a missing-pregnancy experience similar to that of Carolyn and Sandra. In a subsequent abduction a few weeks later, she was taken to the location in which these beings apparently complete their gestation.

Susan was ushered into a room containing many large glass tubes. In each of these tubes, she observed a fetus-like being similar to the one which had, a few weeks earlier, apparently been removed from her. She was told about these beings and was told that one of them was her child. Susan does not feel that she has ever seen this being again but is sure that she, too, has a "star child" out there somewhere.

Transgenic Theory

In their book, *Sight Unseen*,(iv) Budd Hopkins and Carol Rainey build a fascinating case for the plausibility of such a quasi-hybridization endeavor. They describe in considerable detail how this might be done. This does not involve direct crossbreeding of species, but rather transgenics, in which selected genes encoding desirable characteristics in one species may be transplanted into the genome of another. It is the theory of Hopkins and Rainey that such a transplantation is being done to the human genome, for purposes known only to the Visitors.

Hopkins and Rainey go on to cite experiments in which the genes of a salmon were transplanted into the genome of a tomato to enhance the tomato's ability to withstand colder temperatures(v). This is one of many such research efforts(vi) in transplantation of genes from one species to another. It leads us to the speculation that DNA, perhaps synthesized or of alien origin, possibly altered in some way, could be combined with that of humans to build the genetic blueprints of the hybrids which are so common in abduction accounts.

When taken on its own, the hybridization process which Hopkins and Jacobs describe does not seem to clearly suggest a defined end-point or goal. Yet, taken in the context of the other aspects of the phenomenon, perhaps a more coherent picture begins to emerge. One hypothesis is that the purpose of this hybridization process may be simply to breed a better human.

One possible representation of such "advanced humans" is described in the literature as the "indigo child". This term is based upon the work of Jan Tober and Lee Carroll, in their book, "The Indigo Children", in which they describe what they claim to be a modern generation of anomalously advanced children. Thus, we can speculatively ask whether, in some sense, at least some of the Indigo

children might be a product of the hybridization process? Could the genetic changes resulting from E.T. genetic intervention have in some way been back-inserted into the overall human population? I refer to this idea as the "Indigo Hypothesis," and ask whether this might be a key aim of the Visitors. In a future article, we will discuss this hypothesis in more detail.

The more I research the history and morphology of "alien" contact, the more I'm convinced the Extraterrestrial Hypothesis is profoundly lacking. But even the most lucid opponents of the EH, aside from offering vague (albeit endlessly enticing) references to "other dimensions" and "parallel universes," seem dumbstruck by the phenomenon's absurdity; I have yet to read of a plausible means by which the "aliens'" home world could intersect our own, allowing a steady stream of ufonauts.

We typically assume inter-dimensional travel must involve arcane cosmological machinery such as a wormhole or "stargate." But, increasingly, I'm drawn to the idea that our visitors' method of travel is less flashy (from a technical perspective) and more understandable in terms of quantum

neurology - a field we humans have barely skimmed, let alone utilized.

This leads to my suspicion that the "aliens" are less technologically advanced than they lead us to believe. In fact, I think a case can be made that we're dealing with a surprisingly vulnerable intelligence that relies largely on subterfuge and disinformation to achieve its goals.

And as outlandish as it may seem, I've been forced to wrestle with the notion that our relationship with these "others" is far more widespread and intimate than even paranoid dramatizations of the UFO spectacle would have us believe.

These dawning suspicions are borne out, at least in part, by world folklore (with its preoccupation with "little people" in our midst) as well as by recent discoveries that suggest the history of our species is more enigmatic than we'd like to admit. We may well share our planet with cryptohominids that have mastered the art of camouflage in order to coexist with us. More portentously, their agenda may be within our ability to grasp. But to do so, we must suspend the assumption that we're dealing with something as quaint as ET astronauts.

The truth, unnervingly, seems much closer to home, threatening to displace our sense of self in a most unexpected manner.

(2nd post)

My recent post on alleged extraterrestrials has aroused some (deserved) skepticism. Advocates of the Extraterrestrial Hypothesis argue, for instance, that the UFO evidence supports the existence of an advanced, presumably spacefaring technology. Superficially, at least, this seems more congruent with flesh-and-blood space visitors than trans-mythical interlopers from the Great Beyond.

In defense of "ultraterrestrials" (which I'll broadly define as unconventional humanoids from Earth or variations thereof), I suggest that the high-performance flight characteristics commonly associated with UFOs don't necessarily imply ET origin (although I wouldn't be in the least surprised if the parade of close encounters that fall under the ufological rubric include at least some genuine visits from advanced interstellar societies).

Although perhaps unlikely, I think it's perfectly conceivable that a technically superior civilization

could have arisen on Earth in the distant past. This civilization needn't be particularly large nor would its technology have to be centuries or millennia ahead of our own; the rate of technological change in the Western world, as students of the "Singularity" are fond of reminding us, is exponential, rendering accurate forecasts of the future effectively impossible.

(Within two centuries - certainly a blip on an evolutionary time-scale - we've harnessed electromagnetism and nuclear energy, events largely unforeseeable by the preceding zeitgeist. If certain rumors can be accepted at face value, an element within the military is actively experimenting with electrogravitic propulsion, in which case we may be encroaching on a functioning theory of quantum gravity.)

If an ultraterrestrial offshoot of the human species is indeed operating in our midst, we can reasonably expect it to have made huge technological advances given the time it would have had to develop (perhaps in tandem with our own technical progression). "Alien" UFOs, while undoubtedly remarkable from today's engineering perspective, may only be a century or so more advanced than earthly technology. Unfortunately, to my mind, we've become accustomed to thinking of aliens as being from far-away star systems, which in turn tends to make ufologists and SETI pundits alike think in terms of hundreds of thousands - if not billions - of years.

The "Ultraterrestrial Hypothesis," as presented here, hinges on what we know of our species' genetic and social history. Bluntly: Could we be sharing our world with virtual aliens and not even know it? My answer, equally blunt: Why not? As our scientific instruments improve, we discover mounting evidence that the popularly accepted history of homo sapiens sapiens is incomplete. (The recent discovery of the Flores "hobbits," for example, was unexpected enough to temporarily fuse the disciplines of cryptozoology and paleoanthropology, especially when it became clear that there existed a rich oral tradition of small, hairy people among the local population. Intriguingly, these hairy people were said to kidnap babies - a trend that recurs quite explicitly in both fairy lore and contemporary accounts of fetus-snatching by clinical Gray aliens.)

In addition to gaps in terrestrial history, we're confronted by the possible existence of parallel

universes, a theme that's attracted the attention of mainstream cosmologists who no longer speak of reality in terms of a singular "universe," but as a bewildering amalgam dubbed the "multiverse." (Students of ufology will immediately seize on Dr. Jacques Vallee's use of the same term, as recounted in his iconoclastic study "Dimensions.")

As theoretical physicists narrow their search for a Theory of Everything, calculating the quantum wave function of our entire universe (as opposed to those of single elementary particles), new vistas of exploration appear, unbidden, like a froth of bubbles set loose from a bottle of well-shaken Perrier.

Could these realms - so seemingly intangible - harbor clues to the reality of some of our unlikely visitors?

Forget the idea of "other dimensions" for a moment. Perhaps Jacques Vallee's proposed "psychic thermostat," while a well-intentioned attempt to reconcile UFO observations with their psychosocial effects, isn't needed to encompass the weirdness of alien visitation. Forget, also, the idea that aliens are necessarily from space. (Sure, some might be, but I'll deal with them another time.)

Instead, let's assume for adventure's sake that we're sharing the planet with a flesh-and-blood offshoot of the human species. As I've tried to demonstrate, the prospect isn't as absurd as it initially seems; indeed, I expect it will seem much less so when we've learned more about our world and our relatively brief tenure here. (It bears mention that eminent primatologist Jane Goodall has defended the scientific search for "Bigfoot," a cryptohominid commonly described as enormous. Assuming a gigantic and purportedly foul-smelling primate can successfully lay low, it may be substantially easier for an intelligent technical society, with a tested capacity for stealth and a full repertoire of disinformation tricks, to dodge our radar.)

Astrophysicists discern black holes - the invisible corpses of collapsed stars - by detecting their gravitational influence on neighboring phenomena. Similarly, the search for extrasolar life hinges on the belief that technological civilizations - regardless how advanced - will necessarily betray their existence via electromagnetic emissions. Freeman Dyson, for instance, has suggested hunting for alien megascale engineering by looking for its distinctive energetic signature.

We can apply the same basic principles to the search for nonhuman intelligences here on Earth. If some UFOs are indeed the work of an indigenous race, we ought to be able to detect the inevitable "signature" it's imprinted on the planet. This confirming evidence can take many forms: anomalous fossils, genetic traces, "mystery" transmissions, and even inexplicable artifacts.

Our technology-driven world is effectively shrinking at a pace that threatens to obliterate remaining wilderness areas. At the same time, we continue to map the continents and oceans (not to mention the surfaces of other planets) with ever-improving instruments. It stands to reason that the "Ultraterrestrial Hypothesis" is testable. In other words, no matter how addicted to seclusion, a parallel society will eventually betray its existence.

But maybe they don't want to be found. Maybe they'd prefer to observe from the balcony, unseen and unsuspected, while we go about our blundering affairs onstage. If so, then they've almost certainly noticed the hazard we pose to their maintained stealth. And while they might be our technological superiors, one couldn't blame them for being at least a little concerned.

Whitley Strieber has remarked that his "visitors," the subject of the best-selling "Communion" and subsequent books that delve into the ufological, accomplish their agenda largely through stealth and cunning; their technology, as enviable as it may be, is secondary. Strieber attributes the fall-back in his encounters with nonhumans to the fact that he no longer resides in his isolated New York cabin, but in the busy community of San Antonio. Apparently the "visitors" (whoever they are) are daunted by the ubiquity of modern civilization, able to exist among us for only limited periods - and even then assisted by considerable disguise and technical savvy.

In many ways, this would be an appalling predicament for our hypothetical ultraterrestrials. For most of human history they would have enjoyed unimpeded dominance. Humans, without a global media infrastructure, would have been easier to fool (and perhaps to exploit) than we are now. (Or do I err on the side of overconfidence?)

In almost any event, the "others" would have been compelled to misdirect us in order to maintain cultural coherence. I suspect that the prevailing notion that they hail from outer space originates from an overarching disinformation campaign with

roots that predate humanity as we know it. For millennia, we've interpreted them according to the disguises they adopt, each tailored to mesh with the given paradigm. Even a cursory overview of world folklore indicates that this ability is extraordinarily well-honed; it may be their most zealously guarded secret.

However, I suggest that our abrupt transformation into a global, intricately networked society poses a grave challenge to what has traditionally been a routine effort. We may be on the threshold of some oblique form of contact; alternatively, this contact may have begun in modern times, marked by the emergence of the contemporary UFO phenomenon and the equally alarming epidemic of so-called "alien abductions."

Jacques Vallee has remarked, somewhat famously, about the possible futility of trying to look behind the curtain; what might we be confronted with? Given the opportunity, could we even comprehend what we're seeing?

Like the origin of the "aliens" themselves, this sense of existential humility may prove to be a clever construct designed to limit our perceptions.

**Mysteries of 'UFO Ranch' in spotlight

In 1996 a Las Vegas billionaire bought a ranch in Fort Duchesne from a family who had, for all intents and purposes, been run off of their property by forces they could not explain. All they knew was that a series of bizarre events on their ranch had left them financially ailing, mentally anguished, and in the end, horrified and afraid.

Surveillance and full-time caretakers remain on the ranch in Fort Duchesne that has become known for paranormal activity. The property is still owned by the National Institute for Discovery Science.

Vanishing and mutilated cattle. Unidentified flying objects. Huge, otherworldly creatures. Invisible objects emitting magnetic fields capable of causing destruction.

A book has now been published about what went on in the late 1990s and early 2000s at what was dubbed the "UFO ranch," an area in west Uintah County known for its 50-year history of perplexing and even frightening events said to have taken place there.

Colm Kelleher, the co-author of the recently published "*Hunt for the Skinwalker*," was a research immunologist at the National Jewish Medical and Research Center, in Denver, when he came across "a very strange job-placement advertisement" in a respected scientific magazine. The wording caught his eye, he said. The ad's author was looking for scientists interested in "exploring the origin and evolution of consciousness in the universe."

Kelleher said he found the ad "so completely unusual" that he was compelled to respond. "I have had a long-standing interest in scientific anomalies," he said in an interview from his home in northern California. Kelleher is currently working as a senior scientist in biotechnology in the private sector.

A native of Ireland, with reams of scientific degrees behind his name, Kelleher answered the ad and joined a team of respected mainstream research scientists with backgrounds in physics, biochemistry and veterinary studies, who were working for the National Institute of Discovery Science (NIDS).

Founded by real-estate and aerospace tycoon Robert Bigelow, NIDS was intent on removing the crackpot element from the study of the paranormal. Bigelow's goal was to study paranormal events purely from an unbiased and authentic scientific angle, using the brightest minds and the latest technology. "NIDS had a uniquely deep range of analytical capabilities," Kelleher explained.

That's how Kelleher and other NIDS scientists and researchers ended up living part time on the mysterious ranch in west Uintah County that borders the Ute Indian Reservation. The reservation itself, as they discovered through interviews with its residents, is not exempt from

unexplained events similar to those that occurred on the neighboring ranch.

Kelleher worked on the book with award-winning Las Vegas investigative reporter George Knapp, the only journalist ever allowed on the ranch. Kelleher and Knapp detail the days and nights the family spent on their working cattle ranch, besieged by forces which, they found out, never played by the rules. The book also relates the many haunting mysteries that happened to NIDS researchers after they arrived in March 1997.

One of those still unexplained events involved the mutilation of an 84-pound calf that occurred just minutes after the animal had been tagged by the ranch manager. "We were fortunate to get the vet and full NIDS staff up there in five hours," Kelleher recalled. "It was 10 a.m., March 10, 1997. The ranch manager and his wife had just tagged it and their dog started acting strangely. They went back to investigate 45 minutes later, and in the field in broad daylight found the calf and its body cavity empty."

One of the strangest things was there was not a drop of blood on the animal or on the ground, said Kelleher. "Most people know if an 84 pound calf is killed there is blood spread around," he added. "It was as if all of the blood had been removed in a very thorough way." The calf incident was the opening salvo, according to Kelleher. "That early summer and stretching into late summer, there were multiple incidents."

The researchers saw large, ferocious animals with piercing yellow eyes. Although they were seen, they left few tracks and in a few cases, were not injured when struck by bullets, Kelleher said. "Three eyewitnesses saw a very large animal in a tree and also another large animal at the base of the tree," which was shot but never found, he said. "We had videotape equipment, night vision equipment," Kelleher said. "We started hunting around the tree for the carcass and there was no evidence whatsoever."

The same problem was encountered when flying orbs were seen by several people. Expensive audio and video recording devices were meticulously placed but produced nothing, and one time the NIDS teams found their equipment vandalized, with taped wires ripped apart and no evidence at all to point to the culprit or culprits who had wreaked the havoc. "It was very difficult to gather the kind of

evidence consistent with scientific publication," said Kelleher.

In the book, Kelleher and Knapp not only allow the reader inside the ranch, which remains off limits to the public, they also provide a detailed history of observances of phenomena such as skinwalkers, UFO sightings and flying orbs. They delve into Native American legends and curses that had some connection to the events they had witnessed or that people had recounted to them. The pair also spoke to a number of Uintah Basin residents who shared their own encounters with the paranormal in areas not too far from the ranch.

Kelleher and Knapp examine the gamut of possible explanations for what they had seen. Hoaxes, hallucinations, conspiracy theories, military experiments are all investigated and essentially eliminated. Despite plotting out close to 100 incidents or anomalies, the authors do not lay out the full array of scientific data and charts in the book, preferring to gear their narrative to a lay audience.

NIDS disbanded in 2004, after paranormal phenomenon at the ranch and indeed throughout the nation seemed to dramatically decrease, starting in 2000, Kelleher said.

Did he feel his involvement with the group was worth it? While acknowledging that the field of the paranormal has "a bad reputation," his answer is unequivocal: "I firmly believe the study of anomalies can open doors into other fields."

For Kelleher, research into anomalies that occurred on the ranch are basic to the discovery process connected to science, because they ultimately open doors to advance mainstream knowledge. "One hundred years ago meteors were not considered real in science. They were figments of imagination, hallucinations," he said. "That's the way science progresses."

Minnesota UFO Reports by Dean and Margaret DeHarpporte

It was in August or September of 2003 that a man took his new Orion telescope out into the countryside outside of Farmington, MN, to try it out and look at the full moon and stars. It was about 2 or 3 a.m. as he recalls, with no streetlights or other artificial lights in the vicinity. Occasionally he would look around, just to look at the stars to see if there was a point of interest to redirect his telescope. On this particular occasion he looked to the west and saw some lights, moving slowly, and not blinking, as he expected a plane's lights would be. It seemed to him to be traveling at 10 to 15 miles an hour, making him admittedly nervous, due to the unreasonable slow speed, and, as it got closer, the total lack of any accompanying noise.

He reiterated it bothered him quite a bit, as he also saw the enormous size as it passed over a farm house nearby and he was able to see the size of the craft was perhaps 3 times the size of the farmhouse. He estimated the object to be at approximately 500-1000 feet elevation. He noted a curved row of lights in red, blue and green. When he drew the row of lights, it appeared as boomerang shaped. This was on the perceived leading edge of the craft, and he couldn't get a real good feel as to whether he was looking at the bottom, top, or front edge. He describes the lights as not blinking, rather "rippling", like in a wave, from left to right. All he could see of the structure of the craft was what he took to be a wing. It went over him slowly, noiselessly, going to the east and in an estimated 15 minutes was gone.

While the object was passing over him he noted there was an area of black, where he could see no stars. He waited until the object was out of sight and jumped in his truck and took off, admittedly quite spooked and fearful. He said he just wanted to find somebody to tell about this. (He went on home and awoke his wife). He reports no physical effects other than being really scared, as he couldn't understand what he'd seen. Sometime after having this sighting, he started looking on line and at tapes and DVD's that might show something like he saw. He showed us a DVD he'd made of a tape he found, showing amateur footage of various UFO sightings, and on it was a very brief footage of something very like he saw. He said he would try to duplicate the tape/ DVD and let us have a copy. If we get that, we will show it at a MUFON meeting for all to see.

This sighting investigation is ongoing, being investigated by Dean and Margaret DeHarpporte.

T. M., around May-June of 1990-92 was driving to work with the window down with two co-workers when he heard a loud roaring sound. He looked out the window and saw an intense light estimated to be larger than the truck he was driving. The light revealed a structure of unknown material beneath the light. The light was globular and colored yellow-orange with a blue-green tail. It was spinning and stopped and spun in the opposite direction. During the very brief period when the light was not spinning the sound stopped. It was estimated that it was moving in excess of 1000 mph. The duration of the sighting was about 4 seconds. None of the men was frightened by their experience. The witness was an ex-Marine who was familiar with the appearance and sound of military jet aircraft. The craft revealed by the light was globular with no resemblance to any jet aircraft. The sound of the light and its path parallel to the ground makes it unlikely that it was a meteor or space junk. The sighting is classified unknown.

General George S. Brown Chairman JCS Comments on UFOs

In 1968, when I was an Intelligence Officer, I briefed General George S. Brown, at 7th Air Force Headquarters in Saigon, Vietnam about UFOs near the DMZ.

General Brown states in a Department of Defense transcript of press conference in Illinois, October 16, 1973. "I don't know whether this story has ever been told or not. They weren't called UFOs." They were called enemy helicopters. And they were only seen at night and they were only seen in certain places. They were seen up around the DMZ in the summer of '68. And this resulted in quite a little battle. And in the course of this, an Australian destroyer took a hit and we never found any enemy, we only found ourselves when this had all been sorted out. And this caused some shooting there, and there was no enemy at all involved, but we always reacted. Always after dark. The same thing happened up at Pleiku at the Highlands in '69." Thanks to General George S. Brown, USAF Chief of Staff and later Chairman of the Joint Chiefs.

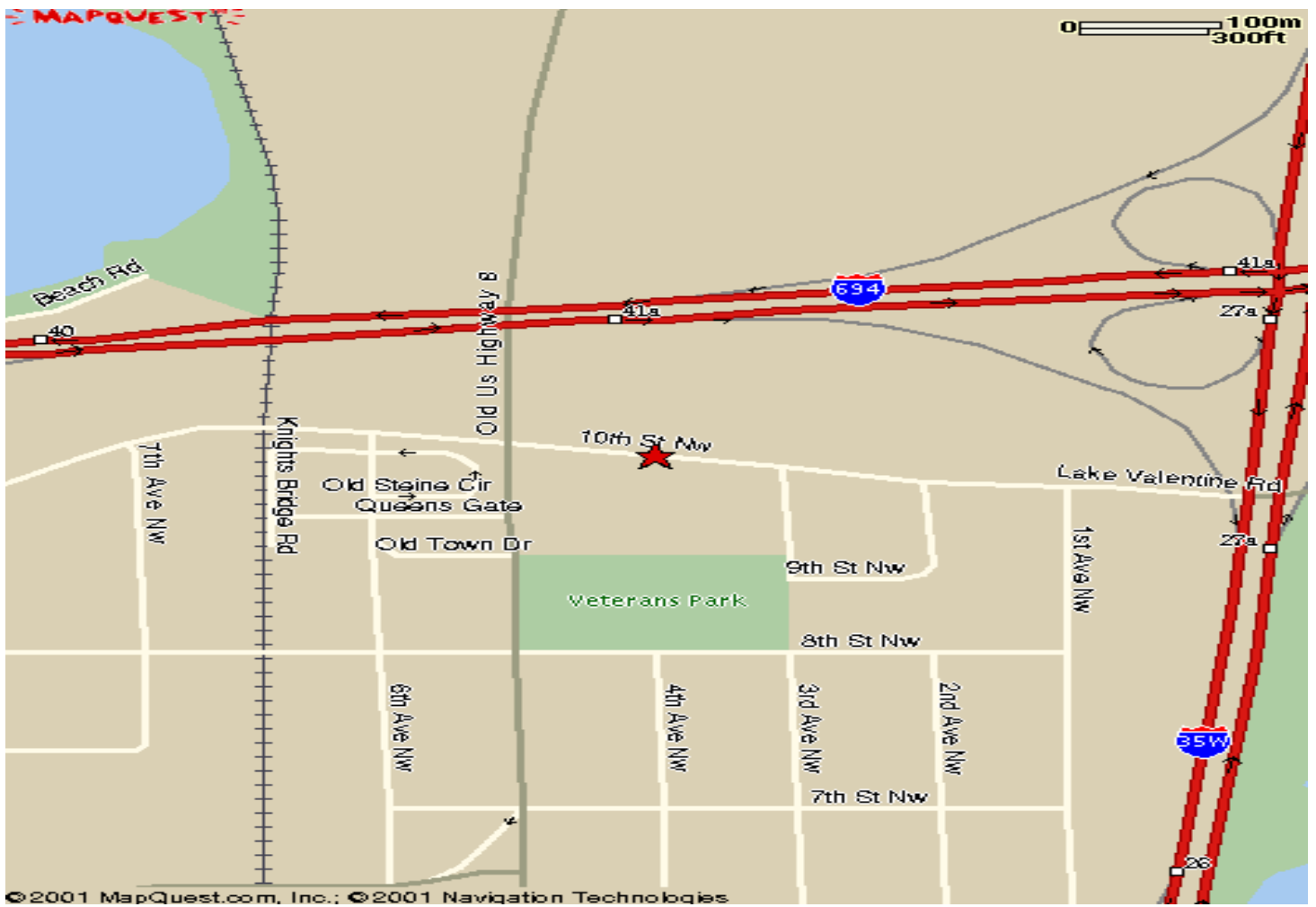
