Two Encounters By Dick Moss, MUFON MN State Dir.

Many people are reluctant to talk about a personal UFO experience if an occupant was seen. They have heard of the ridicule experienced by people who told their story and especially if the witness mentioned the presence of an entity.

A Minnesota woman was on vacation with her daughter at a lake resort. One evening after dark they saw a bright red light nearby and, after a short observation, realized that it looked like a UFO of a shape that they had seen in magazine pictures. The craft was close to their cabin and the surroundings reflected its red glow. The craft had a dome with windows and light was emanating from them.

The women felt that that they were being observed as three entities could be seen behind the windows. One of them turned off the cabin lights and lights inside the object simultaneously went off also. The woman felt an urge to run out of the cabin and towards the object. As her daughter was screaming, she kept running toward the craft. The UFO lifted silently, stopped for a moment, and then shot straight up and disappeared almost instantly.

Back in their cabin they spent considerable time trying to calm down. When her daughter asked her mother why she had run towards the object she replied that she was simply compelled her to do so. They agreed not to say anything about their brief encounter to anyone.

In 1970 there was an event in Canada somewhat similar to the event described above. A nurse was opening windows in a hospital room when she saw an object hovering outside. After staring at it for a while she called to some nearby nurses to come and see the flying saucer. They watched it for a while and saw it leave at a high speed.

But, none of the other nurses that had also seen it knew that the nurse who had opened the windows had seen some entities inside the craft's dome when it tilted towards her. The entities wore dark clothing and their faces were concealed by helmets that they were wearing.

So, a Canadian nurse and a Minnesota woman each claimed to have seen a domed disk and might have received mental impressions from the entities. Reports like this became so numerous that the Aerial Phenomena Research Organization included questions about it on their investigation forms.

MUFON to receive major funding from billionaire backer Eddie Middleton, Nashville UFO Examiner, March 6, 2009

Billionaire real estate investor and entrepreneur Robert Bigelow of Las Vegas is now betting his bucks on MUFON to find valuable new knowledge about alien propulsion systems.

Bigelow, who has long been known to give millions of dollars to fund serious UFO research, has just concluded a deal with MUFON whereby he will supply this organization with whatever it needs to be able to go out and bring back the hard evidence, not only to document the reality of UFOs interacting with us, but most importantly to gather the kind of information that will truly advance scientific understanding of this phenomenon.

This may well prove to be a historical occasion for MUFON and for the science of Ufology in general. MUFON since its inception has been a volunteer effort on the part of civilians who devote whatever spare time and energies they can afford in order to fulfill MUFON's stated mission of scientifically investigating the UFO phenomenon for the benefit of humanity.

Now for the first time MUFON's members are going to be paid to do their work. MUFON's agreement with Bigelow is to train and qualify a special rapid response team of Field Investigators who can be deployed within 24 hours to the scene of a major UFO event, the kind designated as Category 2 or 3 in the classification system devised by legendary UFO researcher Jacques Vallee. These are the rarer cases where either physical traces are left or physiological effects are caused in the witness.

Bigelow has hired 50 top-flight scientists to assist MUFON in this endeavor who will function as consultants and do expensive lab analysis of alien materials gathered at the location of a UFO event. Bigelow, who never does anything on a small scale, a few years ago founded BAASS (Bigelow Aerospace Advanced Space Studies) with the incredibly ambitious goal of putting a commercial hotel up in orbit around the earth. He thinks that even one category 2 or 3 case if properly investigated can yield significant scientific paydirt.

Whatever high-tech equipment needed by the investigators on the scene will be drop-shipped to them overnight by BAASS. These high-profile cases will be investigated using the strictest methods of scientific protocol.

Bigelow who has been known to keep his findings on the UFO subject secret has agreed per his contract with MUFON to hold nothing back from this organization that is revealed in the BAASS lab analysis of materials supplied by MUFON. This project which just launched on March 1 is codenamed SIP (for Star Impact Project) . It is a pilot experiment and will be reviewed on June 30th to see if it has proven successful enough to warrant funding for the rest of the year.

Understandably there is a lot of excitement at MUFON Headquarters and among its membership. Now with this major infusion of funds from Bigelow, it will be better able than ever to carry out its stated mission. And Bigelow possibly will get what he wants to forward his goal.

How this will all work out is hard to guess. This is something that has never been tried before. MUFON and BAASS are moving into unchartered territory here. In any case, Bigelow's investing so heavily in MUFON's ability to make SIP a successful search and find operation for greater knowledge about alien technology is some extremely good PR for MUFON whose credibility can be expected to take a significant leap forward in the eyes of the general public.

At the April Minnesota MUFON meeting, we saw a rebroadcast of an old panel talk show from a series entitled "The Other Side." This show was recorded back in 1994, and featured a panel of UFO abductees/experiencers. On the panel were several noted abductees, as well as hypnotherapist Yvonne Smith. The moderator interviewed each member in turn, and then came a number of audience questions. The show also had its obligatory skeptic in the audience, Michael Shermer - editor of Skeptic magazine, who was there to tell us that the abduction phenomenon did not really exist.

One of the experiencers on the panel was <u>Karla Turner</u>, who has since passed away. Several others, such as <u>Melinda Leslie</u>, became significant names in the abduction field in subsequent years. However, even though it was old and somewhat outdated - the show still gave one a good sense of the contemporary abduction scenario. Indeed, many aspects of the phenomenon really have not changed all that much in the years since then.

Each of the experiencers related accounts of their events - each a powerful narrative of a lifetime of close encounters. Then it was Michael Shermer's turn. Shermer claimed that the close encounter experience is essentially a dream - either awareness during sleep paralysis or some form of hallucination. He even cited, in which he was sleep deprived while on a cross-country marathon bicycle race. While he was bicycling, he says he saw a large object approach him and snatch him from his bicycle. His next memory was about 90 minutes later, again on his bicycle.

Shermer claims his own unusual event that this "event" was entirely a hallucination due to sleep deprivation. There are lots of things I could say about this case but I will simply ask the rhetorical question, "is he sure it was just a hallucination?" How does he know it wasn't an abduction? Isn't it really just his own faith that there is no such thing as alien abduction that leads him to say that it was purely sleep deprivation? I wonder - I have found that some hardcore debunkers often turn out to be experiencers.

One of the experiencers on the panel recounted an event in which some very telling physical evidence was left behind, something Shermer couldn't explain. Furthermore, the man remembered the event without the aid of hypnosis. Still, Shermer insisted that he didn't have to prove every case; he was only speaking in generalities. He also said that he was "not a debunker" of each case - hmmm, interesting comment from someone like Shermer, who makes his living debunking the paranormal. So I ask, isn't that exactly what Shermer has to do? Isn't it necessary for him to debunk *every* abduction case? If just one case can be shown to be an actual case of alien abduction, then by definition the phenomenon is real.

Still, Michael Shermer claims he is "not a debunker" and so, by definition he can speak in generalities. As a non-debunker, he "doesn't have to disprove every case." If that is the case, then how can he claim that there are NO encounter events? If he's not claiming that, then what exactly is his

claim? And what is his proof that abduction absolutely doesn't exist?

Furthermore, I wonder exactly what did happen to him on his bicycle during that period of time he can't remember, a strange object and a man too long without sleep?

Former Astronaut: Man Not Alone In Universe CNN - Atlanta, Georgia, April 20, 2009

(CNN) -- Earth Day may fall later this week, but as far as former NASA astronaut Edgar Mitchell and other UFO enthusiasts are concerned, the real story is happening elsewhere.

Mitchell, who was part of the 1971 Apollo 14 moon mission, asserted Monday that extraterrestrial life exists, and that the truth is being concealed by the U.S. and other governments. He delivered his remarks during an appearance at the National Press Club following the conclusion of the fifth annual X-Conference, a meeting of UFO activists and researchers studying the possibility of alien life forms.

Mankind has long wondered if we're "alone in the universe. [But] only in our period do we really have evidence. No, we're not alone," Mitchell said. "Our destiny, in my opinion, and we might as well get started with it, is [to] become a part of the planetary community. ... We should be ready to reach out beyond our planet and beyond our solar system to find out what is really going on out there."

Mitchell grew up in Roswell, New Mexico, which some UFO believers maintain was the site of a UFO crash in 1947. He said residents of his hometown "had been hushed and told not to talk about their experience by military authorities." They had been warned of "dire consequences" if they did so. But, he claimed, they "didn't want to go to the grave with their story. They wanted to tell somebody reliable. And being a local boy and having been to the moon, they considered me reliable enough to whisper in my ear their particular story."

Roughly 10 years ago, Mitchell claimed, he was finally given an appointment at Pentagon to discuss what he had been told. An unnamed admiral working for the Joint Chiefs of Staff promised to uncover the truth behind the Roswell story, Mitchell said. The stories of a UFO crash "were confirmed," but the admiral was then denied access when he "tried to get into the inner workings of that process."

The same admiral, Mitchell claimed, now denies the story.

"I urge those who are doubtful: Read the books, read the lore, start to understand what has really been going on. Because there really is no doubt we are being visited," he said. "The universe that we live in is much more wondrous, exciting, complex and far-reaching than we were ever able to know up to this point in time."

A NASA spokesman denied any cover-up. "NASA does not track UFOs. NASA is not involved in any sort of cover-up about alien life on this planet or anywhere else -- period," Michael Cabbage said Monday.

Debates have continued about what happened at Roswell. The U.S. Air Force said in 1994 that wreckage recovered there in 1947 was most likely from a balloon-launched classified government project.

Stephen Bassett, head of the Paradigm Research Group (PRG), which hosted the X-Conference, said that the truth about extraterrestrial life is being suppressed because it is politically explosive. "There is a third rail [in American politics], and that is the UFO question. It is many magnitudes more radioactive than Social Security ever dreamed to be," Bassett said.

Exopolitics Toronto, a citizen grass-roots watchdog group based in Toronto, Canada has issued an online report:

(http://www.prweb.com/releases/2009/03/prweb2264 574.htm) exposing the Canadian government's policy of covering up UFO and extraterrestrial-related sightings and interactions. After studying the Canadian government's release of 9500 files on its Archives Canada website, Exopolitics Canada concludes, "Although the UFO files compiled by high level government officials provide an interesting chronology of Canada's accumulation of UFO sightings, many of the files also tell a dramatic story about how high level government officials orchestrated meetings, agendas, memoranda and Ministerial letters designed to play-down and

ultimately cover-up the UFO issue with measures similar to those used by the American government."

Canada's low-key release of UFO and ETrelated files

Exopolitics Toronto points out that although the U.K. Ministry of Defence, the French and Danish governments released secret UFO/ET-related files in 2007, 2008, and through February 2009 to much orchestrated media coverage of a public disclosure process, the Canadian governmental agencies release of secret UFO/ET files relating to the period 1947-1983 took place in August 2005 and December 2007 with no orchestrated public media coverage.

A spokesperson for Exopolitics Toronto observes, "Our evaluation has revealed startling instances of several memoranda and letters, written by high level officials of the Canadian Department of National Defense that not only illustrate how officials attempted to minimize the immense frequency and ubiquitous nature of UFO sightings in Canada but also clearly demonstrate how the Department of National Defense orchestrated intradepartmental tactics and policy designed to explain all UFO sighting reports as fitting its preconceived and predetermined conclusion that all UFOs were nothing but weather phenomenon, meteors, manmade misidentifications or hoaxes."

U.S. policy towards UFOs and extraterrestrial life visiting Earth has not changed since the Durant Report of the 1953 C.I.A. Robertson Panel, which required all such reports to be subject to public ridicule.

Canada's contradictory UFO/ET policy mimics U.S. UFO/ET cover-up.

Exopolitics Toronto's investigation has led them to conclude that Canada's 2005 and 2007 release of UFO/ET-related files differed significantly from the UFO/ET-related releases by France, the U.K. and Denmark. According to Exopolitics Toronto, the government of Canada may have conspired to cover-up UFO and extraterrestrial-related sightings by employing an internally contradictory, confusing policy.

The Exopolitics Canada report states, "One memo identifies how the Canadian government planned to use a policy strategy employed by the United States Air Force (USAF) to "play-down" UFO reports made to them by citizens. A second memo discusses

plans to actually deal with landings of UFOs. (Ed. Note: The use of the word "landing" in this memo implies, in aeronautical terminology the controlled descent and safe alighting of an aircraft, further implying Canadian officials considered the possibility such unidentified craft may be under intelligent control.) In a third letter the Minister of National Defense Douglas Harkness states in no uncertain terms to a Canadian citizen that no department within the government had instructions to withhold information about objects that may be of extraterrestrial origin."

Canadian UFO and extraterrestrial reports relate to 4 governmental agencies:

- 1. The National Defense Department,
- 2. The Department of Transport,
- 3. The NRC (National Research Council) and,
- 4. The RCMP (Royal Canadian Mounted Police)

An independent press investigation

Exopolitics Toronto has called for an independent press investigation of what it terms a conspiracy within the government of Canada to cover-up UFO and extraterrestrial sightings and landings on Canadian territory and airspace.

Their report concludes: "These three files may represent the political 'smoking gun' needed to launch an all-out investigation by the Press. There is every reason to believe that if the Canadian media, and even those in the international media, were to press the Canadian government for an investigation of these issues, such an investigation would expose the most momentous cover-up in history; Earth has been visited by craft of unknown origin, craft that may represent the presence of technologically advanced off-world civilizations. Why mainstream press continues to disregard these Canadian file releases as well as overwhelming evidence is perhaps an even greater media mystery if not a journalistic tragedy."

Exopolitics Toronto introduces Hon. Paul Hellyer

On Sept. 25, 2005, Exopolitics Toronto held a forum at the University of Toronto, which introduced the Hon. Paul Hellyer, former Minister of Defence and Deputy Prime Minister of Canada and his views on public policy towards extraterrestrial civilization. At that Forum, Heller stated, "The United States military are preparing weapons which could be used against the aliens,

and they could get us into an intergalactic war without us ever having any warning."

During Canadian centennial celebrations on June 3, 1967 while Minister of Defence, Hellyer flew in by helicopter to officially inaugurate an Unidentified flying object landing pad in St. Paul, Alberta. St. Paul had built the landing pad as a symbol of keeping space free from human warfare. The sign beside the pad reads: "The area under the World's Landing Pad was UFO designated international by the Town of St. Paul as a symbol of our faith that mankind will maintain the outer universe free from national wars and strife. That future travel in space will be safe for all intergalactic beings, all visitors from earth or otherwise are welcome to this territory and to the Town of St. Paul."

Governments Should Declare UFOs Exist Says Researcher By Jasper Seren and Joan Delaney, Epoch Times - Suwanee, California, USA, Apr 29, 2009

For years, governments around the world have been very careful to keep information gathered about Unidentified Flying Objects out of the public eye.

But finally this February, the Canadian government opened thousands of federal records covering UFO sightings between 1947 and the early 1980s. France, Britain, Chile, Russia and Denmark have also opened their files to some degree to the public.

Britain, which released its first batch of 'X files' the day after the Vatican astronomer declared in May 2008 that extraterrestrial life is "part of creation", will release more records over the next four years.

With this momentum, Alberta UFO researcher and author Jim Moroney says the time has come for governments to go one step further and make a pronouncement that UFOs do indeed exist.

"To reduce rumours and misinformation and to frame single or multiple UFO events, it would be advisable to announce that UFO's exist as early as possible", says Moroney, an instructor at the University of Calgary and author of The New Bridge - Planning for the Extraterrestrial Presence.

"I am convinced that it is time for us to make a considerable effort to lift the veil of fear and uncertainty about this subject and develop an appropriate response", he says.

While the release of the files is "a good start", Moroney says governments now need to "develop a more concrete strategic plan to effectively deal with the increasing UFO activity and the public's corresponding increase in demands for accurate, reliable, and truthful information."

While it is widely surmised that the reason governments keep UFO records secret is to avoid widespread panic, Moroney, who has a background in science and is executive director for the Alberta Municipal Health and Safety Association, says that's not likely to happen. In fact, withholding information could even be counter - productive.

"From our work with disaster planning, the evidence shows that public panic is rare and most rare when people have been candidly informed", he says.

"There is no sound scientific basis for withholding information about the UFO phenomenon from the public. In fact the evidence shows that the longer officials withhold any worrisome information, the more frightening the information will seem when it is revealed, especially when it is revealed by an outside source."

The 9,000 - plus Canadian files are different from those of other countries in that they don't only list UFO sightings but also include analyses and inter-departmental meetings of Canadian officials on the issue.

While Washington is still keeping its UFO records tight to its chest, ufologists are hopeful that President Barack Obama's "change agenda" will soon result in the country's huge UFO archives being released to the world.

In an interview on Larry King Live, American UFO expert Peter Davenport called it "encouraging" that some countries are opening up their UFO files, and said he hopes the U.S. government will allow those in senior positions who have been sworn to secrecy to speak publicly about what they know.

"I would look to the United States now to do the same - as other countries - and what I would like to see is somebody senior in the U.S. government, in the military and intelligence communities, say to its people, 'If you know anything about the UFO phenomenon you are free to talk to the press and to the American public.' That would solve the problem in a hurry."

Moroney, who has been researching UFOs for over 20 years, says keeping the public out of the loop is "appallingly short - sighted."

"UFO communication messages must include information about what the public can do. The public is entitled to information that affects their lives and their families. Explaining what individuals can do will empower them to participate in activities that may be beneficial to improving our understanding of the phenomenon."

A memo in the Canadian files details a UFO sighting at Shag Harbour, Newfoundland, witnessed by an RCMP officer and six civilians on the night of October 4, 1967.

The memo describes how the witnesses reported seeing an object "60 feet in length, moving in an easterly direction before it descended rapidly into the water, making a bright splash on impact... A single white light appeared on the surface of the water for a short period of time."

In the U.S., one of the most remarkable sightings was the so - called "Phoenix lights wave" of 1997, in which a craft estimated to be a mile in length, along with some smaller UFOs, moved over the state of Nevada and was witnessed by thousands.

Apollo 14 veteran Dr. Edgar Mitchell, who in 1971 became the sixth man to walk on the moon, told a British radio station in July 2008 that Earth is being visited by alien beings and "the UFO phenomenon is real, though it has been covered up by our governments for a very long time."

Mitchell referred to the famous Roswell incident of 1947 in which it is believed that the U.S. Government covered up the crash and subsequent salvage of an alien craft and the beings it carried.

However, Mitchell said that with public awareness of UFOs increasing, there are fewer efforts by governments to engage in cover ups and misinformation. He added that he thinks "we are heading towards a major disclosure" on UFOs.

"It is no longer a question of when will humanity interact with extraterrestrials, but rather the much more difficult question of how they have decided to interact with us", Moroney says.

General Lance W. Lord, former commander of the Air Force Space Command, argues that military leaders must think of space as a battleground. Indeed, the combat capabilities provided by advanced orbital systems increasingly are at risk. "Some would say that we're not threatened in space," Lord observed. "I want to disabuse everybody of that argument." Lord delivered his warning at the Air Force Associations annual National Symposium in LA.

Editor's Note: The logical question that needs to be asked? Who is threatening advanced US orbital systems? Is General Lord talking about the Chinese, the Russians or even Extraterrestrials? The fundamental fact confronting us is the existence of a thousand UFO sighting reports each month. Some of these reports may be fraudulent, but most MUFON investigators have concluded that the majority of the reports are quite valid. The witnesses believe they see something real, external, artificial, and not normal types of aircraft. On logical grounds all possible explanations can be subdivided into two major categories, namely, a physically real, manufactured object that the witness could not relate to, or to something entirely different, such as obscure natural phenomena, hoaxes, or psychic projections. We know that the best UFO reports are often observed by relatively experienced witnesses such as police, astronomers and aircrews. We have obtained previously classified Air Force documents signed by General Nathan Twining Commander of the Air Material Command stating: "The phenomenon is something real and not visionary or fictitious."

Air Force Space Command operates satellites sensors that are able to pick up unidentified flying objects that are entering and leaving our atmosphere called Fastwalkers." Several UFOs coming in from space are picked up each week.

North America's early warning system is now being upgraded and in their 22,300 mile geosynchronous orbits, satellites help protect the United States and

its allies by detecting missile launches, space launches and nuclear detonations.

hundred Fastwalkers Several within our atmosphere are tracked worldwide each month. The new satellites should be able to track many more Fastwalkers with their improved infrared sensors designed to detect heat from missile and booster plumes against the earth's background. Insiders report there is a great deal of excitement as the UFOs sometimes trigger the early warning system setting off alarms that missiles have been launched. Computers keep track of over 6,000 satellites and pieces of debris in space. The Fastwalkers are also referred to as Uncorrelated Targets indicating they are not in the data base for objects in space. The Individual Target Event Database which is unclassified should be made available to MUFON and the Filer Research Institute so we can correlate ground based and aircraft sightings with satellite data.

The new Space Based Space Surveillance (SBSS) system is a planned constellation of satellites and supporting ground infrastructure that will improve the ability to detect and track space objects in orbit around the Earth. The primary SBSS contractor, Boeing, characterizes some orbiting space objects as, "Potential future threats to the United States' space assets

Boeing has finished installing the hardware for its Space Based Space Surveillance (SBSS) system's Satellite Operations Center in Los Angeles. The SOC now has the necessary security certification to allow the SBSS program to begin integrated testing. Their mission is to "develop, deliver, and sustain" capabilities that "ensure space superiority" for the United States

U.S. Air Force Col. James Jordan, commander of the Space Situational Awareness Group in the Space Superiority Systems Wing states, "When launched in spring 2009, SBSS will revolutionize the nation's space situational awareness with enhanced performance by providing around-the-clock visibility to detect distant space objects without interference from weather, atmosphere or daylight." The first "pathfinder" satellite of the SBSS system, will launch in the Spring of 2009 on a Minotaur rocket.

Star travel earlier than we thought? ©2009 by Craig R. Lang, MS CHt

I recently saw a series of YouTube postings entitled Further Conversations with Jack Sarfatti http://www.youtube.com/watch?v=NCsnmn17csI Part 1 thru Part 6 and although obscure, to me the implications are astounding. After a period of pessimism about the future of humanity in space, today I am more optimistic than I ever was that humanity's destiny is in the stars.

Over the years, Jack Sarfatti has always been a bit of an icon to me. I have followed and admired his work, including spending a fair amount of time perusing his website: www.stardrive.org. The site describes much of his research and thinking in both consciousness studies and gravity physics - both direct descendants of zero point theory. In recent times, the site appears to have fallen into disrepair, yet the information on there is still extremely interesting.

I studied physics during my undergrad years in the mid 1970s and learned some fascinating stuff. This included an undergrad level of understanding of the mathematics behind quantum physics, particle theory, etc. However, since that time, I hadn't followed the progress at the leading edge of quantum physics beyond what you can read in Scientific American, etc. I also hadn't followed the latest in gravity theory, zero point theory, etc. - all having advanced incredibly since my undergrad years. So when I listened to Sarfatti's YouTube interview today, my jaw dropped. Based upon what I heard presented there, I believe that we could have working star travel: antigravity propulsion, and all that goes with it, within a hundred to two hundred years. The revolution is truly just around the corner.

A few years earlier, Gwyn and I attended a lecture by Dr. Mark Millis, at that time the head of NASA's Breakthrough Propulsion Workshop http://www.grc.nasa.gov/WWW/bpp/

In it, Dr. Millis described the essential hurdles facing star travel, and possible propulsion research coming out of NASA's advanced concepts work. Dr. Millis stated that the biggest problems in the physics of possible star travel have always been:

 Propulsion - how do we propel a spacecraft fast enough to cover the distance to a nearby star in a reasonable period of time?

- Energy how do we obtain the truly prodigious amounts of energy required to travel interstellar distances.
- Gravity how can we tailor gravity fields to both provide the acceleration as well as provide artificial gravity within the starship, itself.

If we move beyond rocketry and begin to study other modes of propulsion, we eventually find that in order to travel to the stars we will have to be able to understand and control gravity. Arguably, this is not something we could do using conventional physics and Dr. Millis stated that we need to think WAYYYY out of the box on this one. Surprisingly (at least to me) there is far more of a mathematical foundation behind this than I thought. I hadn't realized just how much so until listening to the Sarfatti interview on YouTube.

The biggest breakthrough has apparently come through the relatively recent emergence of dark matter, and then of dark energy, in cosmology research during the last couple of decades. Over most of my lifetime, the problem that there was not enough mass in the universe has baffled astronomers/cosmologists. The universe is not gravitationally closed. Therefore, it should ultimately drift off into an infinite void. This was theoretically and poetically unfulfilling; there must be about 10 times as much mass out there, unobserved in some way. Over the ensuing ten vears, it was found that the there seems to be just enough mass, and therefore curvature, to exactly close the universe. So rather than be a mere theoretical artifice, the missing mass must actually exist. It was thus given the (un)imaginative term name of "dark matter".

Then, in 1999, came the <u>cosmological measurements</u> of <u>Dr. Saul Perlmutter et. al.</u> These were expected to confirm this model - that the universe was slowing down at just the right rate to prevent it from expanding forever, yet never falling back in on itself, either. "Unfortunately," the experiments found something different - that rather than slowing down, the universe was accelerating (!!!). This meant that something out there was actually pushing the universe apart - effectively a cosmological scale antigravity. This meant that in some way, antigravity must be possible - because it actually exists.

At that same conference where we heard Dr. Mark Millis, Gwyn and I also attended a talk by <u>Dr. Ning Li</u>, an experimental physicist. In this talk, Dr. Li

addressed the apparent interaction between superconductivity, electromagnetism, zero-point physics and gravitation. Again, most of it was rather over my head, but I did get the gist of what she said (I think I did, anyhow). She build a mathematical physical for the effects within superconductor causing a coherence within the zero-point field, which in turn resulted in modification (shielding) of the gravitational field. Much of this was a theoretical response to the experiments Tempere. in http://www.electrogravityphysics.com/html/tampere.ht ml, which have apparently shown interactions between superconductivity and gravity. Thus, Dr. Li had built a one of the first cases that I knew of for actual gravity modification. Indeed, gravity control WAS possible.

Now, with the concept that the universe is accelerating, it seems that indeed, gravity is far more pliable than we thought. Apparently, the cosmos is made up of about 3/4 dark energy, and only 1/4 matter. Antigravity is not only present, but it is the most prevalent thing in the universe.

Returning to the YouTube interviews with Jack Sarfatti, I listened with rapt attention as he described how something like gravity modification might be accomplished. He talked about some of the current gravity-EM field experiments that are going on at Berkley, Cal Tech, and other leading edge physics institutions. Several of these are close to demonstrating actual conditions in which negative energy density could exist - and thus negative gravity. If this is the case, than the fundamental theoretical hurdle to star travel, the control of gravity, may soon fall.

Someone - perhaps Einstein – stated, "The difficult we can do tomorrow, the impossible may take longer." Now, just maybe, the impossibility of star travel has turned into the difficult task of actually doing it. It may a few centuries to master the "small matter of engineering" required to actually apply the physics to build a working "warp-drive" engine. But if these experiments pan out as described in Sarfatti's interview, then perhaps the biggest "impossibility" has begun to fall.

UFO Investigators Reveal Possible Otherwordly Relic from Roswell by Cid Standifer, Record Staff Writer, 4/30/2009

UFO investigators held a press conference at the Roswell Civic and Convention Center on Thursday to announce that they found ... something. "At this point, we don't know what it was or why it was there," said UFO investigator Chuck Zukowski. "I don't want to speculate."

"We want to announce to the world that this stuff needs further analysis," explained Dr. Bill Doleman, a retired archaeologist who supervised the dig where the items were found. The artifacts were discovered in 2002 during a dig sponsored by the Sci Fi Channel, at a site where some eyewitnesses say a mysterious craft ricocheted off the ground in 1947.

Zukowski and his sister Debbie Ziegelmeyer, state director of the Mutual UFO Network in Missouri, volunteered to help with the excavation, and found the object that has been most thoroughly analyzed. The tiny piece of silvery material came from a site where water tended to gather.

Ziegelmeyer was sifting through buckets of dirt when the object emerged, and she quickly clutched it to keep it from blowing away. The material began to curl up after it was exposed to sunlight. Ziegelmeyer speculated that it might have been sensitive to light or heat, although Doleman suggested it may have started to dry out after it was taken out of the ground. The item, along with other specimens found by the team, was stored at the University of New Mexico's Office of Contract Archaeology.

Zukowski said it took years for them to figure out whether they could run tests on the items. "We didn't really know who had responsibility for these things," he said. "After reams of paperwork I was able to get a hold of it."

Zukowski examined the item using an electron microscope. He said that the microscope belonged to a microchip manufacturer in Albuquerque, and a recently-retired technician helped him use it, but he declined to identify either the company or the assistant, saying it might be unseemly for them to be involved.

Zukowski said he determined that the artifact was mostly aluminum silicate. Other elements showed up in the sample, but he believes they are mostly from the microscope's surroundings or dirt that clung to the object. Doleman said that aluminum silicate is not uncommon in nature, but the item was found on a limestone plateau, which is mostly calcium carbonate. There seemed to be nothing around that would contain or produce the compound.

Zukowski also took extremely close-up pictures of the artifact, capturing some features only a few microns long. "We see some damage in here," he said, "and it's interesting that when you get down that small, you can see holes." He also displayed an image of what looked like a tiny metallic whisker. Zukowski, who designs microchips for a living, said that the features struck him as unusual. "We know this thing definitely is not organic, number one," he concluded. "Number two, we know it's not indigenous."

The small silvery object was one of many that turned up during the dig. Doleman presented slides of what looked like a piece of PVC pipe and fragments of plastic, as well as what seemed to be leather and rubber from a shoe. Doleman said that they had not been analyzed, and he would like to confirm that they are what they seem to be. "We want to figure out that they are using the best scientific methods available," he said.

The excavation also unearthed pieces of igneous rock that seemed out of place on the limestone plateau. "They look like they may have been burned," noted Doleman. "Who knows what kind of burning a UFO creates when it smacks into the earth and then goes bouncing back up into the sky?"

The items that Doleman found most interesting were some orange blobs of material. Assaigai Analytical Laboratories Inc. in Albuquerque found that they were modacrylic adhesive, a heat-resistant synthetic copolymer. The Union Carbide Corporation was the first to produce modacrylic fiber in 1949.

Zukowski said the modacrylic adhesive might tie into an eyewitness account. One of the volunteer excavators was Nancy Easly Johnson, daughter of Maj. Edwin Easly, who was allegedly at the crash site. Easly told Johnson little about the incident, but mentioned orange debris.

"We'd like to get (the objects) identified, and see if they can shed light on what happened in that broad in-the-middle-of-nowhere pasture on the Foster Ranch in 1947," said Doleman. "We're looking for funding, and/or professional laboratories who would be able to take this stuff and try and identify it."

He said that there would be benefits for any lab willing to do pro-bono work, including publicity, possible information about useful alien technology, and "everybody in the UFO community will think they're really cool."




BRIEF DESCRIPTION OF THE EVENT: Hovering

DETAILED DESCRIPTION OF THE EVENT:

The witness lives in Farmington. Although in CMS he gave the nearest city as Hastings, the sighting took place in Rosemount. He wrote: "Driving home on County Road 46, hereafter called Hwy 46] from a friend's house [in Hastings] around 9:45 pm, I saw a light that I thought was on a smoke stack." There are four smokestacks from the ruins of an old factory just to the north of Hwy 46. "As I got closer, I realized it was above a field, not on a stack. It was really bright! I pulled over on a dirt road to the right and got out of my car to look it at. I then noticed it was about 500 to 1000 feet away and 200 feet off the ground, perfectly silent and rock solid in the sky with no movement at all. It consisted of a bright light with two little blinking lights to either side of it." He estimated the randomly blinking lights to be about 10 feet apart." At first I thought it must be a plane landing, but it just sat there in the middle of the field for approximately 4 minutes. I then thought I would try and take a picture of it with my phone. As I was reaching for my phone, I got really freaked out thinking I was all alone on this dark road." He had an overwhelming feeling that he should get out of there, he said. "This is very unusual for me. I can barely remember getting back in my car, but I was shaking and scared, again unusual." He made a quick U-turn (throwing gravel in the process), drove the 300 feet or so back to Hwy 46 and started west. The southern border of the field along Hwy 46 is a few feet lower than the field and is mostly covered with a thick growth of trees. About 500 feet west of the intersection with Akron Ave. there is a gap in the trees. As the witness drove west he could see the object to the north thru this gap, and could see some kind of shape to it, which he later sketched. At this point the witness was distracted by the object to the extent that he almost drove off the road, but was able to pull back on the pavement, and proceeded on home.





FIELD INVESTIGATORS REPORT:

I met the witness at the site on 4-24-09. I had asked him to park his car in the same place he had parked it on 3-28-09. He parked about 300 feet north of Hwy 46. He showed how after he got out of his car, he stood forward of the driver's door by the engine compartment and was looking straight west at the object, which he now estimates was no more than 500 feet away and 50 to 100 feet off the ground. I asked him to try to locate the point in the field above which the object was hovering. The field is covered with corn stubble left after harvest of the grain. The east side of the field is covered with a dozen or so rows that run north and south, but the rest of the field is covered with rows that run east and west. Starting from his car, the witness walked straight west down a corn row, until he reached a point north of the gap in the trees along the highway to the south, and said he thought the object was no closer than that point. I marked it with a flag and he continued on, stopping at a point which he said he thought the object was no further away than that point, which I marked with another flag. The average distance from his car to these flags was about 490 feet, which is very close to the 500 feet he estimated after having thought about it since the original sighting. Since this point is directly north of the gap in the trees to the south, his estimate of 500 feet is confirmed. This also means that he was about 300 feet from the object when he continued on west on Hwy 46 at the time of the sighting.

Using our Casey Holt Memorial Radalert 50 Nuclear Radiation Monitor, I scanned an area of about 5600 sq. ft. around "ground zero". I also visually scanned the area from ground zero about 100 yards in all directions and saw nothing unusual.

The witness said that during the entire 9 minutes of the sighting, he heard no sound from the object. There was no wind; it was a warm, still night. He did hear a "bumping" sound from his car radio, and he turned it off. This possible electromagnetic interference may be significant.

The witness appeared to be a reliable and accurate observer. The witness made sketches of the object as viewed from the east and from the south. These sketches are obviously of some kind of craft. My conclusion is that this object must be considered to be an unknown aerial vehicle.

Doctor Who is being blamed for a big increase in sightings of UFOs.

The total across the UK has doubled in a year, according to the Ministry of Defence.

And the rise has been particularly noticeable in Wales, where Doctor Who and its spin-off Torchwood are both filmed.

In 2006, 97 UFOs were reported across the UK, rising to 135 in 2007 and 285 in 2008, with 18 sightings in Wales.

In the last three years there have been 28 reported sightings in Wales, none of which can be explained by the MoD.

And there have been nine already in the first few months of this year alone. Reports detail bright white objects over Anglesey, black disc-shaped objects in the skies over Neath Port Talbot and objects like footballs moving over Pontypridd.

And a UFO reported in Old Colwyn, Conwy, was described as "bigger than a helicopter?.

The MoD's former UFO expert Nick Pope said: "Doctor Who and Torchwood are filmed in Cardiff, so everyone in the area has aliens on their mind.

"Doctor Who captures people's imaginations and makes them wonder about alien life and look to the skies. Any strange light in the sky becomes a spaceship.

There have been quite a few sightings in Cardiff, Barry, Swansea and other built-up areas in the south of the country.

People think of UFO sightings as taking place in a deserted and dark part of the countryside, but many of the Wales sightings are from cities and towns."

He also claimed it is not the first time events on the screen have affected the number of UFO reports lodged with the MoD.

He said: "The MoD received more UFO reports in 1978 than any other year? and it was when Close Encounters Of The Third Kind was released here."

The main cover feature is all about poltergeists (including a creepy back cover), while the second feature article is a translation of "The Top Ten Ways to Destroy the Earth" by Sam Hughes, to which the magazine has added the subtitle "UFO Top Ten." None of the destruction methods is UFO-related (unless we consider the effect that the fragments of the destroyed Earth will have on other inhabited planets in the galaxy).

In fact, most of the actual UFO content in this issue consists of summaries of UFO reports in the Chinese media over the past few decades. Readers seeking more relevant UFO information can visit a new sub-board for The Journal of UFO Research that the Duzhe Group recently created on its website BBS.

When he tested the limits of his security oath in 1995 and went public with how a UFO crippled a nest of nuclear missiles in Montana during the Cold War, former Air Force captain Robert Salas was on his own. No one else who worked inside or around those subterranean silos dared talk about how the world's top superpower was unable to defend its own nuclear arsenal.

Today, UFOs And Nukes author Robert Hastings has 115 ex-USAF eyewitnesses on record, due in no small measure to Salas' willingness to gamble that the feds wouldn't go after him because prosecution would put them in a credibility jam. "If they did," Salas says from his home in Ojai, Calif., "we could have a righteous trial."

In 2005, the erstwhile deputy missile combat crew commander waved the red cape with even more vigor at the government bull by co-authoring "Faded Giant: The 1967 UFO/Missile Incidents." Salas' story was augmented by other witnesses and FOIA-acquired USAF documents acknowledging the Minuteman shutdown - but without mentioning the U-word.

Salas and co-author Jim Klotz demonstrated how the hovering phenomenon that disabled fully armed nukes on the early morning of March 24, 1967, acted with impunity and deliberate intent, and that its actions weren't confined to Salas' post. On March 16, UFOs also visited an ICBM site some 60 miles away, and shut down all 10 of its missiles in similar fashion.

Having apparently dodged legal repercussions, the 68-year-old former FAA aircraft certification engineer remains puzzled over the lack of MSM interest in the vulnerabilities of our deadliest weapons systems. Aside from appearances on Larry King and niche shows like Art Bell and The History Channel, Salas' story - and those of a growing number of colleagues - has been pretty much ignored by American media.

"I had high hopes for the Peter Jennings special," says Salas in reference to the ultimately feckless ABC prime-time "investigation" in 2005. "They seemed really interested. They flew me out to Dallas and got two, three hours on videotape. But a week before the show, they called and said, 'Sorry, we've got to cut you out.' I don't know if somebody got to them or what."

Forty-two years later, Salas remains in awe of what happened at Oscar Flight, the code-named Minuteman silo belonging to the 341st Strategic Missile Wing. Shortly after jittery topside guards reported bright aerial objects pulsing silently above the security gate, klaxons started shrieking and the missiles began losing power in rapid succession, one by one, until six to eight amid the 10-shot cluster were reduced to no-alert status. Security upstairs reported the objects flew off immediately afterwards.

"Somehow," recalls Salas, who monitored the control panels alongside bunker colleague Lt. Fred Mywald, "these objects were able to penetrate 65 feet of earth and a completely shielded cabling system with an electromagnetic pulse that sent signals to upset the most sophisticated weapons in the world."

Those signals were strong enough to foil the missiles' guidance and control mechanisms, Salas says. An account of the March '67 incidents is available at http://www.cufon.org/cufon/malmstrom/malm1.htm but by no means are they the only ones involving UFO security breaches with nukes. Salas is in contact with plenty of other witnesses who've yet to come forward.

But even if they did, would the media bother to shrug?

"To me, it was a benevolent message," says Salas, whose world view was forever altered by the event. "My own speculation is that these objects were saying we shouldn't be messing with nuclear weapons because we might destroy ourselves."

But maybe that's not news.

Philip Schneider, UFOs And The Black Budget

Philip Schneider was mysteriously found dead on January 16, 1996 after conducting several controversial lectures throughout the US, including Denver where he covered topics such as, Space-Defense, black helicopters, railroad cars built with shackles, extraterrestrials and the secret black budget.

Philip Schneider claimed to be an ex-government structural engineer who helped build deep underground military bases (DUMB) around the United States. His ex-wife, Cynthia Drayer believes that Philip Schneider was murdered because he publicly revealed the truth about the US government's involvement with UFOs.

The following quote is from Philip Schneider from one of his lectures:

"I love the country I am living in more than I love my life, but I would not be standing before you now, risking my life, if I did not believe it was so. The first part of this talk is going to concern deep underground military bases and the Black Budget. The Black Budget is a secretive budget that garners 25% of the gross national product of the United States. The Black Budget currently consumes \$1.25 trillion per year. At least this amount is used in black programs, like those concerned with deep underground military bases. Presently, there are 129 deep underground military bases in the United States".

Philip Schneider recounts his encounter with extraterrestrials in the following excerpt:

"I was involved in building an addition to the deep underground military base at Dulce, which is probably the deepest base. My job was to go down the holes and check the rock samples, and recommend the explosive to deal with the particular rock. As I was headed down there, we found ourselves amidst a large cavern that was full of outer-space aliens, otherwise known as large Greys. I shot two of them. At that time, there were 30 people down there. About 40 more came down after this started, and all of them got killed. We had surprised a whole underground base of existing aliens. Later, we found out that they had been living on our planet for a long time, perhaps a million years. This could explain a lot of what is behind the theory of ancient astronauts."

"Anyway, I got shot in the chest with one of their weapons, which was a box on their body that blew a hole in me and gave me a nasty dose of cobalt radiation. I have had cancer because of that."

"I didn't get really interested in UFO technology until I started work at Area 51, north of Las Vegas. After about two years recuperating after the 1979 incident, I went back to work for Morrison and Knudson, EG&G and other companies."

Philip Schneider released a lot of information pertaining to a supposed deep underground base under Denver International Airport as well. He said these underground bases were all throughout the US and they all were connected by a super highway.

Philip's father Oscar Schneider was also said to have worked on secret government projects including the Philadelphia Experiment, which is the disputed story of the US Navy who supposedly made their large ship invisible for a brief amount of time. Philip and his family were reportedly harassed by government agents including his daughter who says she was being

followed and monitored at school. Philip's ex-wife Cynthia Drayer does not believe that he committed suicide. Here are some of her reasons:

- 1. "There was no suicide note."
- 2. Philip always told his friends and relatives, that if he ever 'committed suicide' you would know that he had been murdered".
- 3. "From a number of sources, including his taped lectures (video and audio), and statements to his friends, and the borrowing of a 9mm gun, Philip felt that he and his family were being threatened and were in danger because of his lectures".
- 4. "All of his lecture materials, alien metals, higher math books, photographs of UFO's coming out of the Operation Crossroad A-Bomb, notes for his book on the alien agenda, were missing. (Everything else in the apartment was still there, including gold coins, wallet with hundreds of dollars, jewelry, mineral specimens, etc)".
- 5. "No coroner ever came out to his apartment after his body was found (against Oregon Law) and a police investigation never took under consideration that items were missing from his apartment it was considered a suicide, plain and simple".

Schneider's death is still a mystery, there are reports that he committed suicide and reports that he was found tortured with piano wire around his neck. There are other reports suggesting that he had a stroke or a heart attack. No one may ever know the truth of Schneider's claims but there is no doubt that he was an interesting figure and that he had some very disturbing and controversial things to say.

The Coordinate Remote Viewing Manual has been released by the US government with an Introduction by Paul H. Smith (Major, ret.) who states "For a number of what I consider to be very good reasons, I strenuously resisted making the Defense Intelligence Agency (DIA CRV) manual public. Since some of my former colleagues had fewer reservations about its dissemination, it now appears inevitable that the manual will become widely available, beginning with its posting here on this webpage.
