Crashed Flying Saucers

In early 1948 military defense observers in Colorado registered an object descending over a region in northwestern New Mexico. During the hours that followed, Air Force personnel located the position of the landed object and cordoned off the area where it rested. Military scientists and instruments were brought in. Air Force investigators proceeded cautiously because it was obvious to them that the object was an alien space craft. The silver disk was about one hundred feet in diameter. The investigating scientists discovered the charred corpses of sixteen entities which looked much like humans except that their teeth were flawless. Their heights were in the usual range of three to three and one-half feet.

The endless rumors of crashed flying saucers have plagued researchers like a nagging backache. It turns out that there has been no shortage of UFO accidents. The first well-documented case of reckless UFO driving goes back to 1897 when an airborne machine of some kind passed over Aurora, Texas. As if the alien pilot was trying to pass a UFO driving test the situation turned into a humorous tragedy when the craft crashed into a windmill and blew up. At this point one can ask the question, did anyone collect pieces of debris and, if so, were they gathered up by any of the citizens in Aurora? Might there be UFO debris hidden away in basements in Aurora? The mangled remains of the UFO pilot were collected and deemed to not be an inhabitant of planet earth. This story ends with a Christian burial of the alien entity.

Pieces of metal were found but the remains of the shredded alien were not exhumed as the Cemetery Association decided to block any attempt to disturb the alien stranger's eternal rest.

Some of the metallic fragments found their way to a physics professor at North Texas University and were found to be seventy-five percent iron with the distinctly nonferrous qualities of being shiny, soft and non-magnetic. No solid conclusions about the Aurora UFO were reached. Ten years later a more spectacular event occurred on June 30, 1908 in which something exploded over the Tungus region of Siberia. For many years most scientists thought that a meteor or comet was responsible. More up-to-date research has shown that this object changed speed and direction before it exploded with the force of a ten megaton hydrogen bomb and that the explosion was of a nuclear nature. The flattened trees and altered growth rings are testimonials to something far beyond natural capabilities.

In 1924 a farmer in Braxton County, West Virginia looked up and saw a huge wingless object crash in the woods. A sheriff led a group to investigate and stumbled onto a seventy-five foot (estimated) fuselage-

like craft having no wings. Busily engaged around the wreck were a half dozen small dark-skinned entities of oriental appearance. Some were wearing odd shiny coveralls and others were dressed in what we might call business suits of a black color. As the sheriff's group was leaving, one of the men noticed a small metal object on the ground and a Mr. Cole picked it up. That night he was awakened at 3:00AM by one of the entities of oriental appearance, ie an alien who was dressed in a military type uniform. This "alien officer" demanded (telepathically?) the metal object and, when it was given to him, he left without further communication.

Between the somewhat short-lived foo fighters and prior to Kenneth Arnold's sighting in 1947 there was a brief period of time involving UFO activity in Europe during which objects were referred to as ghost rockets. They appeared to be of several odd designs such as green fireballs, spool-shaped objects with trailing flames, and slow-moving metallic-looking cigars. Some of the ghost rockets showed a tendency to blow up or crash. As always, we must wonder how such a high-tech device as a UFO can blow up. It was as if they wanted earthlings to see them self-destruct for some unknown reason.

At this point it might help to keep in mind that flying saucers do not actually "fly." If the crew is intent on going to a certain place, they just go there. Not having wings they are not actually flying. They are simply moving through the atmosphere, or outer space, by applying the force of an unknown propulsion system. On March 9, 1950 a Los Angeles business man told newspapers of seeing the remains of a downed UFO and the body of a twenty-three inch entity at a military installation near Mexico City. The craft was measured at forty-six feet across.

UFO researcher Ray Fowler ran across an ex-naval intelligence man who had been ordered to the crash site of an oval object that crashed in Mexico. He claimed to have seen the craft and its dead entities being loaded onto trucks and was told to keep quiet about it. Years later, Fowler located this witness but was unable to convince him to say anything about it.

It happens that an unusual picture was circulated in a German newspaper sometime in the 1950s. It showed a twenty-eight inch alien corpse that had been in a craft that experienced a rough landing near Mexico City.

Fowler found two more cases of crashed saucers. One of these was in Arizona and occurred on May 21, 1953. An engineer employed by the Atomic Energy Commission in Nevada was flown on special assignment to Phoenix. From there he was accompanied by a group of specialists inside a bus with blacked-out windows to an area possibly near Kingman. On the bus they were briefed by a colonel as to the assignment which was to evaluate different aspects of the crash of a top-secret Air Force vehicle. When the engineer arrived at the crash location he saw a heavily guarded silver object which was a thirty-foot oval shaped like two saucers rim to rim. His job was to calculate the speed and trajectory of the saucer upon impact. The engineer happened to glimpse inside a guarded tent and saw a four-foot dark-brown dead alien entity. It was wearing a silver-colored suit. When finished, the investigators took an oath of secrecy. Later, the engineer was given the position of a consultant with Project Bluebook. This man remained silent for twenty years before confiding his account to UFO researcher, Ray Fowler.

The Mattydale NY event occurred during of the spring of 1954 in the early hours of the morning. The witnesses, a Mr. & Mrs. Marsden, were driving home after visiting friends. As they approached an intersection to make a turn they saw flashing lights on several police cars. They assumed that an accident had occurred. What they then saw was a grounded egg-shaped object about twenty feet wide and fifteen feet high. If their estimate was correct the object, a UFO, would be considered small. In retrospect an object with a twenty-foot diameter would be seven yards across on a football field. The couple could see several men moving around and looking at it, possibly police. Being curious, they called the sheriff's office and were told that what they had seen was a military secret. At least, in this case, it was not said to have been a balloon.

In early 1952 there was a newswire story about a crashed saucer that had been found on the deserted island of Spitzbergen. American, British and Norwegian teams made haste to the crash site. After the story was made known there was a deafening silence concerning the incident. By September of 1945 the crash was all but forgotten. Surprisingly, a representative of the Norwegian General Staff issued a statement about the craft. A colonel stated that the board of inquiry was working on a report concerning the crashed object. He added that the materials comprising the UFO were unknown to those involved in the analysis.

The clincher was the concise comment, "we wish to state emphatically that it was not built by any country on earth." The report was to have been published following discussion of some sensational facts with American and British representatives. But, a report was not released and the episode was never mentioned again.

Ubatuba is a Brazilian city located on the southeast coast in the state of Sao Paulo. A fisherman happened to see a flying saucer explode and he recovered some fragments of the object on a beach. Lab analyses indicated that the fragments were pure magnesium. On October 31, 1958 about a dozen witnesses were surprised to hear a loud roar along with metallic-sounding clangs. A wobbling silver flying saucer was seen over Ubatuba. It appeared to be having some mechanical difficulty and purportedly bounced off a palm tree. Then, heading out over the nearby Peropava River the saucer flipped on edge and dived into a stream making a loud hissing sound. Mud from the bottom of the river billowed up in the area of the sinking saucer. Would-be investigators did not get started on trying to find the saucer for about a week. Divers tried everything to locate the sunken saucer but found no trace of it.

An injured alien turned up after another crash into water. The event occurred in Poland on Feb. 21, 1959 where dock workers watched an object drop into a harbor. Divers found an unruined metal fragment which quickly ended up being analyzed. Results of the analysis were not released to the public. But, what about the alien entity? It was located days later supposedly crawling along the beach. Partially burned and in bad shape, it was taken to a hospital where doctors had a difficult time removing its metallic suit. After removing an arm band the alien died. Its body was sent to Russia. Its blood and organs were very different from ours but no description of the internal makeup of the entity was given.

What follows are seven brief accounts of observed flying saucer crashes. In the late 1940s a witness watched a disk fall into an Idaho lake and snapped a picture which ended up in possession of the Air Force. The photo shows a blur and a huge splash. In 1950 UFO researcher Leonard Stringfield reported that he had details of a crashed disk with small dead entities found in Argentina in 1950. In 1954 newscaster Frank Edwards announced on his radio program that the Air Force was examining a UFO at Muroc Field, later renamed as Edwards Air Force Base. In 1955 something dropped from the

sky in eastern Florida making a huge hole and igniting a fire that lasted forty days. In 1956 Civil Aviation officials confirmed reports of a silver object crashing into Holston Mountain in Tennessee. In 1964 newsmen in Alamogordo, NM started speculation that a flying saucer was housed at Holloman Air Force Base where apparently someone had monitored base communications concerning a UFO discovered at the north end of White Sands Proving Ground. In 1965 a flying saucer passed over Cleveland moving at about one thousand miles per hour, then made a twenty-five degree turn and slammed into a wooded area thirty miles south of Pittsburgh.

There is the hypothesis that, whatever its purpose, perhaps the phenomenon itself occasionally produces saucer crashes and dead aliens. Suppose also that the entities, and even some of the saucers, behave like the sometimes reported "angel-hair" which simply fades away. Suffice it to say, government scientists would probably be hesitant to discuss something like that with the general public.

**The CE4 Corner – Sept./Oct., 2010 –
Notes from the 2010 MUFON conference**

A few notes from the 2010 MUFON conference. This year's conference was great, perhaps one of the best I've seen. During the conference, I felt a strong sense of optimism for many reasons. The biggest was the sense of getting-down-to-business. To me this is the business of learning – trying to understand what is going on in the UFO phenomenon and, in my view, trying to help people come to terms with the unexplained experiences they have encountered.

In past conferences, I have noted a conflict between different approaches to this – the esoteric approach and the scientific approach. The sense I had coming away from this conference is that both are essential – we need every possible approach to understand the UFO and close encounter phenomenon. More on this later...

I flew out a day early to attend the field investigator training workshop and I was not disappointed. MUFON has done a great job of updating their field work procedures. They have significantly updated the field investigator manual over the last few years, and yesterday saw a really good set of training materials on how to do investigation work, how to use the MUFON sighting and investigation database, etc.

What was missing was the thing that I most wanted to see, and that was the concluding discussion on working with UFO abductees. Budd Hopkins, the dean of abduction researchers (at least in my book) was to be the presenter. Unfortunately, Budd's health has not been that great recently, so they replaced his presentation with one by Marc D'antonio on astronomy topics for field investigators, including using satellite trackers, star/sky chart programs, etc.

As in previous MUFON conferences I noted this time is the dichotomy between two threads of thought - one being the focus on abduction, the implications of the UFO phenomenon and related topics, the other on the need for scientific rigor and skeptical inquiry. Much of the FI workshop focused on the latter topic, skeptical inquiry. The first one or two presenters actually (I thought) were a bit too conservative on that topic.

One talk was on differentiating hoaxes, natural phenomena, etc., and did a good job of providing the latest in some of the UFO-like things out there - and there are a lot of them (mostly new RC hovering toys, etc.). Unfortunately, I thought that the first talk missed the distinction between identifying what could be a prosaic explanation for a UFO sighting, and what in fact, a UFO-->IFO actually was. It used the Mexicali UFO sightings of 2008 as an example, and plotted the geometry and the physics of the sighting, a ball of light seen from the town by multiple witnesses.

They interviewed a host of people in the town who had seen the object and developed a pretty solid profile of what had been seen, when and by whom. They then developed a hypothesis that it was actually power line corona seen from some distance away. In my view, the hypothesis was potentially quite sound. However, they never actually established that this was in fact the case - only that it could be the explanation. Thus, I believe that they never actually established the explanation, only a hypothesis for the explanation.

In my view this is one of the big dilemmas of skeptical inquiry. It is quite possible to establish potential prosaic explanations for many sightings (but believe me, not all of them). However, to prove that the particular sighting was actually due to that explanation is nearly impossible to prove. Thus, at least in the more complex cases, the UFO never actually becomes an IFO, merely a potential IFO. Most debunkers seem to ignore this distinction and field investigators (sometimes including myself) have occasionally missed it as well.

UFO research seems to tread the limits of science. It is studying an apparently-intelligent phenomenon and in the process, seeking to separate the wheat from the chaff of sighting reports. As a result, many potential explanations for UFO sightings are found. However the differences between hypothesis and scientific knowledge are vital to note. A hypothesis may be consistent with the data, but it is not yet proven that it is actually

true. And in my view, this is where many of the explanations of sightings stand today.

The other thread of thought is primarily that of abduction research. It is (arguably) much softer science (a loose term in itself), often dealing with social and statistical material. The picture is much fuzzier in social research than in physics, biology, engineering, etc. And often the ambiguity can be downright frustrating. One talk was on several of the recent studies of experiencers - statistics comparing the mental makeup of experiencers with random controls from the general population. The results were fascinating, the best job yet of bring solid numbers to a very fuzzy topic.

The study found that, at least in his sample, experiencers were no more fantasy prone than anyone else. However, they had far higher openness for parapsychological and paranormal events, more universal spiritual views and often had more difficult life histories than the general population.

A lot more work needs to be done on this and it will probably provide a lot of work for statisticians. The data involved needs to be massive in order to develop an accurate profile of the CE4 phenomenon. Just exactly how many experiencers are there? How do they relate to other phenomena such as the Indigo children, paranormal and parapsychological experiences, etc...? The questions are legion and we have only scratched the surface of them. I believe we need to connect the dots. It is probably one of the biggest mysteries humanity faces.

Fortunately, it appears that a new wave of abduction research appears to be taking shape. So in the next few years, I believe some definitive data will begin to emerge on the (para)psychological mechanics of the phenomenon. It is a refreshing burst of new energy in the field and I believe it is long overdue...

Friday was the business day at the annual MUFON conference. It is the day of the state directors' meeting, the board meeting, the members' reception, etc... And this year, I came away from the day with a lot of hope and excitement. MUFON is planning some pretty kewl stuff in the next year-plus.

In addition to the usual business-related topics (which were often pretty interesting in themselves), I learned a bit more about the various research programs that MUFON has in the works. Among

them is a next set of efforts by the abduction research team. I have been nominally affiliated with them already, which hadn't yet amounted to much. But now, in talking with the leader of the group, it sounds like he has more of a "rapid deployment" model in mind in which experiencers contacting MUFON can be put in touch with resources including MDs, psychologists and hypnotherapists, as well as the MUFON field investigation infrastructure.

As part of this rapid-deployment model, we need to have field investigators, physical and mental health professionals and certified hypnotherapists available in as many regions as possible. This is something I've found to be a crying need, having heard from so many experiencers located far and wide. So one little piece of homework for us in the next few months will be to begin putting together the network of hypnotherapists who are available to work with experiencers. I hope to see this mature into a very useful network of workers who can conduct both healing and research with the experiencer phenomenon, connecting them with those who are blessed/cursed with its attention.

On Friday evening, Richard Dolan did a talk on his new book, A.D., After Disclosure. I'm sure I will have a world to say about this later, but in short, his presentation was phenomenal. It was very, very speculative, but in my view it picked up nicely where Michael Lindeman's work left off. I cite Lindeman's work a lot in The Cosmic Bridge, where he talks about the variables of contact. Lindeman is more focused on contact than on disclosure, but Dolan's work combines the two in a number of speculative ways. Like Lindeman, Dolan is a futurist par excellence.

The one thing I think the disclosure community misses: the depths of the close encounter phenomenon. My own hypothesis is that both contact and disclosure will occur at the grass roots level, one experiencer at a time. For better or for worse, I believe that knowledge and acceptance of the visitor presence (whatever that really is - I don't think we understand it much at all) eventually will reach a critical mass, and disclosure will occur at the subconscious/metaconscious level. Only at some critical point will it merge into the daylight of human social consciousness.

Dolan had some interesting things to say about the idea of a "Breakaway Civilization" He suggested that this might be a secret group or invisible empire, having higher technology, visitor contact,

etc., existing in parallel to our open society. I have no idea how this would relate to a bottom-up contact/disclosure scenario. Do the two ideas contradict? I don't think so. But this is a fertile area for work in the future.

Saturday was basically an in-depth revisiting of a lot of familiar topics. It began with Stanton Friedman's revisiting of the SETI, scientific community, and UFO community relationships. I thought this would be more of the same as Stan's talks tend to be rather similar - new material mixed in with old. I was pleasantly surprised in that this talk was entirely new material, very contemporary and very appropriate to many of the discussions we've had over the last several days. He looked at comments recently made by Shostak, Hawking, Davies and other physicists, in the light of the UFO evidence. Unfortunately, I thought he took many of those comments far out of context.

Having met a number of the SETI community, I can vouch for the fact that the SETI community and the UFO community treat each other with considerable contempt. Neither understands the other's viewpoints very well and most statements cited by either are often taken out of context. The best one was Steven Hawking's very speculative comments about how contact would not be too healthy. Hawking had based his speculations on the European/Native-American model in which "contact didn't turn out too well for the Native Americans." Given the previous evening's talk by Richard Dolan, which was just as speculative as Hawking's comments and in some respects seemed to have similar conclusions, I question how badly one can criticize Hawking.

In addition, I have heard people in just about every community make potentially quotable comments in relatively informal settings - sometimes at a party with a beer in hand. The setting is not a formal presentation including references, supporting data, etc., but merely creative minds waxing speculative.

I attended several more talks, all fascinating and all covering different aspects of the UFO phenomenon. By the end of a long day, most of us felt pretty fried. We spent the hour or two winding down, just socializing and joking with each other - a pleasant evening that tells me that the community is quite comfortable with letting its hair down. I spent much of Sunday discussing the abduction research team, spending a lot of money at the vendor tables, and socializing with other members of the UFO

research community. Then it was time to hop the Super shuttle to the airport.

As I indicated above, I came away from the conference with a strong sense of optimism, the feeling that things are getting done. It remains to be seen how well our plans, ideas and intentions translate into reality. But for the moment, I felt certain that we are on the road of progress – following that road wherever it leads.

'Extraterrestrial hypothesis' is now public operative explanation for UFOs in France, U.K. and China

According to one source - http://en.wikipedia.org/wiki/Extraterrestrial_hypothesis, "The extraterrestrial hypothesis (ETH) is the hypothesis that some unidentified flying objects (UFOs) are best explained as being extraterrestrial life or space aliens from other planets occupying physical spacecraft visiting Earth."

In France, on May 31, 2010, The Progress Report of the Sigma/3AF Commission, a semi-official report, adopted the extraterrestrial hypothesis for specific UFO sightings. According to researcher Antonio Huneus "A new French report released on May 31, 2010 concluded that UFOs are definitely real and possibly of extraterrestrial origin. The Progress Report of the Sigma/3AF Commission comes from a highly credible source, the Aeronautical & Astronomical Association of France, known as the 3AF, which established a Commission on Unidentified Aerial Phenomena back in May 2008. The Commission's President is Alain Boudier, a former French Defense attaché, and one of its key members is Jean-Gabriel Greslé, a former fighter pilot who studied at the U.S. Air Force Academy and later became an airliner pilot with Air France, where he experienced a couple of UFO sightings.

Greslé has published three UFO books in France, including Unidentified Flying Objects: An Airline Pilot Talks (Guy Trédaniel, 1993)."

In the U.K. on August 4, 2010, the U.K. Ministry of Defense released World War II documents that confirmed that Prime Minister Winston Churchill had adopted the extraterrestrial hypothesis as the operating hypothesis of the U.K. government with regard to specific UFO sightings. In early August, 2010 the U.K. Ministry of Defense made public "an account of a wartime meeting attended by Winston Churchill in which, it is claimed, the prime minister was so concerned about a reported encounter between a UFO and RAF bombers, that he ordered it be kept secret for at least 50 years to prevent 'mass panic'.

"Nick Pope, who used to investigate UFO sightings for the MoD, said: "The interesting thing is that most of the UFO files from that period have been destroyed.

"But what happened is that a scientist whose grandfather was one of his [Churchill's] bodyguards, said look, Churchill and Eisenhower got together to cover up this phenomenal UFO sighting, that was witnessed by an RAF crew on their way back from a bombing raid.

"The reason apparently was because Churchill believed it would cause mass panic and it would shatter people's religious views."

On August 23, 2010 in China, a planetary astronomer formally announced the extraterrestrial hypothesis as applicable to specific UFO encounters he had studied in notable sightings at the Purple Hills Observatory of the Chinese Academy of Sciences.

Dr. Michael E. Salla notes, "In a speech at a science forum held in the city of Guangzhou on August 23, a veteran Chinese astronomer with almost 40 years experience claimed that some UFOs are extraterrestrial spacecraft. Professor Wang Sichao is a planetary astronomer at the Purple Hills Observatory of the Chinese Academy of Sciences. Based on scientific observations of UFOs over his 39-year career, he has concluded that some are powered by antigravity devices.

"He claimed some extraterrestrials are visiting Earth in a Research and Development capacity, and are therefore friendly enough to begin cooperation and mutual exchanges. A summary of Wang's

speech was reported by a number of China newspapers including the influential People's Daily Online.

“Based on his observations at Purple Hills Observatory and analysis of UFO sightings, Wang was able to conclude that some UFOs are not natural phenomenon, and use antigravity technology. This is how the People's Daily Online summarized Wang's reasoning: ‘Wang also found that in the terrestrial space between the height of 130 kilometers and 1,500 kilometers, UFOs have appeared many times. Their flying speed is ... as slow as 0.29 kilometers per second [1000 km/hr] and they can fly in the 1,460 kilometers' height for more than 25 minutes. This means UFOs have the anti-gravity ability. Otherwise, they would fall soon.’”

One of the main characteristics of America's so-called Neo-Conservative movement (although it seems to have lost its momentum these days) with the backing of Fundamentalist, Evangelical Christians, is their total support of Israel through the belief that contemporary Israel is the fulfillment of Biblical prophecies and that the U.S. must continue to support the State of Israel, no matter what.

A large number of these American Fundamentalist, Evangelical Christians, therefore, believe that we are living the "end-time" period of God's prophetic calendar.

It is of utmost importance to point out some of the "end-time" scenarios as believed by the supporters of this view.

Here is the typical order of the prophetic events to come, as outlined by many of those Christians who seem to hold on to the so-called Pre-millennial, Dispensationalist, Pre-Tribulation viewpoints.

1) THE EZEKIEL SCENARIO

They seem to believe that this could easily begin with the escalation of the Middle East conflict, involving Israel. They seem to believe that Iran and Syria will play a major initial role in this scenario.

They say that the Ezekiel 38 scenario includes the attempted invasion into Israel by all Islamic forces (led and orchestrated by the northern-most power, i.e., Russia) and will conclude with a miraculous Israeli victory.

They believe that it is suggested in the Bible that it will take 7 years to bury the dead from this unprecedented conflagration. (The U.S. will be involved, directly or indirectly in this conflagration, they explain).

2) THE APPEARANCE OF THE ANTI-CHRIST

According to their belief, the Ezekiel 38 scenario will conclude with the mysterious appearance of the Anti-Christ who will create a Peace Treaty between Israel and the Palestinians (and all Islamic confederation).

3) THE RAPTURE

They say that the Ezekiel 38 scenario could also conclude with a simultaneous, mysterious disappearance of millions of people from this earth, which will result in total chaos, confusion and fear among the global populace. This, they say, is the "Rapture". It will be a mysterious, mass "evacuation" of the believers to meet the Lord in "mid-air". (The physical bodies will be mysteriously and instantaneously converted to celestial bodies).

In other words, the so-called "born-again" believers will be translated from one side to the other, i.e., from the earthly plane to the heavenly dimension and will meet Jesus in "mid-air".

They say that the "Rapture" (from Latin "raptare", to "snatch" away, as in the eagle "snatching" away her baby when danger comes and taking it away to a safer location, etc.), is a supernatural event clearly suggested in the Bible that has not happened yet in the history of mankind, but will be certain to happen, according to most of these pre-tribulationist, dispensationalist believers.

It will be an inexplicable, instantaneous disintegration of all atomic particles of each of our cells of our tissues, i.e., the instant conversion of our physical body into a spiritual, celestial "body" which will be swooshed up into "mid-air".

In other words, they believe that "in the twinkling of an eye", our physical bodies will go through a mysterious, sudden transmogrification (a favorite word used by John Keel) and will be lifted up to meet the Lord in "mid-air". Our entire physical bodies (the tissues, the cells will go through a sudden, inexplicable atomic fission-type transformation, they say.)

They believe that the "Rapture" is a conduit prepared by God for us to escape the coming global wrath known as the Tribulation (comparable to the days of Noah, when God safely place a few faithful believers in the ark first and then caused the rain to pour down thereafter).

Pre-tribulationist, dispensationalists believe that this unprecedented event will take place simultaneously with the appearance (the revealing) of the Anti-Christ.

The Anti-Christ, according to these believers, will not be able to come to power until the "body of believers" (together with the presence of the Holy Spirit) is removed from this earth. Only then, at that moment, can the Anti-Christ come into power.

According to these Christians, the "Rapture" will literally be a celestial wedding, the union of the bride (the "church" or "the body of believers") and the Groom (Jesus Christ).

This "wedding" celebration in the air will last for 7 days, which could be equivalent to 7 earthly years.

4) THE ANTI-CHRIST SUCCEEDS IN CALMING DOWN THE STUNNED, CONFUSED AND PANIC-STRICKEN POPULACE

When the Anti-Christ appears on global emergency TV news conference, many of these Fundamentalist Christians say that he would calm down the frightened people of the earth with his ingenious, well-calculated explanation regarding the sudden disappearance of millions of people from the earth; this could be when "UFOs" are brought up; the Anti-Christ could use some type of "extraterrestrial" intervention explanation.

(By the way, in the U.S., the majority of the so-called Fundamentalist, Evangelical Christians hold on to the viewpoint that somehow the "UFO" phenomenon is "Satanic" or "diabolical". These groups seem to believe that "UFOs" will play a major role in these future biblical prophecies.

Some theorists even believe that if a global government of some sort is to be set up intentionally (by force) in the future, there are several ways to accomplish it. Creating wars is one example, they say.

Creating other series of "crises" is another, such as manipulating natural global catastrophes, or even creating artificial ones. Some researchers call this the "ORDO AB CHAOS" theory.

They also point out that Henry Kissinger at one time suggested that should the world suddenly face an external threat (i.e., from "outer space") whether REAL or PROMULGATED, it would accelerate a cry for a global unified government. peaceful, and the second half of which will be an iron-fisted rule of the Anti-Christ, who will declare himself to be God at mid-point).

6) THE BATTLE OF ARMAGEDDON:

Towards the end of the 7th year, nations such as Red China (and the rest of the "Kings of the East") will challenge the dictatorship of Anti-Christ's Europe-based New World Order and will begin to cross the Euphrates and make a move towards the valley of Megiddo.

9) THE FINAL JUDGMENT

This is the gist of the events to occur in the near future, according to many of the so-called Fundamentalist, Dispensationalist, Evangelical, Pre-Millennial, Pre-Tribulationist Christians. Is this all wild, "science fiction"? Maybe. But again, no one knows. Does it hurt to believe in this "unbelievable" scenario? These Evangelical Christians seem to say that it won't hurt at all to believe that such scenarios could come true. They say that they have nothing to lose by believing in it even if it doesn't come true, but everything to gain if it indeed takes place, if one is a believer.

**Lt. Col. Wendelle C. Stevens Best Known
UFO Researcher Has Died
Filer's Files #37-2010

UFO research pioneer, Wendelle Stevens (87) passed away on September 7, 2010, at his home in Tucson, Arizona of respiratory failure.

Lt. Colonel (USAF Ret.) Wendelle C. Stevens was born in 1923 in Round Prairie, Minnesota and joined the US Army in 1941. He transferred to the Air Corps in 1942 and became a pilot. He alternated his career between pilot and Air Technical Service assignments with the Air Technical Intelligence Center (ATIC) at Wright Field. ATIC is where the Blue Book Office for the study of UFOs was located. In 1947, he was assigned to Alaska where data collecting equipment onboard B-29s were detecting UFOs. He became interested in the subject and started his collection of UFO photographs. Col. Stevens amassed one of the largest collections of UFO photographs in the world. He had given me permission to use some in my files and at the Air Victory Museum. He served as US Air Attach in South America and retired from the USAF in 1963. He spent much of his adult life actively investigating UFO cases despite harassment by the government. In December 1997, he received an award for lifetime achievement at the First World UFO Forum in Brazilia, the capital of Brazil.

Wendelle Stevens was the Director of Investigations for the Aerial Phenomena Research Organization (APRO) in Tucson, Arizona. He investigated numerous contact cases, such as the Billy Meier case in Switzerland. He published more than 22 books concerning UFOs, and was a founder and Director of the International UFO Congress. He recently transferred his extensive photo collection, and library to Open Minds Production. Wendelle was a great man, and I personally will miss his great smile and in depth knowledge of UFOs.

**An invisible rip in the fabric

De Void tends to ignore personality-spattered UFO food fights because a) they're boring, like real life and b) nobody outside the small circles of what the MSM describes as "believers" gives a damn anyway. But lately, the longest-running private UFO

research group in the country is having a PR problem that's getting a little too loud to ignore — and its new leader is using the C word.

"I'm not trying to be conspiracy minded," says Clifford Clift, the international director for the Mutual UFO Network. "But there always seems to be somebody out there, when we start going in the right direction, who starts putting us through detours."

OK, wait. MUFON's been around since 1969, no mean feat considering how it relies on an all-volunteer staff to conduct its thankless mission of sifting through UFO reports, most of which turn out to be rubbish. Yet, despite its limitations, the 501(c)3 manages to do pretty good work, and its "UFO Stalker" sightings map continues to update its cool interactive database in real time. <http://www.ufostalker.com/?mufon=true>

So maybe a better story here should be how infrequently management-level ego eruptions actually spill into the public domain, given the inherent lack of recognition or material perks in this wretched field. And especially given the number of paranoid, delusional and grandiose wack jobs who routinely inject themselves into diligent UFO investigations.

But that's exactly what happened at a MUFON meeting on May 2, when Ken Cherry, the Texas MUFON director, went sideways and tore into everyone from witnesses to the national leadership. Evidently, two years of frustration emanating from the 1/8/08 Stephenville incident — the most well-documented UFO event of the modern era — blew like a BP wellhead.

No one escaped Cherry's spray, which showered "outsiders" who had the audacity to enter his fiefdom without personal invitations. Cherry said one investigator was so stupid he "didn't know how to use a computer"; another "one of these so-called experts" came with "multiple degrees and a smart ass." He accused then-international director James Carrion of doing "a lot to discredit MUFON" with a pattern of "incompetence" suggesting "evidence of a conspiracy."

After charging MUFON with conducting "an unwarranted and unauthorized investigation behind our backs" and for "discrediting witnesses," the dude went on to repeat the offense himself. Singling out one eyewitness by name for his "psychological problems," Cherry chided other

“nutcase” greedheads for peddling bogus UFO footage in 2008 to the media. Then he pitched his own DVDs and videos, recorded from an earlier lecture in San Jose, for only \$10.

If only he'd stopped there. But then, the guy blasted MUFON's exhaustively detailed radar analysis of the Stephenville phenomenon — a study in which Cherry had no role — for having “so many holes and errors in it as to cast doubt upon the analysts and MUFON.”

And that's what also yanks Clift's bobber, the fact that someone not only recorded this Lone Star malcontent, but hung the sheets out on the line. “There's someone who's putting this information out there, but we don't know who he is,” says Clift. “The perception they're trying to create is that we are not competent, which we are.”

That's probably still true. Clift says Cherry violated several of MUFON's conduct codes, such as naming and ridiculing witnesses (“We say some are not credible,” asserts Clift, “and that's all that needs to be said”), and that new chain-of-command rules have been enacted since the Stephenville incident. He also hints that MUFON's board of directors is on the verge of taking additional corrective measures. “If I were to disparage MUFON, I would expect to be gone,” he adds.

For those who monitor MUFON storylines, the Ken Cherry flameout follows the contentious departure earlier this year of Clift's predecessor, James Carrion, who'd run the group since 2006. No reason to rehash all that here. It's involved.

Here's the bottom line: When it comes to investigating UFOs — publicly, at least — MUFON is the only game in town. And Clifford Clift is amazed at the media response to this rip in the fabric. “You're the only one to contact me about it,” he says. For once, that's probably good news.

China discloses UFO reality: Aliens sending UFO probes here

Aliens Have Been Trying To Contact Us By Cosmic Twitter Scientists Claim The Telegraph - UK, 22 Jul 2010

ET is more likely to be sending out short, directed messages than continuous signals beamed in all directions, experts said. "This approach is more like Twitter and less like War and Peace," said Californian physicist Dr James Benford, president of Microwave Sciences Inc.

He and twin brother Gregory, an astrophysicist at the University of California, Irvine, looked at the Search for Extraterrestrial Intelligence (Seti) from the aliens' point of view. They concluded that Seti scientists may have been taking the wrong approach for the past five decades.

Up to now scientists have listened out for unusual blips or bleeps from targeted nearby stars. Despite 50 years of searching, no-one has yet been able to come up with evidence of an extraterrestrial signal. However, many scientists are convinced we are not alone in the universe.

"Whatever the life form, evolution selects for economy of resources," said Gregory Benford. "Broadcasting is expensive, and transmitting signals across light years would require considerable resources."

Writing in the journal *Astrobiology*, the Benfords claim that an alien civilization would strive to reduce costs, limit waste and make its signaling technology efficient.

They propose that alien signals would be pulsed and narrowly directed in the one to 10 gigahertz broadband signal range. Seti has been focusing its receivers on the wrong kind of signals, and also looking in the wrong direction, they claimed.

Rather than pointing their antennae at nearby stars, scientists should be aiming at the centre of our galaxy, the Milky Way.

"The stars there are a billion years older than our Sun, which suggests a greater possibility of contact with an advanced civilization than does pointing Seti receivers outward to the newer and less crowded edge of our galaxy," said Gregory Benford.

"Will searching for distant messages work? Is there intelligent life out there? The Seti effort is worth

continuing, but our common-sense beacons approach seems more likely to answer those questions."

MEP Calls for Declassification of UFO Files From European Parliament By Kremena Krumova, Epoch Times Staff, July 12, 2010

Italian European Member of the Parliament Mario Borghezio proposed resolution before the European Parliament asking for the declassification of UFO files in all 27 European Union member states.

A proposed resolution before the European Parliament calls for the declassification of UFO files in all 27 European Union member states.

Italian European Member of the Parliament Mario Borghezio sponsored the draft resolution that, if passed, would require EU governments to declassify their secret files on UFOs.

The declaration also calls for a research center to investigate alien life.

So far, 31 MEPs have come out in support of Borghezio's initiative, submitted on June 14.

In the proposed resolution, Borghezio said, "Many members of the scientific community have been looking into the issue of UFOs and have denounced the systematic covering up of information on the subject."

He pointed out that the 33rd General Assembly of the United Nations had officially recognized the existence of UFOs in 1978.

Borghezio will need to secure over half of the 736 MEP votes for the declaration to become an official resolution.

This is not the first time the topic of UFOs has come up in the European Parliament.

After a great number of UFO observations were reported in Belgium in 1990, Belgian MEP Elio Di Rupo, suggested that the EU establish a European UFO Observation Center.

Italian MEP and physicist Tullio Regge, drafted a resolution in 1993, seeking to extend the French national space agency's Rare Aerospace Phenomena Study Department (SERPA, now called GEIPAN) to

the European level. France was then the only government body looking into UFOs.

Regge proposed investigations into various possible explanations for UFOs, including military secrets, foreign civilizations, and super technologies.

Last year, Great Britain partially opened its classified files, publishing 4,000 pages of 800 alleged encounters with extraterrestrials during the 1980s and 1990s.

Prepare for Disclosure. Prepare for War. Jun 1 2010

I hosted a roundtable this past April that consisted of four of some of the most recognizable personalities in UFO research. For the second time I had the pleasure of speaking with disclosure activist Stephen Bassett. More often than not, my thoughts on disclosure have been somewhat polarized. I believe whole-heartedly in letting the public decide for themselves what they should believe and how they should interpret the beliefs of others. It is this free will that defines our desire to be individuals and is part of the essence of being human. I agree that “national security” has been more of a security blanket used as a catch-all for anything that falls outside of the realm of definable and controllable phenomena. So do I agree with the idea that disclosure is needed? Yes, and I also agree that it is our right as Americans and citizens of the world to demand it. Do I think the world is ready for it? No. No, I do not, and this is where I will diverge from the research of many of my peers in saying that I have enormous faith in humanity, yet no faith in humanity’s ability to organize and implement governing systems, and this is where we constantly fall apart.

Disclosure represents many things, but at its core it is about the dissemination of truth. Truth is the seminal double-edged sword. The sigh of relief that accompanies truth is wrought with barbs that often tear, mangle and incapacitate in its release. With disclosure comes truth and I think the brand of truth that many UFOlogists seek often strips the emotion from the experience and looks at validation and confirmation, but not necessarily closure, and I’m talking about the kind of closure that comes from finally coming to terms with trauma. Trauma is a rarely used word in UFO culture. We are all prone to throw around terms like “advanced propulsion” and “aerial maneuvers” but

trauma is a bird of a different feather. If I were inclined to use trauma in reference to the UFO phenomena, and more importantly the ET “problem” I might say. “the way in which the subject was taken from their home, subjected to multiple tests that were both intrusive physically and of a sexual nature left the victim in a state of shock that led to long term psychiatric issues stemming from the initial trauma”. I think that could be an accurate way to use the word effectively. It might also be the same phrasing used in a police report to describe an assault, a rape, or a kidnapping. It is, however, a phrase you would also expect to hear in an account of an alien abduction, and it is the abduction phenomena that raises not only some serious questions for me about disclosure, but some very serious concerns as well.

How do you try another planet for their crimes? The legal issues alone surrounding disclosure are near insurmountable. Are we expected to wipe the slate clean once the smoke of cloak and dagger has dissipated? What about the victims of abductions that have lost their family, friends, jobs and their credibility over what they have experienced? Is it going to be easy for them to see a race absolved of guilt, while they are expected to still seek closure on their own as victims unavenged? Will there be any recompense for the lost time, the lost dollars on therapy, the lost sanity of the “experiencers” once the veil of conspiracy has lifted. Further more, who does take responsibility?

It is responsibility that possibly troubles me the most. How will the world’s governments look in the eyes of their people, regardless of how they try to spin it? What will their angle be or, more importantly, is there one that at all? To admit that they were unaware of the phenomena to a point or even unable to adequately control it points toward negligence worthy of a global outcry. If they admit involvement, they become the very enemies of the people they were sworn to protect. If the problem is so far out of their control they are admitting that their protection is, at best, a smokescreen; another lie to placate a public whose interests they haven’t fully served.

Let’s take the former and the implications that the situation is unable to be controlled by our world’s governments. If this is the case, we need to look not only at the criminal activities of the guilty party (Plaedians, greys, Taliban, etc) but the crimes against humanity that they are also responsible for:

1. Violation of Restricted Air Space – If disclosure reveals that craft have been coming and going at their leisure, that means our national security has been violated innumerable times.

2. Abduction, Restraint and Torture of Private Citizens – The abduction phenomena, complex and sometimes terrifying in all of its David Lynch-like facets, represents an intrusion and torture on a level reminiscent of waterboarding.

3. Animal Cruelty and Terrorism - Cattle mutilations represent a level of detached indifference that startles and horrifies those who witness the end result. The tendency to leave the carcass could be seen as psychological intimidation as well (think this is a reach? If they really wanted to be discrete, I'm sure they could find a better disposal method rather than just throwing it out their car window into the ditch)

So what does all of this mean? What it means to me is that a party or parties hitherto unidentified have been committing acts of tyranny, violence and psychological intimidation worthy of a declaration of war. Once the parties responsible have been identified (in this case through disclosure) how are we to deal with them in a manner that holds them responsible for what they have done? How would we be able to combat their technologies to even hold them accountable?

I am still an advocate of disclosure, however. The truth, no matter how painful or difficult is still the truth. I think it is just going to be a bittersweet truth that could very possibly blow forth the winds of war.

New French Aerospace Report Endorses Reality Of UFOs by Alejandro Rojas

A new French report released on May 31, 2010 concluded that UFOs are definitely real and possibly of extraterrestrial origin. While not an official government study, the Progress Report of the Sigma/3AF Commission comes from a highly credible source, the Aeronautical & Astronomical Association of France, known as the 3AF, which established a Commission on Unidentified Aerial Phenomena back in May 2008. The Commission's President is Alain Boudier, a former French Defense attaché, and one of its key members is Jean-Gabriel Greslé, a former fighter pilot who studied at the U.S. Air Force Academy and later

became an airliner pilot with Air France, where he experienced a couple of UFO sightings. Greslé has published three UFO books in France, including Unidentified Flying Objects: An Airline Pilot Talks (Guy Trdnaniel, 1993).

The Sigma/3AF is not a final report but just a work in progress document; nevertheless, it provides good background material on the history of official UFO research in France, a balance of Sigma's work during the last two years, a brief description of the most significant French cases, and some comments and conclusions. The report begins with a brief history of French official UFO research, which is quite extensive: "France is the only country where the collection of Unidentified Aerospace Phenomena (PAN in French) and its scientific study have been assigned since 1977 to a civilian official organization, the CNES (National Center for Space Studies, the French space agency) through the GEPAN study group." After a short description of this unit, now known as GEIPAN (Study and Information Group on Aerospace Unidentified Phenomena), the report outlines other official or quasi-official French studies, including the famous COMETA (Committee for In-Depth Studies) Report of 1999, issued by a group of high-ranking retired French military and intelligence officers, which concluded that UFOs were real and probably extraterrestrial.

July 4, 2010, 22:40 p.m.

My husband and I were watching fireworks from our deck when I noticed a large red light migrating horizontally across the sky. He agreed that this was a strange red light indeed. We live below a flight path of the airport so we often see incoming planes in the distance, but usually the planes we see have many red and white lights that are constantly flashing. This object had one big red glowing light (perhaps a distant orb but all we could see was a bright red light). We talked about the possibility of a satellite, but it was so red, and seemed much closer.

It moved slowly across the sky. There were occasional fireworks coming from either side of the sighting, but the object was in a clearing between the two houses launching the fireworks. The light moved too slowly, too horizontally, and too straight to be a stray firework.

After a minute or two of watching it move across the sky, I ran into the house to get my glasses. The light was moving slow enough that I figured I would have time to get my glasses before the view of the light would be blocked by the trees. To my surprise, the red light had stopped completely in its tracks. My husband and I continued to stare at the red light, as it seemed to hover in one spot. It was completely still. We discussed the possibility of a distant helicopter, but it was silent and completely unwavering. We probably watched it for 2-3 minutes before the light got smaller and dimmer and suddenly disappeared. It did not seem to MOVE away. It seemed like it just faded into nothingness.

Pyramidal-shaped Craft Over Lakeville North High School Field

Our family attended the Fourth of July fireworks show in Lakeville, Minnesota this evening. My entire family and several other people sitting around us witnessed a light brown flying object with a glowing golden ball in the center.

This thing was not an airplane or firework debris, as it slowly flew across the length of the entire sky over our heads in a curved line at the same altitude. It flew from a west direction towards the east, but then curved northward, again at what appeared to be the same altitude throughout.

The top of this thing spun around, and one side of it was black with something that protruded from it (you could see this black side with the protruding thing spinning slowly as it flew across the sky.) It had no smoke, no sound, and this protruding thing swung around the top of it only randomly and very slowly while the bottom of it did not spin. The best way I could describe the protruding black thing was that it looked like a large telescope with a dark shiny window in the center of it. I say it was shiny window because you could see light reflecting off of the center of it, but the rest of the telescope thing itself didn't reflect light.

The entire object was pyramid shaped, but the top of it spun around slowly while the bottom of it seemed to remain stationery. A glowing orange ball was right in the center of the bottom of it.

There were at least twenty five other people around us who looked up with us and watched this thing as it slowly flew by. I have never seen a ufo before, but I have never seen anything like this thing that we saw tonight.

It happened at around 9pm at Lakeville North High School, about an hour before the fireworks began.

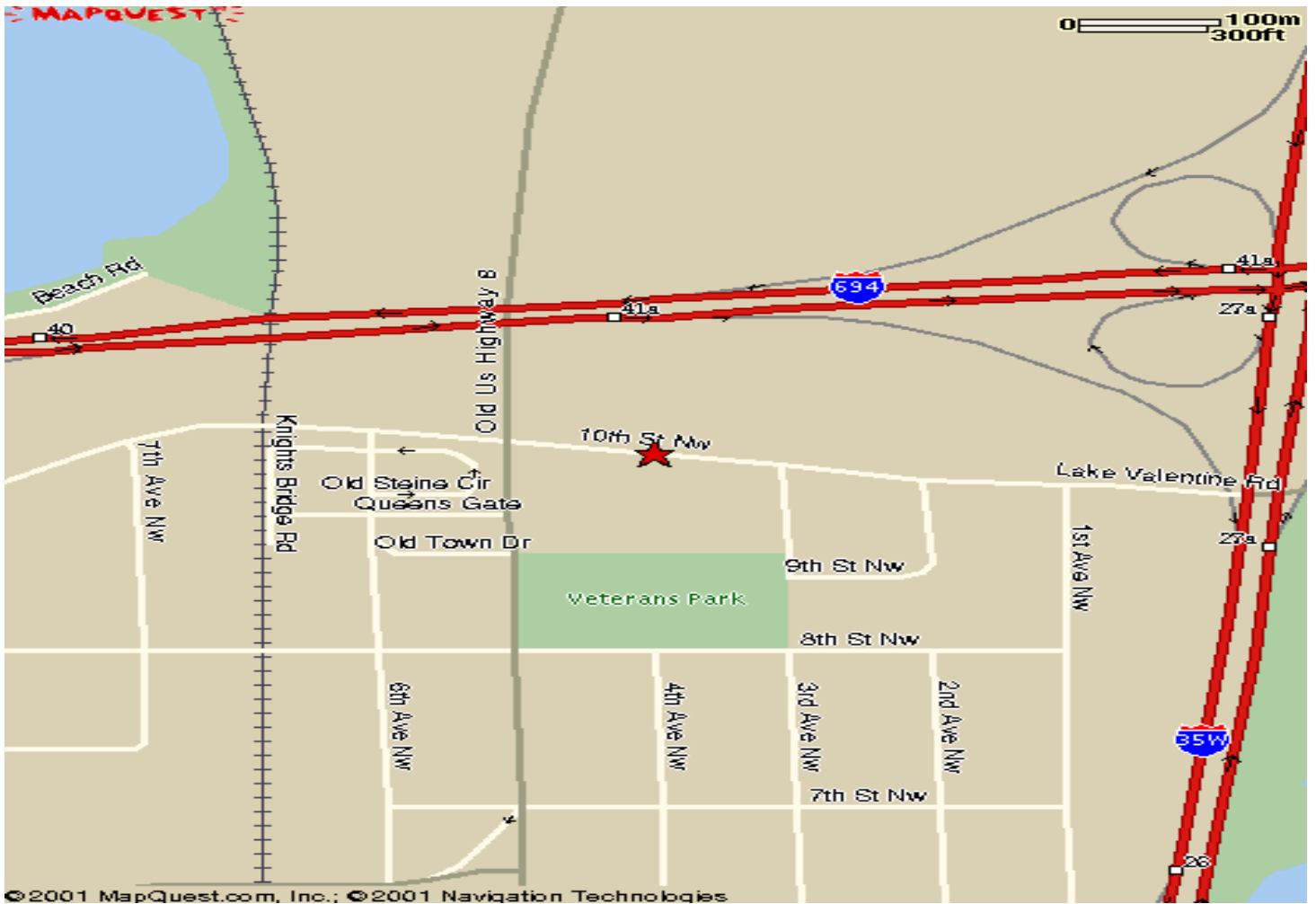
