Dr. J. Allen Hynek

For many years Dr. Josef Allen Hynek was the foremost authority on the subject of UFOs. The Air Force had been looking for a person who would be willing to be their consultant and perhaps explain some cases that the Air Force felt would be beneficial to both the Air Force and the general public. The Air Force's project would be located at Wright-Patterson Air Force Base in Dayton, Ohio. It happened that Dr. Hynek was director of Ohio State University's McMillan Observatory which made him the closest astronomer available. As the years passed he became less enthusiastic about the unscientific attitude of the military's UFO project and more inspired with the hundreds of documented accounts submitted by witnesses. Hynek recognized that the UFO problem was much more complex than first imagined.

Both Jacques Vallee and Dr. Hynek felt that it is simple-mindedness to assume that UFOs are nuts-and-bolts hardware from outer space. Whatever UFOs are, they obviously suggest an intelligence that is in control of the craft. Both Vallee and Hynek maintained that the phenomenon is real and any attempt to simply dismiss the existence of UFOs is nonsense.

Hynek pointed out that the Center for UFO Studies (CUFOS) is comprised of scientists who are established in their own fields. Anthropologists, sociologists, psychologists and psychiatrists were available to Hynek. The UFO problem belonged to several scientific disciplines.

As director for CUFOS, Hynek took the position that they would first explore physical aspects of the phenomenon. He regarded UFOs as strange but physical and he would be forced into the psychic aspects only if observations and evidence forced him to do so.

Hynek and his associates recognized that the problem with UFOs was definitely more complex than first imagined. Both Hynek and Vallee felt that the naive approach would be to promote the idea that UFOs are nuts and bolts hardware from outer space. Any culture would most likely interpret a new phenomenon in terms of their own technology.

Hynek felt that there is a psychic aspect to UFOs but, whatever it is, it represents some sort of intelligence. Hynek and Vallee agreed that the problem was a real one and any attempt to dismiss it as nonsense is itself nonsense.

Hynek told the story of a fellow who had been one of the prominent newscasters in New York for twenty-five years and was as hard-headed as newsmen can become. He had a UFO experience on his way home one day and was totally set on interpreting things rationally.

ET COUNCIL TO INTERVENE, FULHAM SAYS

In an exclusive, in-depth interview on Exopolitics Radio with Alfred Lambremont Webre, former NORAD officer Stanley A. Fulham has stated that a regional galactic governance authority, (the 'Council of 8') made a dramatic decision in January, 2010 to put aside the law of non-intervention.

At a solemn meeting, the Council of 8 decided to intervene with their technology to clean Earth's atmosphere before an environmental collapse occurs on Earth, as has happened on many other inhabited planets with civilizations similar to our own.

The Council of 8 did so, according to Mr. Fulham's information, after reaching a conclusion that that our human technology could not now prevent an environmental collapse and species extinction on Earth from occurring.

According to Mr. Fulham, this is a rare decision by the Council of 8, and is partly a result of Council members wishing to preserve the unique positive qualities of our human population.

Mr. Fulham stated in his Exopolitics Radio interview that the regional galactic governance council ('Council of 8') had chosen New York City for an initial Oct 13, 2010 UFO 'decloaking' because it was a global, cosmopolitan city with a blasé population that would not be frightened of their appearance.

There are multiple, independent evidentiary sources that prove the Oct. 13, 2010 UFO sightings over New York City were the result of an intervention by a non-Earthly intelligent civilization, and not the result of other causes such as released balloons.

The original plan of the Council of 8, taken at a meeting in January 2010, had been for simultaneous UFO appearances on Oct 13, 2010 over major world cities.

Commentary: Here is, seemingly, a prediction of ET intervention that can be tested by whether events occur as stated. However, you will notice

several qualifications that leave this prediction “iffy” [Boldface emphasis mine]:

“...Council of 8’s appearance in 2014 ... **may occur...**”

“...**may be accompanied** by possible earth changes, monetary collapse, and governmental and nation state collapse...”

“...increased UFO sightings in the future **are meant** to lead up to a world speech...”

To my knowledge, no one has made a definitive analysis of the New York sightings to determine if they are truly unidentified. The previous prediction “passed along” by Fulham of massive sightings over many large cities did not, apparently happen.

However, some scientists have stated that if the addition of heat-retaining gasses to our atmosphere was not stopped by 2010, that global warming would be on an irreversible course. This, of course, has not happened. Studies indicate the intensity of hurricanes is increasing, although not the yearly number. In the Midwest and eastern US we just experienced something called a “land hurricane”, with winds to 85 mph and record barometric lows. It is my impression that flooding may have increased world-wide, although I have seen no studies of this. Here in Minnesota the “frost-free date” in the spring has moved earlier by about three and a half weeks, according to local meteorologists.

Bad weather has led to collapse of governments in the past, according to some historical studies. Let us hope the predictions of catastrophe are mistaken and that intelligent policies will lead to stabilization of governments. There is an old saying, “Politics ends at the water’s edge!” We would be wise to heed this. After the signing of the Declaration of Independence, Ben Franklin said, “Gentlemen, we must hang together, or we most assuredly will hang separately!”

If the worst happens, the best we can hope for is either ET intervention, or measures invented by earthly scientists to reverse global climate change.

Aliens 'tried to warn US and Russia they were playing with fire during Cold War'

Aliens may have interfered with US and Soviet nuclear weapons during the Cold War in an attempt to send “a sign to Washington and Moscow that we are playing with fire”, according to a UFO researcher.

Robert Hastings, a long-time UFO researcher, who collated the information, said at a press conference in Washington that “this planet is being visited by beings from another world who for whatever reason have taken an interest in the nuclear arms race”.

He claimed to have gathered witness testimony from more than 120 military personnel showing infiltration of nuclear sites. Six retired officers and one former NCO spoke of their personal experiences.

In some cases, nuclear missiles supposedly malfunctioned while a disc-shaped object hovered nearby. Although the officers produced fresh affidavits detailing their experiences, the incidents, many of them the 1960s, had previously been publicized by UFO enthusiasts. Some of them were first disclosed decades ago.

Mr Hastings stated that beings from UFOs had also tinkered with Soviet nuclear weapons and speculated that the aliens had been seeking to send “a sign to Washington and Moscow that we are playing with fire”.

Captain Robert Salas, a former US Air Force Inter-continental Ballistic Missile Launch officer, said he was on duty during one missile disruption incident at Malmstrom Air Force Base in Montana in 1967 when a “large glowing, pulsating red oval shaped object” hovered over the front gate.

He then noticed that the Minuteman missiles he was overseeing had shut down. “The indicators for all or nearly all 10 missiles showed as red-coloured ‘fault’ lights, which meant that the missiles were disabled and could not be launched.”

He said he was ordered not to discuss the matter but was never given an explanation by his superior officers.

In another case in Britain, Colonel Charles Halt said that in 1980 he watched a UFO directing beams of light down into the RAF Bentwaters airbase near Ipswich.

His security team “observed a light that looked like a large eye, red in colour, moving through the trees”. After a few minutes “this object began dripping something that looked like molten metal. A short while later it broke into several smaller, white-coloured objects which flew away in all directions.”

Sceptics pointed out that there was a lighthouse nearby but Col Halt maintains that the objects were “extraterrestrial in origin” and that “the security services of both the US and the UK have attempted – both then and now – to subvert the significance” of what happened near Ipswich.

UNITED NATIONS — There is no United Nations special envoy for space aliens, let’s get that straight from the outset, nor even an official designated to pick up the phone should one call.

It is true, however, that a United Nations Office for Outer Space Affairs sits in Vienna. (No, it has nothing to do with amorous astronauts, either.) <http://www.oosa.unvienna.org/> Its task consists basically of monitoring or refereeing cosmic matters — space debris, for example, or maintaining a list of about 3,000 objects sent hurtling into orbit in the past roughly 50 years.

Until this week, one could argue that with the exception of the scientific community, the office was more obscure than outer space itself. But it has been thrust into the limelight by a scientific conference in Britain whose panels included space-related topics like “Calling ET, or Not Even Answering the Phone?” and “Extraterrestrial Life and Arising Political Issues for the U.N. Agenda.”

The idea, basically, is that one day, maybe one day soon, some manner of life or maybe a signal will materialize from another galaxy far, far away. How should earthlings react? Might, for example, the

United Nations be designated the spokesman for the entire planet if Darth Vader comes to call. The conference organizers totally dismissed that latter possibility.

“It is not the little green man in the flying saucer — that is the wrong image,” said an organizer, Martin Dominik, a physicist at the University of St. Andrews. What is meant, he explained, were microbes, or perhaps an electronic signal.

“There could be interaction between life on our planet and life elsewhere so how do we deal with that,” Mr. Dominik said, warming to the topic. What if the microbes are harmful, for example, or the signal hostile?

“The question is should we send messages into outer space or not?” Mr. Dominik added. “Is this dangerous? Should we make ourselves visible to extraterrestrial life or not? If they know we are here, do they want to destroy us, will they help us, do we gain something from that? These are all open questions.”

The issue becomes more pressing as knowledge of other planetary systems expands and radio telescopes can beam ever more powerful signals into the void. The United Nations could play a valuable role, Mr. Dominik and others noted, in preventing a single nation, or perhaps, the American military from hogging the dance card of the first alien, even if it is a microbe.

Not that the United Nations will take a position, exactly. The secretary general, Ban Ki-moon, refused to comment.

“There is no United Nations position on extraterrestrial life,” said Mazlan Othman, the Malaysian astrophysicist who runs the Office for Outer Space Affairs. (“I am not the ambassador to aliens!” she said.)

There is also a certain recognition that since the 192 United Nations members are generally incapable of reaching agreement on pressing earthly matters like climate change, negotiating a protocol for alien encounters will be one long slog.

The discussion on coping with a threatening asteroid collision has already been grinding on in a subcommittee since 1999, Ms. Othman noted. “To get consensus on anything at all is difficult at the United Nations — water, peacekeeping, it is not just extraterrestrials,” she said.

**The CE4 Corner – Hypnotic Thinking:
UFO abduction and the limits of memory**

Last week, I spent a couple of enjoyable hours as the guest on Joe Montaldo's radio [October 7, 2010](#) radio show, [UFO Undercover](#). On the show, we discussed a number of topics related to the UFO abduction mystery, including one which challenged my discernment filter in a big way. Joe makes the argument that the Barney and Betty Hill abduction of September, 1961, was in fact, a military abduction. Personally, I am quite skeptical of the claim. However, I would have to do far more homework before I could truly either agree or disagree. However I recently spent some time reading Joe's article on the topic on his website (see www.icari.com/Betty---Barnie-Hill---Milabs.html). However something in Joe's argument very much caught my attention - his references to 'hypnotic thinking.'

The article states that if 'hypnotic thinking' exists, it invalidates the usefulness of hypnotic regression as a means of accessing subconscious material. However, while hypnotic thinking is a real, hypnotic regression is also very useful - if we understand its limitations. Unfortunately, hypnotic regression does not leave the memory intact. In fact, as Ernst L. Rossi states in his book, *Psychobiology of Mind Body Healing*, 'every access is a reframe.' Put another way, memory is not 'read only,' as if playing back a tape or reading computer memory. During each access of a memory, the mind processes it. This makes regression an extremely useful healing tool, but less useful as a means of historical research.

Thus, to a certain extent Joe is right. Because hypnotic thinking is different than our everyday critical thinking process, the material reviewed by hypnotic regression frequently cannot be taken literally. When in deep trance, the mind follows a different pattern of thought than our normal left-brained, beta-state reasoning. This phenomenon is what more than one hypnotherapy book author has referred to as 'trance logic.' It includes thought progression based upon symbolism, metaphor and association, rather than math and logic. It is the thought pattern of the dream, the symbolic processing of the subconscious.

In hypnotic trance, the mind can overlay different thought patterns, for example, literal memories with symbolic aspects of the subconscious. We can think of the mind as accessing everything as a form

of 'memory.' Thus I have often heard types of 'memory' referred to as 'biographical', 'metaphorical', and 'creative.' Often, the skill of the hypnotherapist can be vital when it comes to dealing with these. The hypnotherapist must remain alert for material that is symbolic but not literal.

During hypnotic regression, one can often distinguish creative or metaphorical material from biographical memory using multiple passes through an event. Typically, I have found that memories tend to remain stable during multiple passes through the event. Each retelling of the narrative will remain consistent with the previous pass, while developing additional detail. If this is not the case then the account may be more metaphorical or creative in nature. These are subjective rules of thumb and it is seldom absolutely clear which is the case. Yet these can provide a useful tool when reviewing events in the subconscious.

During any hypnotherapy session, clean regression is vital. Avoiding leading questions, keeping hypnotic navigation instructions very generic (e.g. 'please continue', 'what's happening now?', 'what else do you notice?', 'let's return to the beginning of the event', etc...), using very neutral wording; all of these can go a long way toward preventing contamination of biographical memories.

Ultimately, the most important task of the hypnotherapist is healing and even when a 'memory' is not biographical it may still be important. When processing material for healing purposes, metaphorical material can be extremely vital. The only thing to remember is that it cannot be taken as literally true - any more than dreams can be taken literally.

The opposite side of this argument is also valid. When working with clients in deep trance, I often observe them associate closely to the memory – reliving the events as if they were there now. In such cases, the mind often finds memories indistinguishable from present events. By using squeaky clean regression techniques, it is possible to keep the mind within the scene, keeping the material unchanged. In addition, it is relatively straightforward to detect when metaphorical or creative material the subconscious might begin to encroach on the memory. In such cases, the skill of the hypnotherapist is key – being able to discern dream-like characteristics, logical inconsistencies between passes through the narrative, or other departures from biographical memory.

In his article, Joe claims that the idea of 'hypnotic thinking' invalidates hypnotic regression as a tool for UFO investigation. On the contrary, rather than negating it, we now understand this process with a much clearer perspective. We see that there are limits on our ability to treat the subconscious as a repository of historical information.

While subconscious may not always be the ultimate hidden-information retrieval system that researchers had once hoped for, it is still a very valid way of understanding past events. Hypnotic regression is useful, but only if we understand its limitations. As part of our quest for understanding of the UFO abduction mystery, we need to remain aware of the limits of human memory.

**Will UK's Prime Minister disclose' the
UFO/ET presence?

More countries such as Brazil, France, U.K. and China are using the term 'UFO' to imply extraterrestrials are visiting earth. Prime Minister David Cameron and Deputy PM Nick Clegg the new UK Deputy Prime Minister are well aware that the Earth is being visited.

Cameron is a descendant of the British monarchy, and is a direct descendant of King William IV and is likely aware of Prince Phillip and the Royal Families interest in the phenomenon. At a meeting in Tynemouth, on January 27, 2009, David Cameron, while running for office was asked about Astronaut Edgar Mitchell's statements on radio show that the American government has had contact with extra terrestrials on multiple occasions and that these were ongoing. He spoke about the Roswell event in 1947 where wreckage of a downed UFO was recovered and contained alien bodies. He said this event was real but was covered up by the government for many years. Cameron was asked, "Do the people of the UK have the right to know?"

David Cameron who is now Prime Minister stated, "I have no idea there is intelligent life out there and no idea whether any of the sightings which have taken place or whether any incidents which have taken place have any basis in truth. But, I think we should be an open as possible, so I would be quite happy to give you a guarantee that if I became prime minister I would always be entirely open and

frank about these things. "I don't think any of us have any clue whether there's intelligent life out there and it is certainly not something that any government should seek to hide from anyone."

Deputy Prime Minister Clegg was born in village of Chalfont St Giles, England, that has been a UFO hotspot with hundreds of UFO sightings with the most recent on May 10, 2010, where jets were reported chasing a small fast unidentified object shown here.

The Ministry of Defence (MOD) apparently wants to keep this secret and is shutting down its UFO reports desk, and adopting a secret policy of destroying all UFO reports after 30 days. The MOD is adopting the same policy toward UFOs and extraterrestrial phenomena as the U.S. Department of Defense. This action seems to indicate they are worried about what the new Prime Minister might reveal. The newly released MOD files have already indicated USAF and RAF aircraft intercepted UFOs and attempts were made to shoot them down, or in my case chase them away. They may also be protecting assets such as space planes.

Into this situation is Gary McKinnon the London hacker who easily broke into official US Government classified files and was arrested by the UK police. US authorities have sought the extradition of McKinnon since 2005. Making the situation more interesting is that apparently, Prime Minister Cameron's is blocking or delaying Gary McKinnon's extradition to U.S. and implies he is taking a stand against U.S. policy.

Both Prime Minister David Cameron and Deputy Prime Minister Nick Clegg, prior to their 2010 election, declared their opposition to extraditing Gary McKinnon. As Gary grew up his stepfather, Wilson told him of seeing of cigar-shaped objects flying above Bonnybridge, Scotland convincing him UFOs were real. Gary joined Bufora, the British UFO Research Association as a teenager and became interested in the UFO propulsion systems. Gary felt a relatively cheap form of clean energy was being withheld from the people of the world. He decided to try to obtain proof of the existence UFOs and how their propulsion systems operated by hacking into US Government files.

McKinnon stated, "We're having wars over oil, we're burning fossil fuels from the Middle East. Pensioners are dying in Britain because they cannot afford to heat themselves. So why on earth isn't this technology being revealed?"

McKinnon became a trainee hacker and found numerous hackers from many countries were hacking into NASA, the Pentagon, and dozens of military installations. Gary says, "It was incredibly easy I just wrote a program that searched for network administrators who were too lazy to change their user names and their passwords from password'. When I found one I was in. It is apparent many US secrets have been hacked as indicated by the recent release of thousands of secret documents concerning Afghanistan.

Gary McKinnon essentially showed the US how easy it is to hack into their most secret files, but he was not in position to take advantage of his discoveries. However, other countries such as China and Russia have the ability to use the secret files to their advantage. These nations are also very interested in the operations of UFOs and our space fleet and probably desire to duplicate these craft. It seems unreasonable for the US to pursue a 63-year sentence against McKinnon's hacking, while hackers from other nations are ignored. He is a relatively unsophisticated hacker compared to the sophisticated hacking techniques used by Chinese Military Intelligence Units. He entered sites essentially left open by US Government facilities. He also possesses a great deal of information that he so far has kept hidden in order to have some bargaining power in negotiating a smaller sentence. He found indications of UFOs, and 'Non-Terrestrial Officers?'

He spent over six years hacking into the secret files of the US but found no indication of any conspiracy related to the US involvement in 9/11. The most interesting thing he admits finding is a list of Non-Terrestrial Officers. He feels there are US Navy spaceships in orbit. He says, "I found a list of fleet-to-fleet transfers, and a list of ship names. I looked them up. They were not U.S. Navy ships. What I saw made me believe they have some kind of spaceship, off-planet.

McKinnon's data assumes that the US Navy and probably the Air Force have spacecraft similar to the Shuttle based on back-engineered ET technology. The Navy Clementine mission micro-mapped the Moon indicating they had plans to return. McKinnon found evidence the US was operating an off-planet craft or an advanced shuttlecraft. The Obama Administration has indicated the NASA Shuttle program will end this year, but it is likely the military has a space fleet. McKinnon also saw a photograph of a smooth,

spherical object in a file at the Johnson Space Centre that might have been a UFO.

There is an obvious question, why do key members of the governments of the world desire to keep the truth from the public? It is possible the answer is that some aliens are exceptionally malevolent and would cause worldwide panic. It is also apparent there is little government's can do to protect us, and may be building space ships to fight the alien technology.

The actions of the Cameron-Clegg government with regard to Gary McKinnon's extradition will be an early sign of U.K. independence from the anti-disclosure position of U.S. Government. It is most plausible that the U.K. Ministry of Defence, like its counterpart the U.S. Department of Defense, wants to concentrate on its secret compartmentalized programs with extraterrestrial civilizations, while shutting down all of its mechanisms for collecting public reports of UFOs. The scientific elite generally ignores the evidence of extraterrestrial visits and warns if they do exist they are likely hostile to human life and should not be approached.

In the early 1990's Operation Right To Know (ORTK) <http://exopolitics.blogspot.com/2008/03/ortk-ufo-demonstration.html> began a series of UFO/ET demonstrations and other forms of activism. We started with a demonstration in front of the White House in Washington DC that stimulated demonstrations and other forms of activism across America, even to Argentina and the UK. The idea was to try to kick start a global UFO/ET activist movement that would stimulate mainstream media to take the subject seriously and not only report on UFOs, but to seriously investigate the issue. Even though we are in the mist of UFO/ET disclosure as Richard Hoagland aptly points out, most informed people realize that mainstream press attention is still key to the final unraveling of the 60 year old cover-up.

Unfortunately in the absence of vigorous citizen activism on a variety of issues including UFOs the mainstream press becomes the lapdog of government and special interests, rather than a watchdog for the citizenry. In the 1990's the overall conditions for a sustained vigorous UFO/ET

activism movement to end UFO secrecy was not favorable and our effort failed in its main goal to end the UFO/ET cover-up once and for all.

Some secondary goals succeeded like the focusing of major press attention onto the subject. I believe this succeeded in sparked many mainstream UFO shows. We also made inroads in stimulating an awareness in the UFO community that good science can't succeed if it being suppressed, and its data being manipulated for political reasons. A political problem deserves political solutions, something some very savvy propagandists and intelligence people in the UFO community realize very well!

Now almost 20 years later the times are changing and we are the mist of accelerating disclosure where the conditions are becoming more favorable for UFO activism. These conditions include with the rise of the Internet, Internet social networking sites like Facebook, Exopolitics, a growing number of informed individuals in the UFO community, a band beginning to sing UFO protest songs, and a increase of media savvy UFO experts talking to the mainstream press. (Stanton Friedman can't stand up to the media savvy propagandists and debunkers on his own!)

As Richard Hoagland in a recent interview with George Noory <http://www.youtube.com/watch?v=7sfjEkYX5Ek> pointed out, government's create boundaries that the mainstream press will not cross and it's not real unless its on CNN. It is now my contention that a ground swell of sustained citizen activism is growing to a point that will allow the press to push the boundaries of serious reporting and investigation to eventually bust up the UFO/ET cover-up. We can't hold the mainstream press entirely responsible for abdicating it's watchdog status beginning in the 1950's in the face of a government propaganda blitz of denial and ridicule and public apathy.

In 1993 in the second UFO demonstration in front of the White House ORTK got massive media attention that spread across the country and the globe. While the Washington AP, a critical bottleneck of press information, tried to subvert our action through disinformation and ridicule, CNN to its credit was there honestly covering our event with it's top reporter a good friend of a friend of mine. <http://www.youtube.com/watch?v=M16BSLUV9U> U Later Larry King from CNN covered our Pentagon demonstration. CNN has once again pressed the boundaries with its excellent coverage of the Salas-

Hastings press conference in Washington. <http://pnhay.home.sprynet.com/ufo/>

Today Jeff Peckman supported by Larry Bryant one of the original members of ORTK have resurrected UFO activism with the Denver Initiative. Now that I am on Facebook and can see the possibilities, I have begun to help out to build up Internet buzz in preparation for mainstream press attention before, during and after this event. Since several days ago when I first began to push the petition <http://www.petitiononline.com/> drive on Facebook there has been a sharp spike of petition signatures to over 1000.

Anybody can sign this petition even overseas and I ask folks to please do so. Your signature matters and sends a signal in support of Jeff Peckman and the power of social networking in general. With more social networking on Facebook by new UFO/ET activist leaders, we should be able to double and even triple the number of signatures in a short period of time.

Now a band is going to hold a upcoming concert at the same time as the Initiative in Denver <http://news.exopoliticsinstitute.org/index.php/archives/487> and is singing about a UFO Uprising, all the factors for a activist movement seem to be falling into place, and this time I hope it will blow the UFO/ET cover-up sky high. This to organize and follow through on ORTK original actions to end the sixty year old cover-up that is not only destroying the environment by suppressing new cheap exotic energy technologies, but is suppressing human evolution on earth! The Dawn Of Disclosure: UFOs Paralyse US Missile Bases

Is there anybody out there? Or to rephrase the question – in a multiverse of countless dimensions, containing trillions of galaxies, each containing stars with orbiting planets, many of which have all the conditions necessary to sustain humanoid existence, how could there not be?

At a National Press Conference in Washington on September 27, 2010, televised on CNN, leading witnesses, integrally involved in the US nuclear

missile programme, testified before the world that while on their watch a number of UFOs had been seen with the bare eye, photographed, recorded on tape and sensitive equipment, and tracked by radar. The most disturbing news as far as the US defence establishment is concerned is that in some instances laser-like rays were shot down from the alien craft which paralyzed the missile controls, rendering them temporarily inoperable and in four cases activating them for a short while before they were deactivated and put back on line. There also another account that at a similar installation in Russia, a UFO had actually armed and activated a nuclear missile, which was once again shut down shortly after.

There is evidence coming from a UK government 'insider', not aired on this disclosure conference, that in the 1960s the British intelligence agencies produced a secret report detailing claims of extraterrestrial sightings, drawn from the evidence of 1,800 people in Europe and Scandinavia who claimed to have seen a UFO, an extraterrestrial, or whom had had contact with beings from another world. A series of interviews were conducted simultaneously in US, the USSR, Australia and Japan, producing an eventual 62,000 individual testimonies. The conclusions were that the majority of these experiences were markedly similar and 75% told of positive, loving communications with the ETs of various races.

Evidence is also appearing that since the 1940s, all successive US presidents have been privy not only to the existence of extra-terrestrials and UFOs, but to the fact that there have been and are now actual extra-terrestrials working alongside humans in various establishments, mainly huge underground complexes engaged in a variety of 'black' projects, some retro-engineering super-hi-tech devices to produce terrestrial spacecraft and others involved in genetic experimentation.

There are also personal accounts, such as those by Duncan O'Finion and Aaron McCollum, reinforcing this information, that some of these craft were piloted by humans, largely genetically and experientially modified 'super-soldiers'. McCollum

testified to having travelled with 'greys' in the secret US TR3-B spacecraft, the product of back-engineering on human abduction missions. McCollum also testifies to having seen genetically produced hybrid human-dolphins! These two, namely the super-soldier programme and hybrid experiments, are but an infinitesimal part of the black op programme, particularly the super-secret space programme currently being pursued by the US, Britain, Russia and China to name but a few. These programmes are way, way above top secret, 27 levels above that accessible by the US president, in fact, and are almost unknown by the majority of the world's population. That anyone knows about them at all is largely due to the courage of 'whistleblowers', individuals who have actually been involved, first-hand, in many of these programmes and have come forward to testify, often under threat of dire reprisals, and some have actually 'disappeared' under highly suspicious circumstances, often after being visited by the legendary 'men-in-black'.

The government's response to the UFO news conference - You can't beat a system you can't understand

Last week, I wrote a column about a Sept. 28 National Press Club news conference concerning six former Air Force personnel who were willing to break their silence and “disclose dramatic first-hand experiences with UFOs at nuclear weapons sites.”

The conference, hosted by recognized UFO researcher Robert Hastings, and co-hosted by former ICBM launch officer Captain Robert Salas, did indeed occur. As promised, the six former Air Force personnel did testify and disclose accounts of alleged UFO encounters that they had been harboring for decades.

Although this disclosure appears to be a major breakthrough that should support the argument that extraterrestrials are visiting Earth on a regular basis, it did not accomplish that effort.

The Federal Aviation Administration (FAA) responded with its usual rhetoric. “We do not investigate claims of UFO sightings,” an unidentified FAA spokesman said via a telephone inquiry.

The FAA has taken this position for quite some time. Also, the news conference was not the first that Hastings has hosted.

In a CNN video from Nov. 13, 2007, Gary Tuchman reported on a similar conference, again at the National Press Club that hosted 14 guests from seven different countries, all reporting close encounters with alleged extraterrestrial visitors. One of the guests was a retired Belgian general and another was Fife Symington, former governor of Arizona.

Whenever these press conferences have been held, a few more people gathered the courage to come forward and share their experiences. Most of them are credible, respected and educated citizens. All of them fear being perceived as nut cases or “weird” because of the absurdity of their claims.

According to Michael Horn, another acknowledged UFO researcher, who gave the most reasonable

explanation that supported both sides of the UFO controversy, everybody is right.

He went on to say that everything unknown or unidentified is not necessarily extraterrestrial. Many of the sightings have natural explanations.

Horn, who claims to have experienced six separate UFO sightings, says that he has been held to the same scientific standard. He, and all of the other witnesses, saw something that they cannot explain.

Nobody has ever shown solid proof that they communicated with whomever or whatever was piloting the craft. None of the credible witnesses ever claimed to have experienced anything more than seeing something unusual, for which they had no explanation. That does not mean that what they saw came from another planet.

The military personnel and witnesses from large groups that claimed to have seen the unusual flying objects have never said they saw a pilot or evidence of a living being involved in their encounters.

Even the group from Malmstrom Air Force Base in Montana, where 10 nuclear-powered missiles were rendered inoperable when the alleged space vehicles were hovering about the silos, cannot prove that the unexplained visitors caused the malfunctions.

This does not mean that the government does not believe these witnesses, or that the events did not happen. Any malfunction of a defense system is taken very seriously. However, there is no proof of aggression by the alleged spacecraft.

All they have ever done is make their presence known, and perform some aerobatic maneuvers that are beyond the capabilities of any known aircraft from this planet.

As disappointing and frustrating as it must be to the witnesses and others who are concerned about the seeming increase and bolder encounters with unexplained flying objects, most governments are taking similar positions.

Until one of the visitors commits an act of aggression, or lands in a public place and the pilot comes out and attempts to introduce himself/herself/itself, authorities are not going to do anything. Without tangible proof, there is nothing to investigate.

In conclusion, the government's response to alleged alien visitors flying UFOs and visiting military installations, is no response.

Nonetheless, I can't help but think that someone might be sending us a message by shutting down 10 ICBMs so they can't be fired.

Until someone can prove a close encounter of the third kind, UFOs will remain part of our system that we can't understand.

Veteran China astronomer claims UFOs are extraterrestrial space craft Michael Salla, Honolulu Exopolitics Examiner, August 23rd, 2010

In a speech at a science forum held in the city of Guangzhou on August 23, a veteran Chinese astronomer with almost 40 years experience claimed that some UFOs are extraterrestrial spacecraft. Professor Wang Sichao is a planetary astronomer at the Purple Hills Observatory of the Chinese Academy of Sciences. Based on scientific observations of UFOs over his 39 year career, he has concluded that some are powered by antigravity

devices. Also, in contrast to Professor Stephen Hawking, who recently declared intelligent extraterrestrial life was likely to be predatory in nature, Wang dismissed such thinking as premature. He claimed some extraterrestrials are visiting Earth in a Research and Development capacity, and are therefore friendly enough to begin cooperation and mutual exchanges. A summary of Wang's speech was reported by a number of China newspapers including the influential People's Daily Online. This ensures wide coverage in China, and raises the following question. Are Chinese authorities tacitly encouraging an 'exopolitics debate' over the motivations of advanced alien life in order to prepare the Chinese and world public for the inevitable official disclosure of the existence of extraterrestrials?

Based on his observations at Purple Hills Observatory and analysis of UFO sightings, Wang was able to conclude that some UFOs are not natural phenomenon, and use antigravity technology. This is how the People's Daily Online summarized Wang's reasoning: "Wang also found that in the terrestrial space between the height of 130 kilometers and 1,500 kilometers, UFOs have appeared many times. Their flying speed is ... as slow as 0.29 kilometers per second [1000 km/hr] and they can fly in the 1,460 kilometers' height for more than 25 minutes. This means UFOs have the anti-gravity ability. Otherwise, they would fall soon."

According to a report in another Chinese online newspaper, Sina.com.cn, Wang stated that the extraterrestrials appear to be engaged in a scientific Research and Development mission. This contributed to Wang concluding that Hawking's views regarding hostile intelligent extraterrestrial life was premature. Wang said: "If they are friendly to us, we can promote the human beings' civilization through exchange and cooperation with them. If they are not, as long as we prepared for their invasion, we can beat them back based on their weaknesses. After all, they are life entities, they would show their slips."

Wang's speech has yet to be translated into English and released for distribution, but the prominent coverage given to it in China is certain to generate much interest in the rest of the world. The People's Daily Online is an official organ of the Chinese communist party that still exercises tight control over all media sources. This suggests that Wang has tacit official approval to disseminate his views to the media, and for the Chinese media to report on

his conclusions, thereby generating an exopolitics debate between scientists over the motivations of extraterrestrial life.

Recently, China officially became the world's second largest economy when it surpassed the Gross Domestic Product of Japan. It appears as though China is not content to simply exercise its economic influence, but also its scientific influence by encouraging Chinese scientists to openly discuss UFOs and extraterrestrial life. A global exopolitics debate among influential scientists on the motivations of extraterrestrial life, whether aliens are actually visiting the Earth in UFOs or not, is most definitely underway.

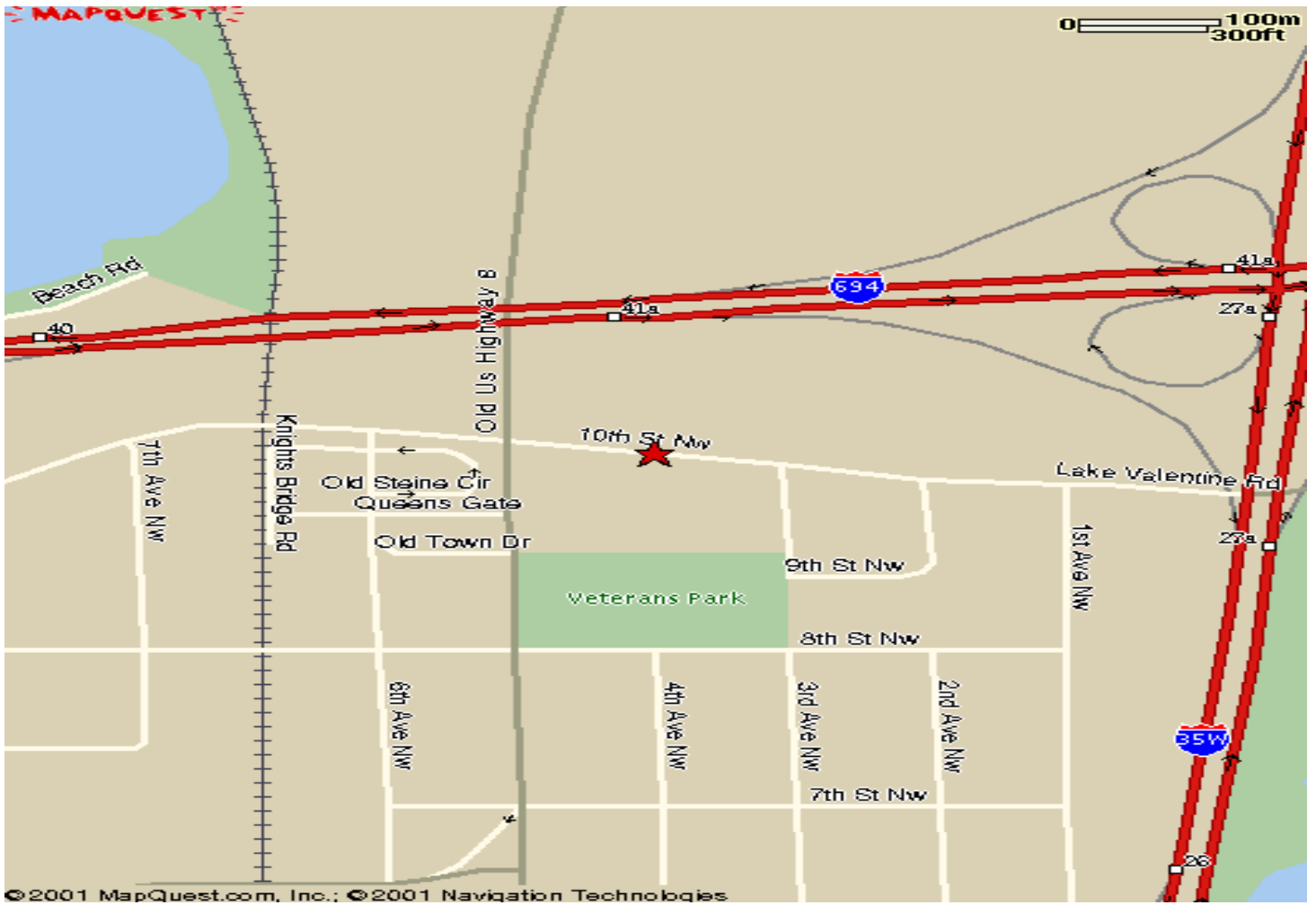
