### January/February, 2014 - Asking the right questions

A few weeks ago, I did a past life regression with a client who was in some ways, far more advanced than I may ever be. In the process of our work, we explored some of the depths of spirituality, things that I had touched on in the past, but had never gone all that deeply into. In the process, I got into a dialog with a spiritual side of her that definitely taught me a thing or two.

In effect she was channeling what she said was a higher spiritual being [my paraphrase, CL]. I always treat channeled information and any information behind it with a high degree of discernment. Still, the questions she raised were interesting ones. The result was for me, a fire bath of universal spirituality (please don't ask me to define that), as well as a lot of specific messages to the present-day anomaly research community.

One of these messages was that in the UFO research world, we are not asking the right questions. I asked her what she meant and she told me that our MUFON work is in pursuit of knowledge, the essence of the discipline of science, itself. But, she said, knowledge for its own sake is useless. She told me that instead, we should be seeking with the heart. Spirit is the essence and the greatest need our world has, and that our (specifically my) focus needed to be more on that.

In the weeks since that dialog, I have pondered this question. Is she right? Are we pursuing the wrong goals? Seeking the wrong answers? Are we asking the wrong questions?

One point often stressed in the spiritual/metaphysical community is that humanity has advanced in science and technology far beyond our spiritual and ethical boundaries. The result has been global war, runaway population, environmental peril, etc. i don't think I need to say much more on that.

Several experiencers who have subsequently begun to deeply study the UFO question have conveyed a similar message. Somehow, they are told (not sure by whom) that we are seeking the wrong goal. Rather than trying to figure out whether the aliens are from a nearby star system, inter-dimensional, etc., we should be focusing on our relationship with the cosmos. We should be trying to advance our own level of consciousness, rather than trying to figure out how the alien warp drive works.

So, in exploring the interactions with the phenomenon, I again need to ask, are we seeking the right answers?

What do UFO studies seek to accomplish? The stated goal of MUFON is "the scientific understanding of the UFO phenomenon for the benefit of humanity." For many years, we have focused on the first half of the sentence, the scientific understanding. But what do we mean by "for the benefit of humanity"? And how can we bring the fruits of our research into the service of our world?

In UFO studies, there have generally been two camps. One is a purely nuts and bolts focus, studying the physics of the unexplained, seeking to understand UFO flight characteristics, ground traces, medical effects, field effects, and so forth. They stress solid, evidential, rigorous science. The other is much more metaphysical, seeking a deeply spiritual understanding and relationship with the phenomenon.

I began almost purely as the former. I was an engineer, trained in electronics and electrical engineering. As an UFO investigator, then abduction researcher, and then as a hypnotherapist, my path has led in a far different direction - much more toward the metaphysical, much more toward the idea of the phenomenon as a relationship. And indeed, that's one way to understand UFO interactions - as a relationship between the observer/experiencer and the phenomenon.

So where does that lead us? What do we do with that understanding? Can we understand and develop a relationship between humans and visitors?

In *The Cosmic Bridge* ([www.thecosmicbridge.com](http://www.thecosmicbridge.com)), we examine the close encounter scenario and look at ways to understand it. One aspect of this question is what I call the Indigo Hypothesis. The Indigo Hypothesis proposes that part of the Abduction phenomenon is focused on breeding some type of genomic changes, which the visitors are then infusing back into our own genetic makeup. Why? Perhaps it is to help foster an awakening of some form - resulting in a new generation of children, many of whom I have observed in the family lines of experiencers.

At least in part, perhaps the phenomenon is giving us a power assist in our own growth. For better or for worse, I suspect that at least one intent behind the abduction phenomenon is some sort of "human improvement project." Perhaps they are somehow trying to alter humanity to be better cosmic citizens. (It remains to be seen whether this would

be better from our perspective, but from a cosmic perspective, it probably makes sense.)

One of my goals, especially when working with experiencers, is to bring healing to the relationship between humans and visitors. While healing needs to be defined in each case, and in some cases none is needed, in many cases there is a well-defined issue to be resolved - most often fear. Thus, one of my biggest endeavors in the last few years has been to find better ways to help people overcome the fear response to the phenomenon and level the playing field for we humans.

How can we best help experiencers come to terms with the phenomenon, asserting their own rights as sentient beings in a free-will universe? Can we begin to forge a "Cosmic Bridge" between humanity and cosmos, bridging gap between the two worlds in which experiencers find themselves? Can we also learn to do what the visitors can do, build craft that do what they do, etc.?

Personally, I don't see any of these goals as being mutually exclusive. Even though I have strong metaphysical interests, I'm as much of a nuts-and-bolts'er now as I ever was. I would dearly love to understand how the alien warp drive works. Yet we need to pursue many other goals besides intellectual/technical understanding.

My guess is that this is what the spiritual side of my client was advocating during our dialog. More than simply a scientific understanding of the phenomenon, we need to put that understanding to work for the betterment of humanity. We need to grow our own collective consciousness such that we can become part of the cosmic community. And to do that, we need to be sure we ask the right questions.

**AN ESTIMATE OF THE SITUATION –  
JANUARY 2014

There are today probably two main ways of approaching truth: "The Intelligence Method" and "The Scientific Method". The first is the method used by the military and intelligence agencies such as the CIA and the NSA. The second is the method that is supposed to be used by scientists. Unfortunately, as the late J. Allen Hynek PhD, former head of the astronomy department at Northwestern University and scientific consultant

on UFOs to the Air Force for twenty years once wrote, "Science is not always what scientists do."

Science has been defined in many ways. Perhaps the one that applies most aptly to UFOs is "Knowledge derived from scientific disciplines, scientific method, or any systematic effort".

The scientific method has been defined as "A method of discovering [knowledge](#) about the natural world based in making [falsifiable](#) predictions ([hypotheses](#)), testing them [empirically](#), and developing theories that match known data from repeatable physical experimentation." In the spring of 1952, as I recall, a "think tank" studying UFOs for the Air Force predicted on the basis of their study that UFO sightings were moving toward the U.S. east coast and there would be a peak in sightings there in the summer of 1952. In July of 1952 the famous Washington DC sightings, both visual, radar and photographic, occurred. As massively documented in the book "Shoot Them Down! The Flying Saucer Air Wars Of 1952" by Frank Feschino, Jr., eastern U.S. sightings continued from July through September, including the "Flatwoods Monster" on Sept. 12. Feschino provides strong evidence that the "monster" was a small flying vehicle which emerged from a much larger downed craft which area witnesses also saw on that same night. He also documents hundreds of Air Force pursuits of UFOs and subsequent poorly explained plane crashes, evidence that there really was a "war" going on.

However, while it is possible to apply science to some aspects of UFO reports, a systematic study, such as used by intelligence agencies, has generally been the best method to attempt to approach the truth about UFOs.

After over 60 years of studying the subject, including reading dozens of books and investigating and recording hundreds of first hand reports, photographs and other evidence, here is what I think is going on with UFOs: I believe that Earth is being studied scientifically by a large number of extraterrestrial races, about 70 or more. These races seem to be operating under what has come to be known as the "Star Trek Prime Directive", the rule under which the fictional space explorers operate in the television and film series *Star Trek*. The *Prime Directive*, Starfleet's "General Order number 1", is the most prominent guiding principle of the fictional United Federation of Planets. The Prime Directive is explicitly defined in the *Star Trek* episode "[Bread and Circuses](#)," which is set in the year 2267: Whenever the *Star Trek* crew visits a new planet, there is to be "No interference with

the social development of said planet." The reason for this directive is that such interference could cause problems which the space explorers would then be morally responsible for fixing, and often fixing problems can be very difficult!

There are at least three sources to support the number of 70 extraterrestrial races. The first and most specific is a statement made by Betty Andreason under hypnosis as recorded in the book "The Andreason Affair" by Raymond Fowler. The second is a book by science writer Patrick Huyghe *The Field Guide to Extraterrestrials* which contains approximately fifty depictions of extraterrestrials based on documented accounts, witness sketches and descriptions. These do not include the prototypical "greys", of which other accounts suggest there are at least four different species, and a number of creatures documented in other reports. The third source is a man named Roger Kvande.

Roger Kvande is responsible for the most interesting learning experience that I have had with regard to UFOs. He reports a number of experiences with UFOs, including an intelligent space craft, which appears to be controlled solely by some form of onboard intelligence. Craig Lang and I have been talking to Roger and discussing his accounts for 15 years. I asked him to write a book about his experiences and he asked me to help him, which I did. The book is published on [www.lulu.com](http://www.lulu.com) and the title is "Extraterrestrial Odyssey" by Roger Kvande, William McNeff and Craig R. Lang. We cannot yet prove his story scientifically, but after careful study, I believe he is an honest man and has had some very interesting experiences. His account of "space-time travel", in which he depicts a "flat" universe, parallels current theories of physicists about our universe being a projection of a "flat" universe. In this book Kvande, who is an artist, depicts a night meeting when he was a boy with a large group of different extraterrestrial species.

A discussion of the term "extraterrestrials" is in order. One of MUFON's respected science consultants states that we should not use the term, because we have no scientific proof that these reported creatures are in fact extraterrestrial. From a scientific standpoint, he is absolutely correct. They might be "interdimensional", "angelic", or even "demonic", for instance. The term "aliens" might be more apt. I will use that term through the remainder of this article.

In regard to the "No interference" directive, there is an account in which an alien was asked why they didn't make open contact. The reply allegedly was, "We want you to believe in us, but not too much!"

Even if the aliens have a “No interference” directive, sometime in the future circumstances might arise under which they would make themselves known much more openly, for instance if the human race were carrying on activities that would result in severe damage to the Earth or the virtual erasure of our civilization, such as it is. As Stanton Friedman so aptly states, one of human beings chief activities is “tribal warfare”.

A case could be made that the human race is too immature for alien contact. Dr. David Jacob believes on the basis of his extensive studies that the aliens are planning some kind of invasion in the not-too-distant future, and quotes some statements by aliens to this effect. There is also on record an alleged statement by an alien that this “invasion” will be peaceful in nature. But when all is said and done, there seems to be no firm evidence that an invasion or open contact by aliens is going to happen any time soon.

The same must be said for acknowledgement by the U.S. government of an alien presence in the vicinity of Earth, despite the efforts of many over the years. The most recent effort is that by the Paradigm Research Group (PRG), which is planning to post a new “Disclosure Petition” on the White House website, which will petition the Obama Administration to: “Support immediate congressional hearings for government/agency /political witnesses under oath regarding an ET presence.” There are so many other political hot potatoes which the Administration and Congress are currently wrestling with, that I fear the question of an alien presence is not one either will be eager to take up. I would also expect some secret efforts to discourage any such hearings. Still, I hope that all people who are interested in UFOs will sign the PRG petition when it goes on line. It could bring the inevitable day of alien acknowledgement and disclosure a little bit closer.

This is my considered “Estimate of the Situation” as we begin 2014.

## **Out of the closet, into the fire**

For more than six years, De Void has tended to avoid the whole alien abduction thing because, well, radar tracks, multiple eyewitnesses, detectable electromagnetic effects and videos are one thing.

Nasal probes, mindscans, teleportation, hybrids — that’s an entirely different conversation. Although, if UFOs are truly the manifestation of the technology they appear to be, running circles around our most advanced weapons systems, then it stands to reason that literally anything is possible. But if that’s true, if Zeta Reticulans or whatever can move like vapors into our bedrooms, then we’re all screwed, and De Void’s not into that. Furthermore, try to goad the mainstream media into getting a grip on the idea of beaming humans aboard starships seriously; hell, De Void can’t even get Texas public radio reporter Wade Goodwyn to examine ordinary FAA/National Weather Service records that painted [a UFO incident he covered in his own back yard](#).

But, deep breath, here we go: Recently, retired Air Force captain Bob Salas went public with his own abduction experience. And there’s no getting around it because [Salas was one of the first military veterans to go on record](#) about UFOs tampering with and disabling U.S. nuclear missile systems. His example emboldened dozens of other USAF veterans to step up and share their stories about high strangeness in the missile fields. Salas took a no-nonsense stance and [wasn’t afraid to call people out if he thought they were being dingbats](#). He spent years crafting a rep as a fully grounded left-brain type.

Now this -- an abduction in 1985 in Huntington Beach, Calif. You can read all about [at the Open Minds site](#). The salient passage (cringe): “He floated off the bed towards the locked bedroom window, which he felt certain they [the aliens, presumably] would be unable to lock. Nevertheless, he went through the window in an upright position and was taken aboard a craft. He was shown a needle, eight to twelve inches in length, which was inserted into one of his testicles in order to collect semen.” Oy vey! “The pain was excruciating, and when Salas complained to his abductors, the pain suddenly ceased. This was followed by a physical checkup in which his back seemed to be of primary interest. He next remembers moving through a curved hallway and seeing a bright light before suddenly finding himself back in his bed.”

As abduction accounts go, this one’s pretty routine. Salas states he never forgot the incident after it occurred, but he didn’t recover the details until undergoing hypnotic regression in 2006. Only then did he begin discussing it with his wife Marilyn who, even today, recalls only the broader aspects.



**THE FLAT UNIVERSE:  
SUPPORT FOR ROGER KVANDE'S  
ACCOUNT OF SPACE-TIME TRAVEL

“I don’t remember nearly as much as Bob does. I think I was being an ostrich about it, like, if I stuck my head in the sand it’d all go away,” Marilyn says from their home in Ojai, Calif. “I remember being on the side of the bed that faced the doorway, and when I opened my eyes, there was a foggy, bluish, gray light down the hallway that seemed to be coming from the living room area. That’s all I remember, but it was a freaky thing at the time and I shut my eyes, thinking ‘I don’t believe what I just saw.’ It was so strange I didn’t even mention it to Bob the next morning.” Nor did hubby say mention it to her.

Though they met in 1969, Marilyn says Bob didn’t even discuss the Minuteman missile shutdown at Malmstrom AFB, which happened just two years earlier, until the mid-1990s. Even then, it would be another decade before he started asking if she remembered a blue-light incident from Huntington Beach. Bob pressed the issue a lot farther than Marilyn did.

“Honestly, I don’t have any desire to know more than the blue light,” she says. “My concern, when Bob decided to discuss it openly, was how the general public was going to respond to it. But this is something Bob felt like he needed to do.”

Salas says he wanted to spill the beans as soon as he got sharper visuals through hypnosis. “Understandably,” he says, “I wanted to fully establish my primary story before I talked about this. I did not factor my reputation into it — I’m not trying to make anyone’s life more difficult. But I feel a responsibility not only to myself but also to the hundreds of thousands, maybe millions of people, who’ve been abducted.”

So there it is — the point man on UFOs and WMD, out of the closet. Will it damage his credibility? No doubt. Salas is unconcerned. “I’ve already received some blowback, but so be it,” he says. “But they’re not just here to fly around in our airspace. Something else is going on. If they’re taking eggs and they’re taking semen, then they’re producing hybrid beings. And it could be either horrifying or unifying, depending on how you want to look at it.”

De Void doesn't want to look at it at all. Nevertheless.

Recently, in one of his emails, Victor Martinez forwarded a summary of a relatively new theory in physics, the theory of the holographic universe, which postulates that the universe is a hologram and everything you can see -- including this article and the device you are reading it on -- is a mere projection. (I don’t like the word “mere”, but that was the wording of the article. There is nothing “mere” about our amazing universe.) Martinez wrote the following:

*“This is according to a controversial model proposed in 1997 by theoretical physicist Juan Maldacena. Until now the bizarre theory had never been tested, but recent mathematical models suggest that **the mind-boggling principle could be true.** The holographic model suggests gravity in the universe comes from thin, vibrating strings. These strings are holograms of events that take place in a simpler, flatter cosmos.”*

*“The theory suggests that the entire universe can be seen as a 'two-dimensional structure projected onto a cosmological horizon' - or in simpler terms, the universe we believe we inhabit is a 3D projection of a 2D alternate universe.”*

When I read this email, I immediately thought of Roger Kvande’s account in the book which Craig Lang and I co-authored with him: *Extraterrestrial Odyssey* (lulu.com). He states that when he was aboard the alien ship and was placed in the life-support chamber with his mind in direct contact with the ship’s intelligence/mind, he could see everything that the ship saw.

He stated that when the ship prepared to perform a space-time jump, a circular, colored galaxy-like “whirlpool” was visible. Roger nicknamed this “The Space-Time Whirlpool”. The ship would pick some point in this whirlpool to jump to, and it would immediately be in this new location at a chosen time. Roger noticed that whenever the ship jumped back to Earth, it always went to the same point. I asked Roger by email whether this theory of the holographic universe was what he was depicting in his rendering of the “Space-time Whirlpool”.

Roger replied, "The universe is a 2D flat thin surface, a projection perceived by us as 3D. The universe exists within a dark matter cloud; the big bang pushed most of it out of the way. We are a bubble falling, expanding back into the dark matter cloud. At the interface of the bubble and dark matter is an event horizon, where gravitational forces of the dark matter cloud slow and stop time. The bubble piles up, all the events, till all that is, is trapped there."

"An alien ship plays its beam over itself changing the 4 laws of physics; it becomes insubstantial, pops out of the thin layer of the universe like gas from under water. It stops at the dark matter event horizon, looks down on a whirlpool of light, all that ever was and is: the 'space-time whirlpool'. The ship picks a new time space coordinate and jumps back. This is space-time travel."

"Everything has already happened -- consciousness makes the 2D flat universe into 3D reality."

Please note that Roger Kvande's explanation includes information about "dark matter", a subject of great puzzlement to the cosmological community. Scientists are relatively certain that it exists; the shape and organization of galaxies seems to demand it. Theories about dark matter – what it is, how it might be detected, abound. So far, efforts to detect it have been fruitless. Roger says that the Big Bang pushed most of the dark matter away. That implies that there is still some dark matter scattered through the universe. This is what the majority of physicists and cosmologists believe.

In spite of a fair amount of study of quantum theory, string theory and cosmology, I don't pretend to fully understand the theory of the "flat universe" or Roger's exposition of it. But what seems plain to me is that the physicist's theory of the flat universe is credible and lends credibility to Roger Kvande's account of the "space-time whirlpool", space-time travel, and his seemingly incredible experiences.

There is a similarity between the flat universe theory and the black hole theory. Martinez quotes the physicists as saying, "In a black hole, for instance, all the objects that ever fall into it would be entirely contained in surface fluctuations. This means that the objects would be stored almost as 'memory' or fragment of data rather than a physical object in existence." This is what black hole expert Rudy Schild, PhD at Harvard has been saying, that black holes are the "memory drives" of the universe.

Similarly, the flat universe is the holographic "DVD" of the universe.

What blows my mind is that Roger Kvande says "Everything has already happened." In spite of that, I still believe, rightly or wrongly, that I have free will – and you are free to doubt or believe that or anything else in this article!

## **Former Minister of Defence: Shooting Down UFOs Could Spark Intergalactic War**

The honorable Paul Hellyer, Canada's former minister of defense, appeared on the RT interview show SophieCo with Sophie Shevardnadze to discuss extraterrestrials and UFOs.

Hellyer is a firm believer that extraterrestrials are visiting Earth in spaceships, and he has spoken publicly about this for years. And on several occasions, he has stated that "UFOs are as real as the airplanes that fly over your head."

Shevardnadze asks Hellyer, "Why do you say that UFOs are as real as airplanes flying over our heads?" Hellyer responds, "Because I know that they are. As a matter of fact, they've been visiting our planet for thousands of years."

Hellyer claims that UFOs have been downed by military action, and alien technology has been harnessed by Earthlings.

He states that:

"As far as technology is concerned, they are light years ahead of us, and we have learned a lot of things from them. A lot of the things we use today we got from them, you know – led lights and microchips and Kevlar vests and all sorts things that we got from their technology and we could get a lot more too, especially in the fields of medicine and agriculture if we would go about it peacefully.

"But, I think, maybe some of our people are more interested in getting the military technology, and I think that's wrong-headed, and that's one of the things that we are going to have to change, because we're going to have to work together, all of us, everywhere on the planet."

Shevardnadze asks Hellyer if shooting down these UFOs is risking an interstellar war, and, if so, "should we be creating a Star Wars force to defend ourselves from possible invasion or something like that?"

Hellyer responds, "I think it's a possibility, but it's a possibility especially if we shoot down every UFO that comes into our airspace without asking who they are and what they want. Right from the beginning we started scrambling planes, trying to shoot them down, but their technology was superior enough that we weren't able to get away with it, certainly not for a long while."

"During that period of time they could have taken us over without any trouble if they wanted to, so I think, rather than developing our own Star Wars to protect ourselves against them, we should work with the benign species that are of a vast majority and work together, and rely largely on them, of course, and cooperate, so that we would be contributing something at the same time; I don't think there's any point in us developing a galactic force that would tempt us to ride on our own and get into mischief, which is one of the things that some of them are concerned about."

Hellyer was one of several witnesses who testified at the Citizen Hearing on Disclosure in Washington, DC that took place in May, 2013. As part of his testimony, Hellyer stated that "aliens are living among us and that it is likely at least two of them are working with the U.S. government."

Short Description of UFO Event: My son and I saw a large blueish orb falling from the sky over Snelling ave and it disappeared into the tree line on the other side of Snelling.

Detailed Description of the UFO Event:

At about 8:00 pm my son and I had just taken the garbage out to the curb in front of our house and as we got near the front door we stopped because I was finishing smoking a cig and we were talking. I noticed a large bluish white orb falling from the sky at an angle, I yelled at my son to look at it because he was facing me and it was falling from the sky behind him, he turned and saw it just as it was descending into the tree line on the other side of

our street. We both watched it disappear. I don't know what it was but I do not think it was a plane or a helicopter because it made no noise. We live on a frontage road of a busy 4 lane street and there is also a frontage road on the other side, so it is an extremely wide distance that the orb moved from our side of the street on the east to the other side of the street towards the west. We are both perplexed as to what we saw tonight.

After hundreds of years of detailed observation and study, our closest companion in the vast universe, Earth's moon, remains an enigma. Six moon landings and hundreds of experiments have resulted in more questions being asked than answered. Among them:

**1. Moon's Age:** The moon is far older than previously expected. Maybe even older than the Earth or the Sun. The oldest age for the Earth is estimated to be 4.6 billion years old; moon rocks were dated at 5.3 billion years old, and the dust upon which they were resting was at least another billion years older.

**2. Rock's Origin:** The chemical composition of the dust upon which the rocks sat differed remarkably from the rocks themselves, contrary to accepted theories that the dust resulted from weathering and breakup

of the rocks themselves. The rocks had to have come from somewhere else.

**3. Heavier Elements on Surface:** Normal planetary composition results in heavier elements in the core and lighter materials at the surface; not so with the moon. According to **Wilson**,

"The abundance of refractory elements like titanium in the surface areas is so pronounced that several geologists proposed the refractory compounds were brought to the moon's surface in great quantity in some unknown way. They don't know how, but that it was done cannot be questioned."

**4. Water Vapor:** On March 7, 1971, lunar instruments placed by the astronauts recorded a vapor cloud of water passing across the surface of the moon. The cloud lasted 14 hours and covered an area of about 100 square miles.

**5. Magnetic Rocks:** Moon rocks were magnetized. This is odd because there is no magnetic field on the moon itself. This could not have originated from a "close call" with Earth—such an encounter would have ripped the moon apart.

**6. No Volcanoes:** Some of the moon's craters originated internally, yet there is no indication that the moon was ever hot enough to produce volcanic eruptions.

**7. Moon Mascons:** Mascons, which are large, dense, circular masses lying twenty to forty miles beneath the centers of the moon's *maria*,

"are broad, disk-shaped objects that could be possibly some kind of artificial construction. For huge circular disks are not



likely to be beneath each huge *maria*, centered like bull's-eyes in the middle of each, by coincidence or accident."

**8. Seismic Activity:** Hundreds of "moonquakes" are recorded each year that cannot be attributed to meteor strikes. In November, 1958, Soviet astronomer **Nikolay A. Kozyrev** of the Crimean Astrophysical Observatory photographed a gaseous eruption of the moon near the crater Alphonsus. He also detected a reddish glow that lasted for about an hour. In 1963, astronomers at the Lowell Observatory also saw reddish glows on the crests of ridges in the Aristarchus region. These observations have proved to be precisely identical and periodical, repeating themselves as the moon moves closer to the Earth. These are probably not natural phenomena.

**9. Hollow Moon:** The moon's mean density is  $3.34 \text{ gm/cm}^3$  (3.34 times an equal volume of water) whereas the Earth's is 5.5. What does this mean? In 1962, NASA scientist **Dr. Gordon MacDonald** stated,

"If the astronomical data are reduced, it is found that the data require that the interior of the moon is more like a hollow than a homogeneous sphere."

Nobel chemist **Dr. Harold Urey** suggested the moon's reduced density is because of large areas inside the moon where is "simply a cavity."

MIT's **Dr. Sean C. Solomon** wrote,

"the Lunar Orbiter experiments vastly improved our knowledge of the moon's gravitational field... indicating the frightening possibility that the moon might be hollow."

In **Carl Sagan's** treatise, *Intelligent Life in the Universe*, the famous astronomer stated, "A natural satellite cannot be a hollow object."

**10. Moon Echoes:** On November 20, 1969, the Apollo 12 crew jettisoned the lunar module ascent stage causing it to crash onto the moon. The LM's impact (about 40 miles from the Apollo 12 landing site) created an artificial moonquake with startling characteristics—the moon reverberated like a bell for more than an hour.

This phenomenon was repeated with Apollo 13 (intentionally commanding the third stage to impact the moon), with even more startling results. Seismic instruments recorded that the reverberations lasted for three hours and twenty minutes and traveled to a depth of twenty-five miles, leading to the conclusion that the moon has an unusually light—or even no—core.

**11. Unusual Metals:** The moon's crust is much harder than presumed. Remember the extreme difficulty the astronauts encountered when they tried to drill into the maria? Surprise! The maria is composed primarily illeminite, a mineral containing large amounts of titanium, the same metal used to fabricate the hulls of deep-diving submarines and the skin of the SR-71 "Blackbird". Uranium 236 and neptunium 237 (elements not found in nature on Earth) were discovered in lunar rocks, as were rustproof iron particles.

**12. Moon's Origin:** Before the astronauts' moon rocks conclusively disproved the theory, the moon was believed to have originated when a chunk of Earth broke off eons ago (who knows from where?). Another theory was that the moon was created from leftover "space dust" remaining after the Earth was created. Analysis of the composition of moon rocks disproved this theory also.

Another popular theory is that the moon was somehow "captured" by the Earth's gravitational attraction. But no evidence exists to support this theory. Isaac Asimov, stated,

"It's too big to have been captured by the Earth. The chances of such a capture having been effected and the moon then having taken up nearly circular orbit around our Earth are too small to make such an eventuality credible."

**13. Weird Orbit:** Our moon is the only moon in the solar system that has a stationary, near-perfect circular orbit. Stranger still, the moon's center of mass is about 6000 feet closer to the Earth than its geometric center (which should cause wobbling), but the moon's bulge is on the far side of the moon, away from the Earth. "Something" had to put the moon in orbit with its precise altitude, course, and speed.

**14. Moon Diameter:** How does one explain the "coincidence" that the moon is just the right distance, coupled with just the right diameter, to completely cover the sun during an eclipse? Again, Isaac Asimov responds,

"There is no astronomical reason why the moon and the sun should fit so well. It is the sheerest of coincidences, and only the Earth among all the planets is blessed in this fashion."

**15. Spaceship Moon:** As outrageous as the *Moon-Is-a-Spaceship Theory* is, all of the above items are resolved if one assumes that the moon is a gigantic extraterrestrial craft, brought here eons ago by intelligent beings. This is the only theory that is supported by all of the data, and there are no data that contradict this theory.

Greek authors **Aristotle** and **Plutarch**, and Roman authors **Apollonius Rhodius** and **Ovid** all wrote of a group of people called the Proselenes who lived in the central mountainous area of Greece called Arcadia. The *Proselenes* claimed title to this area because their forebears were there "before there was a moon in the heavens."

This claim is substantiated by symbols on the wall of the [Courtyard of Kalasasaya, near the city of Tiahuanaco](#), Bolivia, which record that the moon came into orbit around the Earth between 11,500 and 13, 000 years ago, long before recorded history.

**1. Ages of Flashes:** Aristarchus, Plato, Eratosthenes, Biela, Rabbi Levi, and Posidonius all reported anomalous lights on the moon. NASA, one year before the first lunar landing, reported 570+ lights and flashes were observed on the moon from 1540 to 1967.

**2. Operation Moon Blink:** NASA's *Operation Moon Blink* detected 28 lunar events in a relatively short period of time.

**3. Lunar Bridge:** On July 29, 1953, **John J. O'Neill** observed a 12-mile-long bridge straddling the crater Mare Crisium. In August, British astronomer **Dr. H.P. Wilkens** verified its presence,

"It looks artificial. It's almost incredible that such a thing could have been formed in the first instance, or if it was formed, could have lasted during the ages in which the moon has been in existence."

**4. The Shard:** The Shard, an *obelisk-shaped object* that towers 1½ miles from the Ukert area of the moon's surface, was discovered by Orbiter 3 in 1968. **Dr. Bruce Cornet**, who studied the amazing photographs, stated,

"No known natural process can explain such a structure."

**5. The Tower:** One of the most curious features ever photographed on the Lunar surface (Lunar Orbiter photograph III-84M) is an amazing spire that rises more than 5 miles from the Sinus Medii region of the lunar surface.

**6. The Obelisks:** Lunar Orbiter II took several photographs in November 1966 that showed several obelisks, one of which was more than 150 feet tall.

" . . . the spires were arranged in precisely the same way as the apices of the three great pyramids."

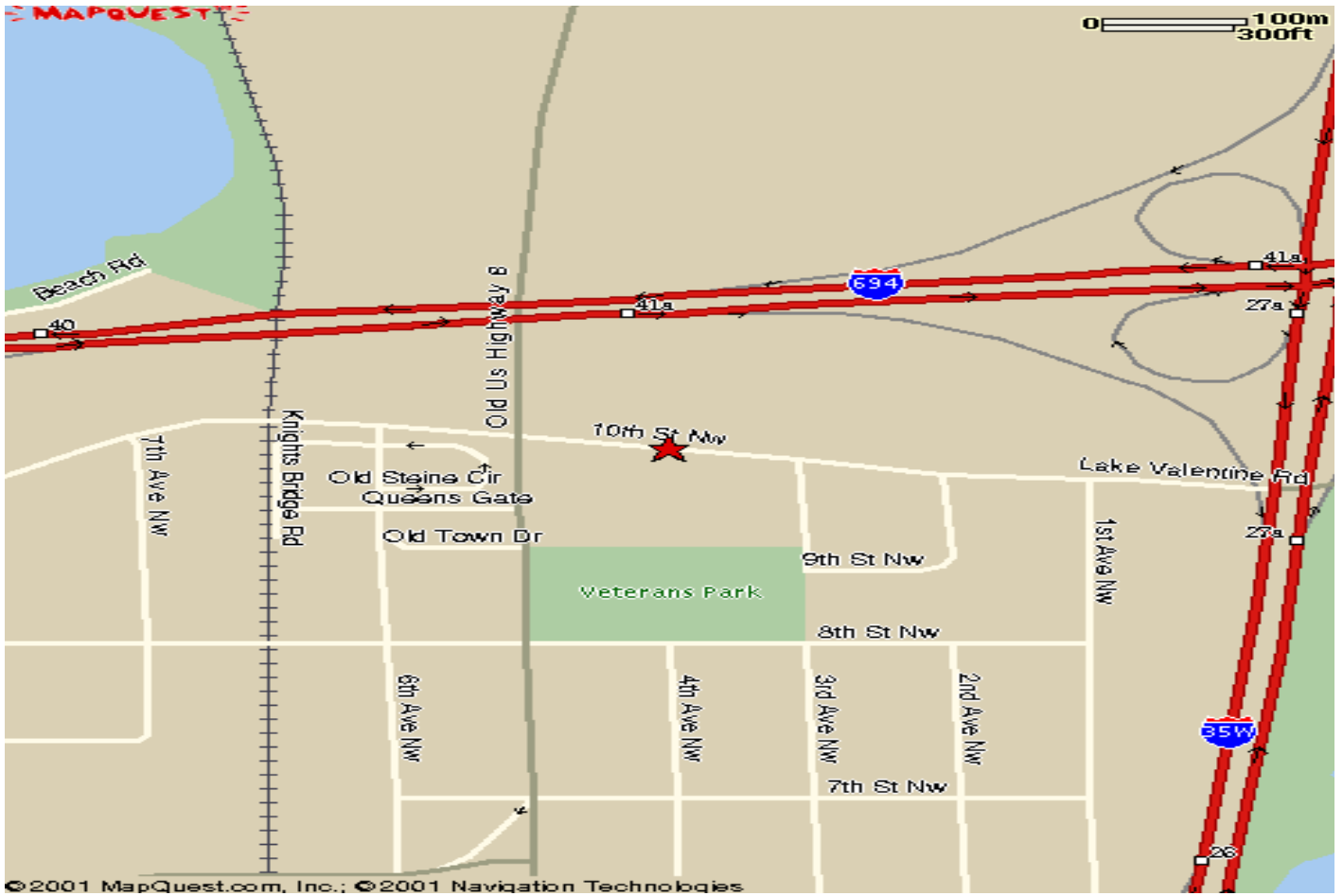
