Intriguing anomalies are everywhere. If you keep your eyes open, you can notice them every day. Synchronicities, events that seem to defy explanation, dreams that come true - these are a few of the little (or sometimes not so little) events that remind us there is more to reality than we understand.

A few days ago during a meditation circle, we noticed an interesting little mystery. The circle was led by a friend of mine, a psychologist who also teaches meditation, mindfulness, etc. Prior to the start of the circle, she had a background music CD playing. Then, during the meditation itself, she played a guided imagery recording of a lake with a sunset, waves on the shore, etc. - with trance music in the background. She began the meditation by ringing a small pair of finger bells before starting the CD. At that point, she set them down on the table, started the CD and we began the meditation.

After a few minutes the guided imagery was concluded and she turned off the CD. I found the moment to be one of unusually deep meditation, but soon it was time to come back to the physical world. We heard the "ding" of the bell once again as our eyes opened. Everything was great except there was one little mystery - she wasn't holding the bells. They were still sitting on the table, motionless and silent.

Curious, we checked a number of possibilities. The CD player was indeed off. I don't think anyone else had their cell phones on, or had ring tones that sounded like these particular bells (I do have a meditation timer on my cell phone with a chime that sounds somewhat similar, but not identical). Furthermore, the second dinging sound definitely came from the same location as the first. So it remains an open question - where did the bell sound come from? Who rang the bell?

I love these little anomalies - not quite miracles, not quite magic, not quite explainable within our rational understanding of the world. Yet they happen. To me, they suggest that there is simply more to the fabric of reality than we understand.

Some time ago, when I was interviewing an experiencer (I will call her Sarah), she told me the story of when she and a friend/coworker (whom I will call Nancy) were staying in a hotel during a business trip. The hotel was reputed to be haunted and the "extra resident" had a reputation of being protective of female guests. But he was also a bit of a prankster.

*While Sarah was in the shower, her roommate stepped out to take care of some errands. A few moments later, as Sarah was stepping out of the shower, she heard movement just outside the bathroom door. She assumed Nancy had returned, and said something through the bathroom door. There was no response. A short time afterward, when she emerged from the bathroom, she found no one else present. For a moment, she assumed Nancy had simply stopped back to pick up something she had forgotten. But then she noticed the door - the chain lock had been set.*

A few moments of thought will clarify that this is truly an anomaly. While no one else was present, and Sarah was in the shower, Nancy had left. Yet one cannot lock a chain lock from the outside. It can only be locked from the inside. So - who locked the chain lock?

Other anomalies abound, and I suspect many of us have our own stories. As I interview experiencers and their families, I often ask if they have had any other unusual events in their lives, or their family history. I am often rewarded with accounts of fascinating synchronicities, precognitions, or other anomalies. In [The Cosmic Bridge](#), I talk about some of these reality anomalies and include a story of how "Evelyn," during the return stages of one abduction event, watched the UFO depart from in front of her home. She distinctly recalled the window being open slightly as she watched the object rise out of sight. Yet, when I looked at the window, I found it did not open or close. It was a solid pane of glass.

What do events like these tell us about the reality we live in? Assuming there is not some as-yet-overlooked explanation short of the extraordinary, they suggest our world has aspects to it that somehow defy logical explanation. Who rang the bell in our meditation circle? Was there some reality overlay in which the bell was both rung and not rung? Was there some interaction between the physical and metaphysical world that allowed a dream-like event (or sound) to occur? What allowed

a window to be both opened and fixed shut, or a chain lock to be both put into place and not put into place?

In the theories of Carl Jung, there is a continuity between the purely physical and the purely mental world - what he called a psychoid reality. In quantum physics, when a measurement occurs a choice is made between different possible quantum states. Thus one or another potential path through space-time is chosen while others are not. The paths not chosen are known as the counterfactuals.

In the Many-Worlds interpretation of quantum physics, when a choice is made, the universe actually divides into separate and distinct timelines, one in which the particular choice is made and other worlds we do not perceive in which a different choice occurred. And thus we can ask, could there be some interaction between these worlds? Could some form of meta-reality still be connecting the possible universes? These all suggest deeper, intriguing layers to the fabric of reality.

Little mysteries are one of the truly fun aspects of anomaly research. Beyond dealing with the sometimes-frightening accounts of alien abduction and their attendant post-traumatic effects, I find it both fascinating and pleasant to notice these little anomalies. They stretch and tear at our reality. They prompt us to question our standard (post)Newtonian view of the world and our belief in rational cause and effect. They make us ask whether there is more to our universe than we do (or even can) understand - and they force us to ask ultimate questions like....

"Who rang the bell?"

Hate to be a pedantic nag, especially because [the detailed first-person piece written by airline captain Andrew Danziger](#) for the New York Daily News last week was pleasantly surprising in its fearlessness. Getting a commercial pilot to go on record with a job-related UFO encounter in this country is like finding someone to admit they take baseball bats to baby harp seals in order to make underwear.

As we know, plenty of other countries, from France to Uruguay, encourage aviators to openly log UFO

incidents because, well, it only makes sense, given the potential risk to flight safety. But here in the U.S., we have this thing called exceptionalism. That means a former NASA scientist like Dr. Richard Haines has to acquire that sort of data by extending the sanctuary of anonymity — i.e., the [National Aviation Reporting Center on Anomalous Phenomena](#) — to pilots afraid of losing their jobs for telling the truth. What is it with this country, anyway? We label our money “In God We Trust,” which sounds sardonic, if not outright blasphemous. But God doesn’t even leave radar tracks behind for us to verify.

Anyhow, last week, Danziger bucked the trend in a big way and went public with his extended in-flight encounter with an apparent shape-shifting bogey outside Kansas City. Granted, the incident occurred in 1989 — “early in my career,” wrote Danziger, who appears to be nearing retirement — and his confession couldn’t possibly put his then-employer in a jam at this point because Air Midwest folded in 2008. What added a little more heft to Danziger’s testimony was the fact that he was deemed competent enough to ferry candidate Barack Obama during his first presidential campaign.

Clearly, NARCAP’s Haines hopes Danziger’s testimony could be a momentum-builder. “His account, if it is accurate, should help keep the flame under this pot of coffee at least warm, which is important,” states Haines in an email. After all, NARCAP studies of pilot encounters with what he calls unidentified aerial phenomena suggest a catastrophe is just one abrupt over-correction away. “We should not allow the pot to grow cold,” Haines continues, “or else new pilots coming on the scene may think there is absolutely nothing to worry about or at least to be prepared for. I see a lot of normalcy bias here....”

So good on Captain Danziger for whatever mitigation his story may have on the UFO stigma. And it’d be great to thank the Daily News for playing it straight. If only.

Here’s how Danziger concluded his piece: “More than a few pilots have shared their UFO stories with me, too. I’m not going too far out on a ledge to say that virtually all pilots believe in UFOs. Little green men, ‘close encounters,’ alien kidnappings, not so much, but with billions of stars and trillions of planets out there, ‘ya gotta believe,’ and almost all of us do.”

Unfortunately, the editors couldn’t leave well enough alone. They inserted a little green man illustration into Danziger’s story with this simple cutline: “Many pilots believe in little green men, Captain Andy said.” Well, no, that’s not what he said. Try to imagine President Obama writing in an op-ed, “We are not going to bomb Iran,” and the editors decide to run an illustration of Tehran in flames above the cutline: “We are going to bomb Iran, President Obama said.” At a minimum, the dingbat who made that call would’ve gotten his/her eardrums scalded and blistered for that little stunt, and there would’ve been a correction.

It’s a small thing. But this issue has been trampled beneath the weight of countless small things. Proving, once again, that when the subject is UFOs, [as the corporate media proved once more in January](#) with its epic fail on the digitization of the ancient Project Blue Book files, you can get it wrong forever and there will never be consequences.

## UFOs DEEMED DEMONIC PART VII

Due to the huge paradigm shift within society in the 2nd half of the 20th Century due to technology UFO’s took an interplanetary explanation. Perhaps that label was closer to the truth. “Creatures” allegedly used by Secretary of State, Cordell Hull when he referred to the alien appearing cadaver that was reported kept hidden in an underground facility below the White House circa 1938 according to a close friend who grew up with Cordell Hull and then became a pastor.

### Stage of history set

However, in 1938 with Nazi Germany gaining momentum in Europe and a vague footing of war beginning to materialize, and with Japan already invading Manchuria as the Chinese Emperor’s infiltrated government refused to retaliate, little could anyone have guess what would happen by 1942. As the secretive military expedition made its way from Los Alamos to the Dulce, New Mexico

area. A monumental confrontation would soon take place according to Anthony Sanchez, but was this incident properly interpreted by either the powers that be at the time or author Anthony Sanchez himself?

### **Reality or myth?**

Admittedly, even Sanchez acknowledged that the invaders had coexisted with man since primitive times centuries earlier with only a cover story that they had evacuated their devastated planet to seek asylum on earth even though they were not well suited to our atmosphere and degree of solar radiation, necessitating their underground preference. So the story goes. Yet, the story does not seem to support the actions of an extraterrestrial race that although technically superior, chose to inhabit the underworld instead of the surface of the planet as did the cannibalistic Morlocks who existed underground in the H. G. Wells science fiction classic "The Time Machine".

### **Grim parallel**

Strangely, there is a bizarre correlation between the Morlocks of the H.G.Wells classic novel and the relationship between the unsuspecting human population and the underground creatures who partook in cattle mutilations by night, abducted humans nocturnally, and even openly assaulted people in larger groups when such actions became unavoidable. The 1942 expedition to the Archuleta Mesa was one of those occasions where open hostility became unavoidable. So, as the first elements of the secret elite unit began to arrive in the area, reconnaissance revealed that indeed rumored underground caverns did indeed exist. orders were quickly given to penetrate the unknown.

### **Intriguing place**

At first foot soldiers who had uncovered the access point under direction of their commanding officer began a slow systematic probe of the caverns. The upper levels proved astonishing in many respects. Evidence of a terrific battle that had taken place decades before seemed evident, but along with this revelation came other fantastic discoveries. Once the complexity of the find was determined, the commanding officer radioed his findings and more experts were ordered in to help decipher the combination of bizarre elements being uncovered by the soldiers.

### **First impressions**

The upper level appeared to have been the scene of a bloody skirmish that had resulted in the deaths of many on both sides. Apparently Native American warriors had raided the caves armed with repeating rifles, six guns, spears, and arrows. Scorching from blasts were evident on the walls of the cavern. Bodies lay strewn on the floors, Weapons of old made for familiar artifacts but there also puzzling devices that appeared to be from an arsenal of some kind, but they were not recognizable. What was supposed to have been a exploration had now become a combination archeological effort as well as a forensics investigation. The commanding officer knowing he was out of his depth had requested specialists to examine what had been found.

This unexpected aspect added to the expeditionary force slowed down the probing into the depths of the caverns and preoccupied the troops with collection of artifacts, labeling, containerizing, and transporting the findings onto the surface where trucks and jeeps had been brought in to ship the contents to proper facilities for examination. Days turned into weeks and a slow progress was made moving deeper into the caverns.

### **Who were they?**

After collecting the forensic evidence of a battle that had preceded the turn of the century in all likelihood, forward scouts began a deeper descent in earnest. At first there were brief and sporadic sightings of diminutive figures peering at the GI's (General Infantryman) from behind corners. The men quickly realized they were not alone, but who indeed had they happened upon? The decomposed bodies of large heads and small torsos were unrecognizable and had been collected, embalmed, and packaged for further study elsewhere, but now there were the living creatures that made their presence vaguely known as they retreated further down the long dark corridors.

### **Advanced technology**

The expeditionary troops soon realized the cavern walls had transformed into a finished surface not unlike cement, but of a finer type of material. Gone was the rocky natural surface. As they walked along inspecting the bizarre interior of the underground mesa they encountered instrumentality they did not recognize. According to author, Anthony Sanchez, it was the thin flat panel screens and monitors that we are familiar with today only fabricated by another civilization decades before we had manufactured this technology. Unbeknownst to the

curious soldiers who squinted at technology they thought was German in origin, they were being watched through the very devices they did not understand.

### **A changing trail**

Further down into the caverns it appeared that the rocky walls had been lined with some kind of strange paneling. There was a change in the atmosphere as a terrible smell was present along with a dank mustiness that made the men sweaty and uncomfortable. This began taking a toll on the men assigned physical labor as the artifacts were being lifted, carried, and moved to the surface. Once it was reported that there was an unknown presence in the caverns, the officer in charge made sure all men were armed and prepared for possible action. Forward scouts ordered deeper into the caverns were now on alert and heavily armed. At that time they had no ground penetrating radar or geologic analysis of the area. They had no idea how deep the caves would go.

### **Further into hell**

The further the scouts probed the more hot and noxious it seemed the air became. it was becoming more difficult for the men to tolerate the adverse conditions. Some men could no longer psychologically handle the underground conditions and were assigned topside duties. Tension and morbid expectation came to a head when two of the furthest forward scouts ran into what looked like adjacent rooms with several frightening entities within. As they quietly crept to a vantage point so they could spy on the strange congregation, a handgun fell from one man's holster making an echoish metallic sound as it hit the stone floor.

### **One deadly mistake**

Almost immediately the tense silence was drowned out by the savage reaction of the beings as they rushed out after the men. Before the soldier could grab his Model 1914 and begin firing he was overwhelmed! The other soldier could hear the man's anguished screams from behind him as he sprinted through the caves toward his comrades with the creatures in hot pursuit! The commotion had begun so deep in the caverns that it had not been heard by the main body of the military unit. The soldier continued to run, gasping for breath in the foul smelling air as he tried to put distance between himself and the fiends who had surged over his buddy and were now after him.

### **The fight breaks out**

As he drew closer to his comrades nearly at the end of his endurance, the soldier screamed to the main body of infantry and fired his handgun into the air! Suddenly, the soldiers found themselves face to face with entities they had not thought of as vicious and hostile that were now upon them. These were elite troops, however, trained to respond in every kind of condition and they did! Although surprised at first they responded. The creatures who had swarmed upon the one scout who had blundered deeper down the cavern had not been confronted by a sophisticated form of resistance they were apparently not prepared for! fifty caliber machine guns, M-1 rifles, and automatic handguns were pumped into the ghastly entities that had charged at the expeditionary troops.

### **The nightmarish fight**

Muzzle flashes lit up the dim caverns as the savage firefight raged on. it was clear that these entities were unaccustomed to the weaponry deployed by the elite infantry selected for the mission. Previously they had tasted the sting of Colt 45's and Henry rifles at the hands of the Apaches who had fought them earlier, but these were well trained soldiers with the most devastating arms issued to any infantry in the world! Even though they fought viciously the creatures succumbed to the concentrated might of US Army issued firepower. During the deadly skirmish some of the advanced weapons of the creatures had been leveled at the troops and these were the ones that had scorched the walls of the upper levels decades before during the battle with the Indian warriors! This did not turn the tide of the battle. What remained of the creatures retreated deeper into the caverns in the wake of the bloody fight.

In the aftermath of the battle, medics were faced with treating wounds they had never seen or been trained to treat. Burns originating from blasts that had been projected by an unknown type of weapon. Lung ailments had also befallen many of the soldiers due to exposure to the submerged cavernous environment. The medical reports were just about as disturbing as everything else reported from the Archuleta Mesa expedition.

### **The inhabitants**

Author Anthony Sanchez claims that after the initial battle reports sent to Washington from accounts given by the commanding officer on site orders, were submitted to wipe out the rest of the "inhabitants" as they were called. The federal government and US military command had no idea



who was down there in the Archuleta Mesa caverns, but the area was of significant strategic value and efforts toward weaponizing nuclear research were being delayed!

### **Pandora's Box**

In his book "The Day After Roswell" Philip J. Corso, author and former US Army intelligence officer wondered if the supposed crash of the alien disk 75 miles northwest of the 509th Army Airfield was not indeed an intentional seed that had been planted. Had the Roswell wreckage been nothing more than the introduction to mankind of a rapid technological ascent designed to hasten a destructive cold war that would escalate into a third global conflict rife with famine, plague, and pestilence? The designs of evil and godlessness are persistent and all consuming as the government, our media, and Hollywood all play a role in the separation of Church and State, secular humanism, and the attacks on decency that have made our world a continuing arena of terrorism and social unrest.

### **Outer or inner space**

The question remains. Who were those inhabitants who would again emerge years later in 1979 when tunneling operations in the vicinity unearthed another savage confrontation with the "Inhabitants". Were they really aliens from another planet who had decided to remain underground in a noxious environment or were they the same evil entities that have plagued man since the very beginning in a spiritual war of good and evil that any of us cannot afford to lose because it all has to do with the disposition of our very souls.

### **Final thought**

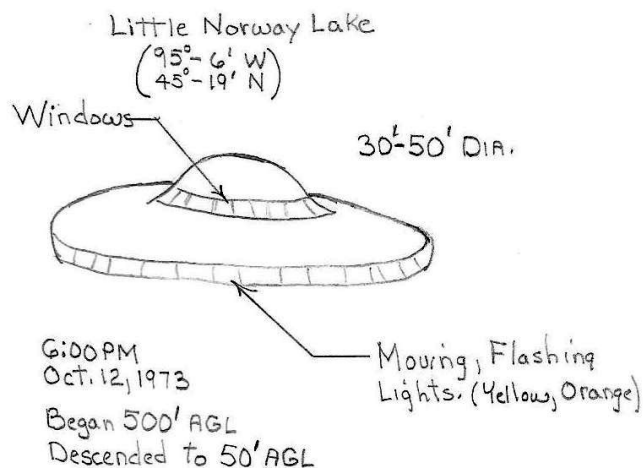

### **KANDIYOHI COUNTY REPORT**

## **FROM 1973 Investigation Report by Preston Mattke**

The following is from the Field Investigation Report in the MUFON Case Management System (CMS) on a sighting that took place on Oct. 12, 1973. It has been slightly edited for clarity and to protect confidentiality of the witnesses. -- William McNeff  
These notes are attached on 2/16/15 by MN State Section #3 Director, Preston Mattke. A face to face interview was completed with witnesses of this report on Feb. 12, 2015, at their residence in Willmar, MN, at 3:00PM. The witnesses, Mr. R. \_\_\_\_\_ and wife K. \_\_\_\_\_ are retired and in good health at this time. R. is a former US Navy veteran and a retired Union Construction worker and Medical Cardio Management operative.

Both presented a very credible source for the information presented in this sighting report. The sighting took place while they were present inside their lake home while peering through the picture window of this home as it faced west looking out over Little Norway Lake in Kandiyohi County of Mn. Location of this lake is at 95 degrees 6 minutes West & 45 degrees 19 Minutes N. The witnesses collaborated on a sketch of the suspended craft they saw which is attached below. The following notes are additional clarification of their sighting as was told to me at this interview.



1. Their son was the first to spot the floating craft as it entered the viewing area of the picture window from the north. At that time, the lad was just 6 years old and his name was S.. He was not available for questioning and the witnesses indicated his disinterest in being part of this interview. As it entered from the north at an altitude of an estimated 500 ft. AGL, it was

traveling from right to left and descending as it approached their location.

2. As the craft reached their home sight which was situated on a hill overlooking the lake at an elevation of some 15 to 20 feet above the water line, it paused in front of them for about a duration of 15 to 20 seconds. It had now descended to an elevation of about 50 ft. above the water line and some 150 to 200 yards out from their sight.

3. At this point only R. and his son S. were viewing the hovering craft but all the excitement brought K. into a viewing position as well. She indicated becoming very alarmed and decided to close down the viewing moment immediately by pulling the curtains while R. was going for his camera. No pic was ever made.

4. When R. returned he peeked around the curtain to see the craft accelerating rapidly back to the north or upper right at an angle of some 45 degrees and simply vanished from sight.

5. That ended their recollections of this experience with no noise or odors noticed. No evidence was left behind.

6. K. indicated that the craft showed a continuous band of flashing yellow-orange lights around its base as the craft floated during its entire visible time.

7. R. indicated that he had called the Willmar airport to see if any planes had been noted in their area on this day but a got a negative response to this questioning. The Willmar police dept. was also called but had nothing to add.

8. When asked if anything else has happened to them following this event, they replied seeing another mysterious hovering glowing white light the next night within one half mile of their residence hovering over the trees bordering the lake shore to their north. It made no movement and hovered there for some time and then simply vanished.

9. No additional information was collected on this sighting. It is concluded to be an Unidentified Aerial Vehicle.

Joe Swenson - A Day Trip to Mars:  
Nuts and Bolts of UFOs**

"I started researching man made UFO's at age 13 when I heard an engineer, a pilot, and an attorney discussing the ones they saw," says Joe Swenson, MUFON speaker for June 13, 2015. 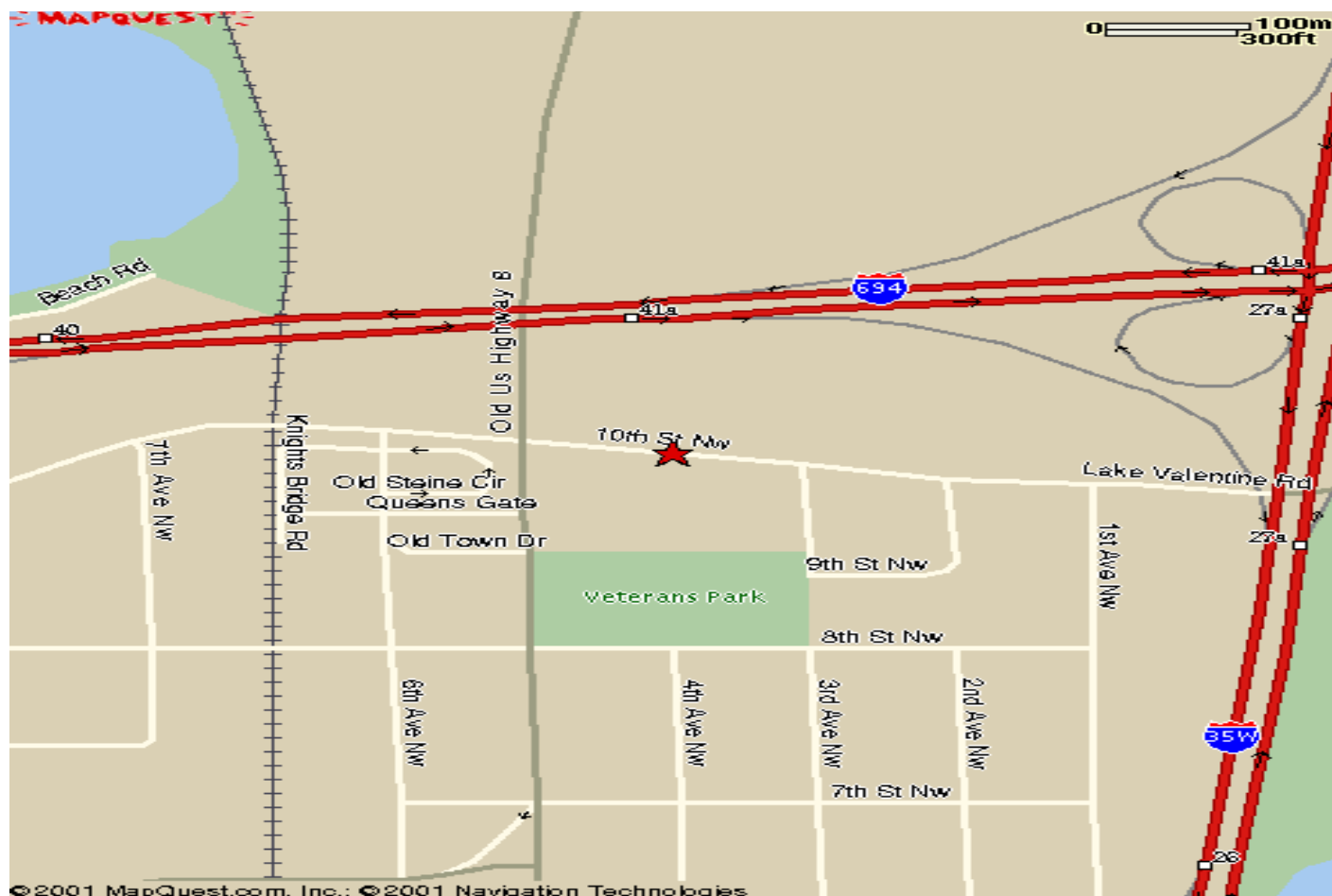
