July/August, 2015 – Sharing a lonely burden

A few nights ago, I got another one of those late night calls from out of the blue. This time the caller (I will call her 'Jane from Kansas') told me she had had a lifetime of experiences. Most recently, she had had a few really frightening experiences late at night. They had begun to give her serious nightmares, preventing her from sleeping enough, and it was beginning to imperil her job.

Jane lived in a very socially conservative community. Her friends were mostly Baptist and Pentecostal Christians. Her family was equally as conservative and as a result, she had never been able to say much about her experiences to the people in her community. The few times she had tried to tell someone - including her minister - they recommended that she have an exorcism done. She was obviously possessed by an evil spirit. As a result, she carried in lonely silence her burden of contact with - well, with who/whatever is contacting us.

Surveys and polls taken over the years [such as the Roper Poll of Extraordinary Experiences] have suggested that somewhere around one person in 100 have encountered the UFO and/or close encounter phenomenon in sufficient degree they could be considered an experiencer. The phenomenon affects life in a multitude of ways, from shattering daily reality to driving a wedge between the experiencer and those closest to him/her. They carry their story like a weight, unable to share it with anyone. The result can be a sense of isolation, bearing their secret "other life" on their own shoulders, and it once again brings up the topic in my mind – how to help the experiencer realize that 'you are not alone.'

We have received reports from many close encounter experiencers over the years who had only recently found out about MUFON. Prior to that, they had no idea who they could confide in and who would take their narrative seriously. In the segment of society in which many experiencers live, it can sometimes be nearly impossible to find 'someone who will believe me.'

Many of the experiencers who call me, often out of blue after having found my name and number on a website somewhere (such as [www.abduct.com](http://www.abduct.com)), tell me how they feel alone and isolated. If they confide in someone close to them, it will more often than not stretch the confidant's belief systems beyond the breaking point, in some cases, the confidant to turn away from the relationship. In some cases, I am the first person who has ever listened to them without ridiculing them,

telling them they were possessed by the devil, urging them to see the doctor for their delusions, or some other non-useful response.

So who is that kindred spirit? How can one know who to trust? How can the experiencer find the right confidant? Here are some suggestions I can offer to help ease the burden, just a little bit. It may be a way to test the waters, using your own discernment to learn who you can and cannot trust.

1) Test the waters with a person you may want to confide in. Try mentioning topics like space exploration, astronomy, etc. - things that are not too paradigm bending, but which trend toward the extraordinary. See where that leads. If a discussion ensues then at least the person is open to leading edge topics in science.

2) If the person is open to topics such as ET life (and intelligence), then offer a little more - maybe a comment about UFOs or (hypothetical) alien contact. This is television shows such as Hangar 1 and Ancient Aliens have been truly invaluable. It brings up an avenue by which experiencers can bring up the topic in general conversation. They can talk about what they saw on the show and offer the other person a chance to engage in the topic. When this happens, carefully note the reaction of the other person. How comfortable (and how curious) do they seem. Do they want more?

3) If the person is receptive, then gradually let a little more information out, as long as the person is (and remains) supportive and receptive. If it looks like the person's reality is being stretched too thin, stop(!!!). It's time break off for a while.

4) If the person is truly open to the extraordinary, this will become apparent along the way. If the person really is a kindred spirit, that too will become apparent. If, and only if, that rapport is reached, would it be advisable to let the other person know what you have been undergoing all this time.

The lesson I take from this is that it is important to tell someone, yet it is just as important to make sure that person can be trusted, and is not overloaded. The isolation has always been there. Only now are we beginning to see how extensive it really is, and how it can also be broken. And ultimately, the most important lesson of all is that you are not alone.

## **FORMER ASTRONAUT ADMITS TO ALIEN VISITATIONS**

A former NASA astronaut who has walked on the moon has said aliens are not only real but have visited Earth several times. Dr Edgar Mitchell, said he was aware of several UFO visits during his career, but each one had been covered up.

The 77-year-old, who was a crew member of the Apollo 14 mission, said sources at the space agency had described aliens as resembling "little people who look strange to us" Dr Mitchell told Kerrang! Radio that human technology was "not nearly as sophisticated" as theirs and had they been hostile, he warned: "We would be been gone by now". He said: "There's not much question at all that there's life throughout the universe, we are not alone at all. I'm most assured about that. "Have we been able to identify where the other planets are? No, certainly not in our Solar System but we have been able to identify quite a number of planets that could be life bearing planets. "I happen to have been privileged enough to be in on the fact that we've been visited on this planet and the UFO phenomena is real. "It's been well covered up by all our governments for the last 60 years or so, but slowly it's leaked out and some of us have been privileged to have been briefed on some of it. "I've been in military and intelligence circles, who know that beneath the surface of what has been public knowledge, yes we have been visited. "Reading the papers recently, it's been happening quite a bit."

Dr Mitchell, along with Apollo 14 Commander Alan Shepard, still holds the record for the longest ever moon-walking session at nine hours and 17 minutes following their 1971 mission. Officials from NASA, were quick to play the comments down. In a statement, a spokesman said: "NASA does not track UFOs. NASA is not involved in any sort of cover up about alien life on this planet or anywhere in the universe. "Dr Mitchell is a great American, but we do not share his opinions on this issue."

**COMMENTS ON ARTICLE BY LARRY

The July 2015 issue of the MUFON UFO JOURNAL contained an excellent article by Larry Cates, B.S. Mathematics and member of the MUFON Science Review Board. It presents many theses that are a good starting point for further thought. Quoting the first three paragraphs:

“ET has not remained at the other end of the telescope. They are right here in our own backyard. We are facing an intrusion of unknown entities whose only kinship with us is intelligence and self-awareness.”\*

“We have lost the protective cocoon of massive distances and with it, superior knowledge of physics, mastery of this world as well as mastery of the universe even if it was empty. Our central place in this universe continues to erode in a manner inversely proportional to our knowledge of it.”

“We are not top dog anymore.”

This is surely true. But we never were “top dog”. Merely by the Laws of Probability, the likelihood that there were no creatures out there in the cosmos that were more intelligent, rational and moral than we are, was, thankfully, always small. Besides, if there is a God, they are not at the top of the heap either. God is, by definition. (Based on my 82 years of life experience, I believe there is a God, but that is another, long, story.) I fervently hope there are some beings out there who are more moral than we are.

Cates proceeds to quote an article in the British Interplanetary Society by Deardorff, Haisch, Maccabee and Puthoff in which they wonder whether a program of gradual disclosure by ET, a “leaky embargo” is underway. Cates quotes Stanton Friedman as believing that ET is here to enforce a quarantine.

So what is it – leaky embargo or quarantine? I don’t think the two are mutually exclusive, and I suspect that both are true. Cates expects humans to have difficulty getting out into the cosmos, and I agree with him. He points out that interference by ET with our space exploration ventures will probably be undetectable by us. We would probably attribute failures to such things as dried-

up funding and stupidity. He didn’t mention technical “glitches”, something we were reminded of just the other day as Chinese and U.S. stock exchanges and an airline suffered the same.

Cates says say goodbye to “where no man has gone before”. He should have said “where no one has gone before”. The ladies won’t be able to get there either. Unless we have already gotten there – there are persistent rumors that we have already gone to Mars and that the Martians wisely avoided contact with us! There are also rumors that our government and other governments have been dealing with ET. No less a source than Edgar Mitchell says that he knows an individual who in the course of his official duties, met with an extraterrestrial.

Cates points out that ET seems to have been sending us messages signaling disapproval of our nuclear weapons, and warning us against aggression toward ETs. Frank Feschino has provided us with massive documentation of planes forced down or shot down after they tried to attack UFOs. Message received! A draftsman I worked with at Control Data told me that he was manning a Nike missile battery in the Twin City area when a UFO was sighted. The crew raised the missiles up and requested permission from higher headquarters to fire. They were emphatically told no to fire and were soundly “cussed out”. Either HQ had “gotten the message” or was concerned about ground casualties, or both. I suspect both.

With a reported 80 plus races involved in near Earth activity, we could expect a number of different goals and purposes. Various sources tell us there is a “galactic federation”. Such a federation could be expected to have protocols for dealing with primitive inhabitants of new planets. There are also rumors of some races who operate outside of federation guidelines. “Reptilians” are rumored to be such a race.

With regard to our relationship with ETs, Cates says it appears we will have plenty of time to get our global act together. I suspect that is true with respect to ETs. But in the meantime, we are polluting our planet at a dangerous, unsustainable rate – that is, a rate at which it may be very difficult to sustain ourselves. Cates suspects earthly leadership will do something really stupid. I think the pollution and the current saber-rattling shows that we are already doing some stupid things. It is time for a change.

### Talking the walk ...

Don't know about you, but I'm loving those mystery lights on Ceres as NASA's surveillance probe, Dawn, bears down on the biggest chunk of real estate in the asteroid belt. And not because of the prospects for discovering alien activity – they're remote, at best – but because of the opportunity to witness, again, the ritual disconnect that characterizes institutional science whenever The Great Taboo legitimately insinuates itself into a news cycle.

Let's go back a few years when, after half a century of logging zilch in the Great ET Radio Signal Experiment, SETI pioneer Jill Tarter proposed a new name for their endeavors, the Search for Extraterrestrial Technology (SETT). This was a tacit grudging concession that maybe radio astronomers had been working with a flawed model. In 2011, [the International Journal of Astrobiology published a paper by astrophysicists Martin Elvis and Duncan Forgan](#) proposing an even more specific tack, that maybe Earthlings ought to consider scanning the asteroid belt for evidence of ET “macro-engineering projects.” Translation: mining operations. Made sense. After all, they noted, asteroids are repositories for raw material like gold, platinum and silver, the kind of stuff you'd likely need to repair or refuel extended planetary missions.

And, [as Forgan would hypothesize two years later in the IJA](#), ET wouldn't even have to bend the known laws of physics to reach the rocky debris zone between Jupiter and Mars, no matter which part of the Milky Way he/she/it came from. Upon crunching the numbers, Forgan and a mathematician hypothesized that robotic technologies could have mapped this galaxy well below light speeds, in about 10 million years. On the cosmic scale of time, that's no big deal.

So here's what's going on. In 2007, NASA hurls an unmanned vehicle toward the asteroid belt to look for clues to the formation of our solar system. Destination: “dwarf planets” Vesta and Ceres. Dawn enters a 14-month mapping orbit over Vesta in 2011, then moves on toward the bigger prize. In February, as it closes to within 29,000 miles of Ceres, Dawn's cameras detect something totally off the charts – lights on the surface. Their luminosity doesn't appear to be significantly affected by different sun angles. Two months and 25,000 miles closer, their intensity is still unblinking. Planetary scientists are stumped; at the Jet Propulsion Lab's website, PR flacks do a very savvy thing by letting visitors vote on the most likely suspects: “volcano,” “geyser,” “salt deposit,” “ice,” “rock,” and “other.” Wonder what “other” could be. Hmm. Anyway, we'll get an even better peek by summer's end, when Dawn dips to within 900 miles of the surface. No matter what those lights are all about, this sort of suspense is cool. Talk about a teaching opportunity for schools.

Now let's review some of NASA's recent headline-grabbing statements. In 2014, given our ongoing exoplanet transiting searches and the impending

exploration of more local worlds like Europa, space agency scientists predicted Earthlings will discover ET life within 20 years. That forecast was reiterated just last week at the Astrobiology Science Conference in Chicago. In fact, NASA Associate Administrator for the Science Mission Directorate (there's a mouthful) and former astronaut John Grunsfeld suggested that ET civilizations might already have detected us, the same way we're locating and confirming the existence of deep-space planets. Quote:

"We put atmospheric signatures that guarantee someone with a large telescope 20 light years away could detect us. If there is life out there, intelligent life, they'll know we're here."

Left unsaid, what none in that sheltered crowd wants to contemplate: *And if they discover us before we discover them, maybe they're already a lot closer than we think.* But of course, there was no room in Chicago for a discussion of UFOs. That would be a little too declassé, like farting in church. Oh, and just to make sure nobody got terribly excited, [coverage of last week's Windy City pow-wow](#) also included a canned statement from NASA chief scientist Ellen Stefan. In April, during a discussion about Mars, she drew distinctions between the discovery of biological life and some other silly alternative like, well, the 2011 peer-reviewed paper's "targeted asteroid mining" scenario. "We are not talking about little green men," she insisted. "We are talking about little microbes."

Stofan could've said "intelligent life." But she went for the gag line instead. Knowing full well how much everybody loves microbes.

Hey, no one wants to look like an idiot as we approach the biggest discovery of all time, wherever that may be. The solution to the Ceres lights will likely fall far short of little green men. But the language we employ as we draw closer to the inevitability doesn't inspire much confidence; it suggests we're deeply conflicted in our enthusiasm for confirming The Other. Or at least the people at the top of NASA appear to be. Fortunately, we can console ourselves with the knowledge that science and politics never mix.

## **Obama aide John Podesta Tweets he Regrets not Disclosing UFO Files February, 17 2015**

## **Could German UFO files finally reveal whether aliens have visited Earth? Court forces government to release top secret documents**

Germany's parliament has been ordered to release confidential documents about UFOs after a lengthy legal battle.

The existence of the files was disputed as recently as 2008, but a UFO enthusiast discovered evidence to the contrary and pushed for their release.

News of the impending publication has been welcomed by UFO researchers, but some fear they may not be as exciting as hoped.

The German Supreme Administrative Court in Leipzig ordered the Bundestag to make the UFO files available.

In 2008, Dr Wolfgang Schäuble, Germany's Minister of the Interior denied that the German government had ever investigated UFOs, but in 2009, a UFO enthusiast named Robert Fleischer discovered a parliamentary department had been investigating extraterrestrial objects.

A German blogger named Frank Reitemeyer took the Bundestag to court over the secret reports and the dispute has only just been resolved, The Express reported.

No date for the release of information has yet been confirmed.

UFO enthusiasts are already looking forward to March, when the UK's Ministry of Defence will make 18 confidential UFO files available in the National Archive, although there's a chance they may not be accessible by the public.

Some paranormal investigators have greeted the forthcoming German release with enthusiasm, but Nigel Watson, author of the UFO Investigation Manual, said: 'They won't reveal any secrets about hidden alien technology or alien bodies, but then again we can always hope!'

Mr Watson believes some governments hide UFO-related information to protect other secrets.

'Sometimes governments hide information like this to protect operational procedures or protect non-UFO related secrets, like the capabilities of early warning systems or the names and details of witnesses,' he said.

'In this case perhaps they don't want to show they have taken this subject seriously, or that they are as much in the dark as everyone else.'

It was only in 2005 that the British government admitted conducting a thorough scientific study into UFOs, after years of denial.

'It concluded that unidentified aerial phenomena, or UAPs, do exist, but not flying saucers,' Mr Watson said.

'When, or if the German files are released, it will be interesting to see if they come to similar conclusions.

He told MailOnline: 'I doubt it [the information] will be anything related to the recovery of crashed saucers or clandestine meetings with aliens.

'It looks like much of their material is related to the Search for Extraterrestrial Intelligence (Seti) and the implications of alien contact and whether this relates to UFO sightings in Germany.

'Then again there might be some surprises!'

Mr Reitemeyer told the Berlin Court in 2011: 'I want to know facts and it bothers me that in France, England, USA, Canada, the citizens can see the UFO files, and I am not informed as a German from my German government,' The Huffington Post reported.

Mr Watson said the move 'shows that public pressure, and the work of activists, does eventually work to get these UFO 'secrets' released by Governments.

'In Britain, it literally took decades for most of the UFO files to be released.

'The demand for UFO information is such that governments are forced to respond and the internet is the ideal medium for making this material available, taking pressure off civil servants who have to deal with requests on a daily basis.'

## Heartbreak in the UFO closet

Fleet Street is enjoying watching the Ministry of Defence squirm, again, as federal censors attempt, again, to get the UFO monkey off its back. The controversy was officially put to bed in 2013, when the UK's National Archives dumped the last of the MoD's reports into the public domain. That was it. End of story. No mas. But last week, in a shout-out to "World UFO Day," The Daily Express crowed "Exclusive: MOD to release UK's top secret UFO 'X-Files' that 'could prove aliens exist.'"

That's wishful thinking. But the MoD really should be ashamed of itself for putting Archive historians in such a sticky wicket last year. That's when, in response to a FOIA request concerning retired U.S. airman John Burroughs -- who claims to have suffered permanent injuries from an alleged 1980 UFO encounter at an air base on British soil -- the military admitted it was still sitting on, ahem, 18 relevant documents. That shouldn't have been terribly surprising, since few if any of the previously published pages from half a century of eyewitness sightings had ever been classified to begin with. In reply to Burroughs' followup, the Defence Secretariat conceded in February 2014 that the files in question were being considered for release "in the near future."

Last week, 18 months later, Conservative Party House of Lords member Guy Black of Brentwood formally wondered from his Parliament seat just what, exactly, "in the near future" really meant. That forced Defence Minister Earl Howe to promise the military would get said files into the hands of the Archives no later than March of 2016. Then he whacked the ball into another court by adding the Archives "will make the necessary judgement about

when they release these files to the public." So on and on it goes in the UK.

It's sad when a government can't bear to admit the extent of its interest in UFOs. But even more heartbreaking than the UK was what happened last week in Germany. In a showdown that seems almost ludicrous, on June 29, the Federal Administrative Supreme Court felt compelled to order the German Parliament, or Bundestag, to release material on what it's done to comply with a particular United Nations resolution. On UFOs. From 1978.

Known technically as UN General Assembly Decision A/33/426, that agreement suggested member states should, among other things, "take appropriate steps to coordinate on a national level scientific research and investigation into extraterrestrial life, including unidentified flying objects, and to inform the Secretary-General of the observations, research, and evaluation of such activities." Which is not, one would think, a huge national priority anywhere.

And yet, since a report on German efforts toward that end was confirmed by Exopolitik.org in 2010, the Bundestag has gone to court to prevent the release of what blogger Andreas Muller states is a mere "informational summary of known facts on UFOs, the search for extraterrestrial intelligence (SETI), and the UN-Resolution A/33/426." Although a little clarity gets lost in translation, Muller says it contradicts Germany's long-standing position that the state has had no interest in The Great Taboo. Muller then links to a 2014 story summarizing 67 pages of previously withheld Cold War UFO documents languishing in files of the BND German intelligence agency. Many are still bound by a 30-year statute of limitations embargo, but available details on the known incidents are lights-in-the-night-sky innocuous.

The aforementioned grenzwissenschaft-aktuell blog goes on to quote Germany's Congressional Scientific Research Service -- which reportedly produced the Bundestag's currently litigated "A33/426" documents -- as stating, "The fact that both the United Kingdom as well as France (and several other countries) have been engaged with the question about the existence of UFOs and extraterrestrial live (sic) forms and that they confirmed this interest by publishing their formerly secret files extensively, even online, suggests that

also German agencies and federal ministries are engaged with this problem and question.”

Come on, Bundestag. Man up. Say it. We're interested in UFOs. Just say it. Say it.

Did NASA astronauts really land on the Moon?

Vladimir Markin, a spokesman for the government's official Investigative Committee, has said it is calling for an inquiry to find out what happened to the original footage of the first moon landing in 1969 and also lunar rock, brought back to Earth during the several "missions".

The moon landings have been a staple of conspiracy theorists everywhere since 1969 – most claim the missions were faked on a Hollywood style film set.

Mr Markin did not go as far as suggesting the missions were faked, but said as part of world history it was right to establish what happened and an inquiry could provide new insights into the historical journeys.

He said: "We are not contending that they did not fly [to the moon], and simply made a film about it. But all of these scientific – or perhaps cultural – artefacts are part of the legacy of humanity, and their disappearance without a trace is our common loss. An investigation will reveal what happened."

The call comes amid ongoing tension between Russia and the US over world affairs and a return to the "space race."

In 2009, NASA said it "erased" the original video recordings of the first moon landing among 200,000 other tapes in order to save money.

It has since said restored copies of the landing had been put together using recordings from news footage at the time.

NASA claims because of restoration work undertaken during this, the recordings' quality is better than the original which is no longer available.

Where is the lunar dust and rock and why were videos deleted?

We are not suggesting the missions were faked, but as part of world history it is right to establish what happened and an inquiry could provide new insights into the historical journeys-Vladimir Markin, spokesman for the government's official Investigative Committee

In 2001 David McKay, chief scientist for planetary science and exploration at NASA's Johnson Space Center, said most of the soil and rock removed from the Moon was stored there, but is unclear where it all is now, 46 years on.

US media has speculated that the call is no more than a smear since the US brought about the downfall of FIFA's leadership following its corruption inquiry.

This was because in an article for Russian newspaper Izvestia Mr Markin said US authorities had "crossed a line by launching a large-scale corruption probe targeting nine FIFA officials."

On the flip side the rest of Randy's story gives a good impression and to hear Captain Kaye rattle on about his experience, the guy doesn't slow down or miss a beat - it's all fluid, instant recall with just the right amount of emotional context.

Super soldiers are nothing new and I would actually be quite surprised if the US government was NOT working on a super soldier. We even had a movie with Kurt Russel about it, so its not such a wild concept. We have also heard through multiple sources, all putting forth the same story that humans are currently experiencing DNA hybrid upgrades so this also is nothing new and yes this is occurring in the general population as well. You, might have advanced DNA and not be aware of it. The MILAB or Ultra Black military program of taking and breaking young children in order to make them into controlled super beings is nothing new and this might have origins from Nazi scientist

who came over to the US after WWII in what is commonly known as Operation Paperclip. 
